

# **Natural Environment Referral Response - Biodiversity**

#### Reasons for referral

This application seeks consent development on land, or within 40m of land, containing:

- All Development Applications on
- Actual or potential threatened species, populations, ecological communities, or their habitats;
- Wildlife corridors;
- Vegetation query stipulating that a Flora and Fauna Assessment is required;
- Vegetation query X type located in both A & C Wards;

And as such, Council's Natural Environment Unit officers are required to consider the likely potential environmental impacts.

#### Officer comments

The previous vegetation mapping, and the limited site survey, did not indicate that the vegetation potentially impacted is part of the Endangered Ecological Community Duffys Forest. The site survey did not observe the threatened flora species *Grevillea caleyi* in the field. While the location of the proposed shed will require removal of native species, they are part of a common community and the proposal includes replacement planting of trees that are locally common. The proposal is not considered to have a significant impact, and is consistent with the Pittwater LEP 2014 and P21 DCP controls.

#### **Control of Weeds**

Prior to the completion of works, all priority weeds (as listed under the Biosecurity Act 2015) are to be removed/controlled within the subject site using an appropriately registered control method. Information on weeds of the Northern Beaches can be found at the NSW WeedWise website (http://weeds.dpi.nsw.gov.au/). All environmental weeds are to be removed and controlled. ## **No Planting Environmental Weeds**

If construction activity associated with this development results in injury or death of a native mammal, bird, reptile or amphibian, a registered wildlife rescue and rehabilitation organisation must be contacted for advice.

**Reason:** To mitigate potential impacts to native wildlife resulting from construction activity.
