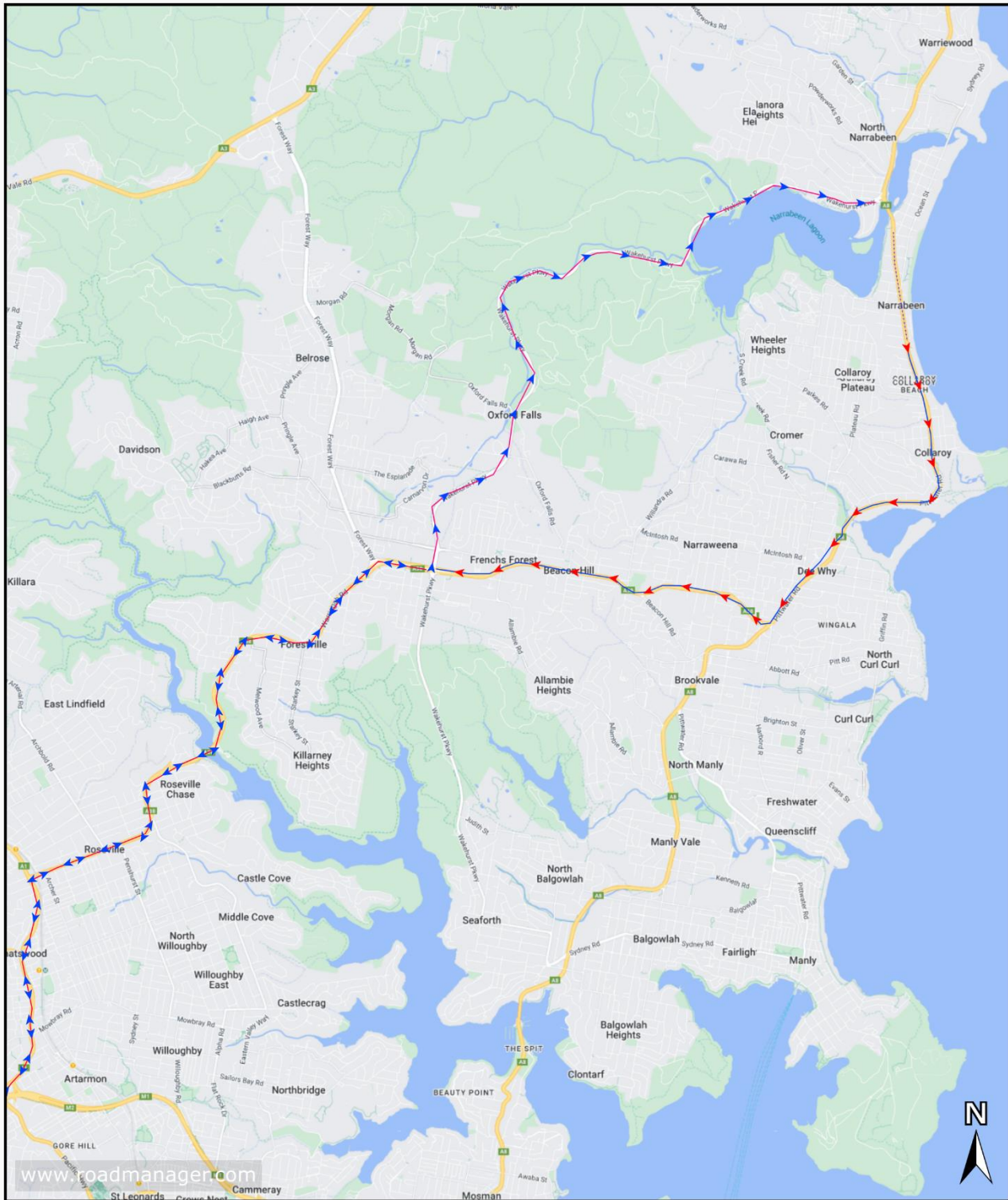

## Vehicle Delivery Route Map View (VMP)



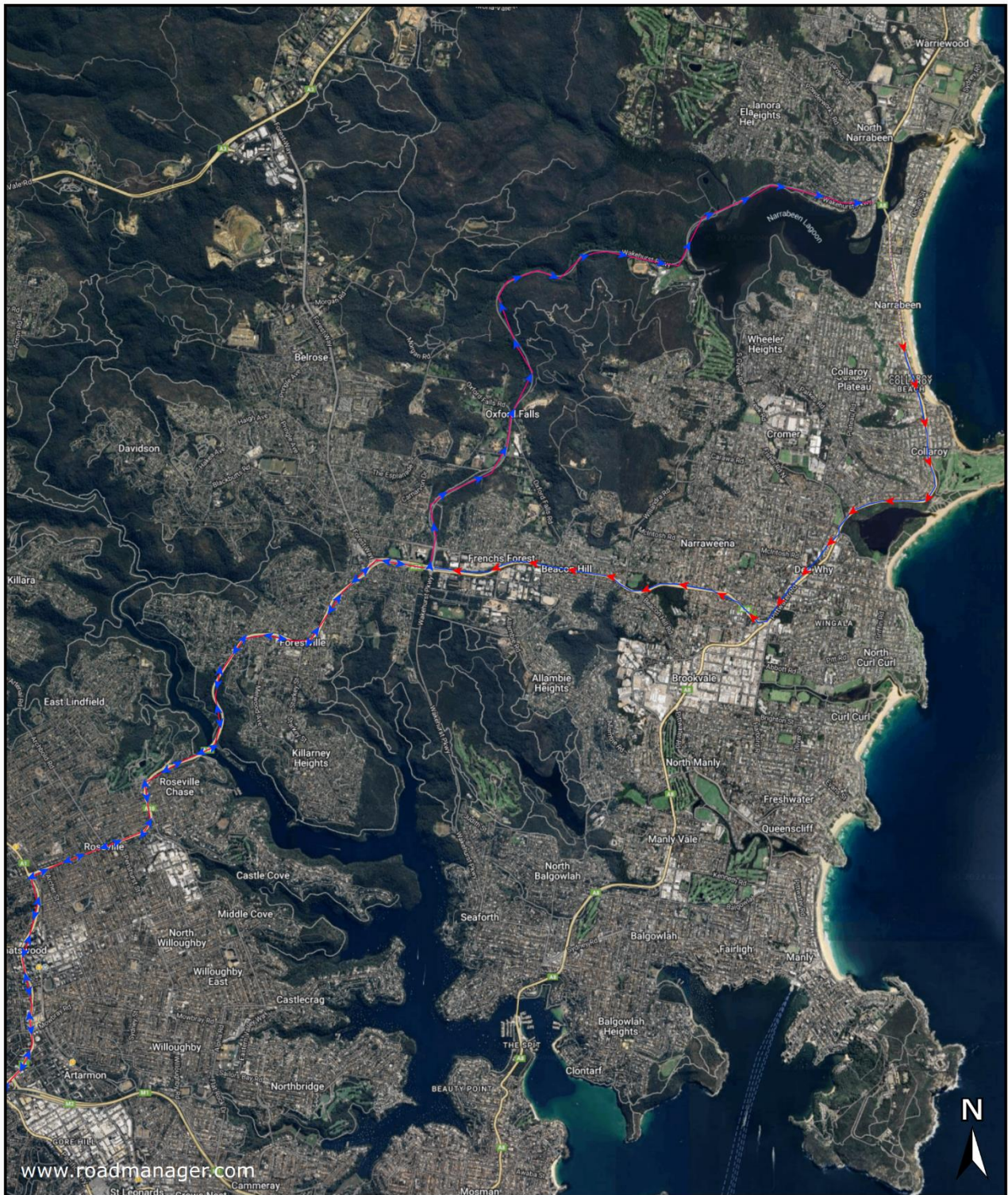

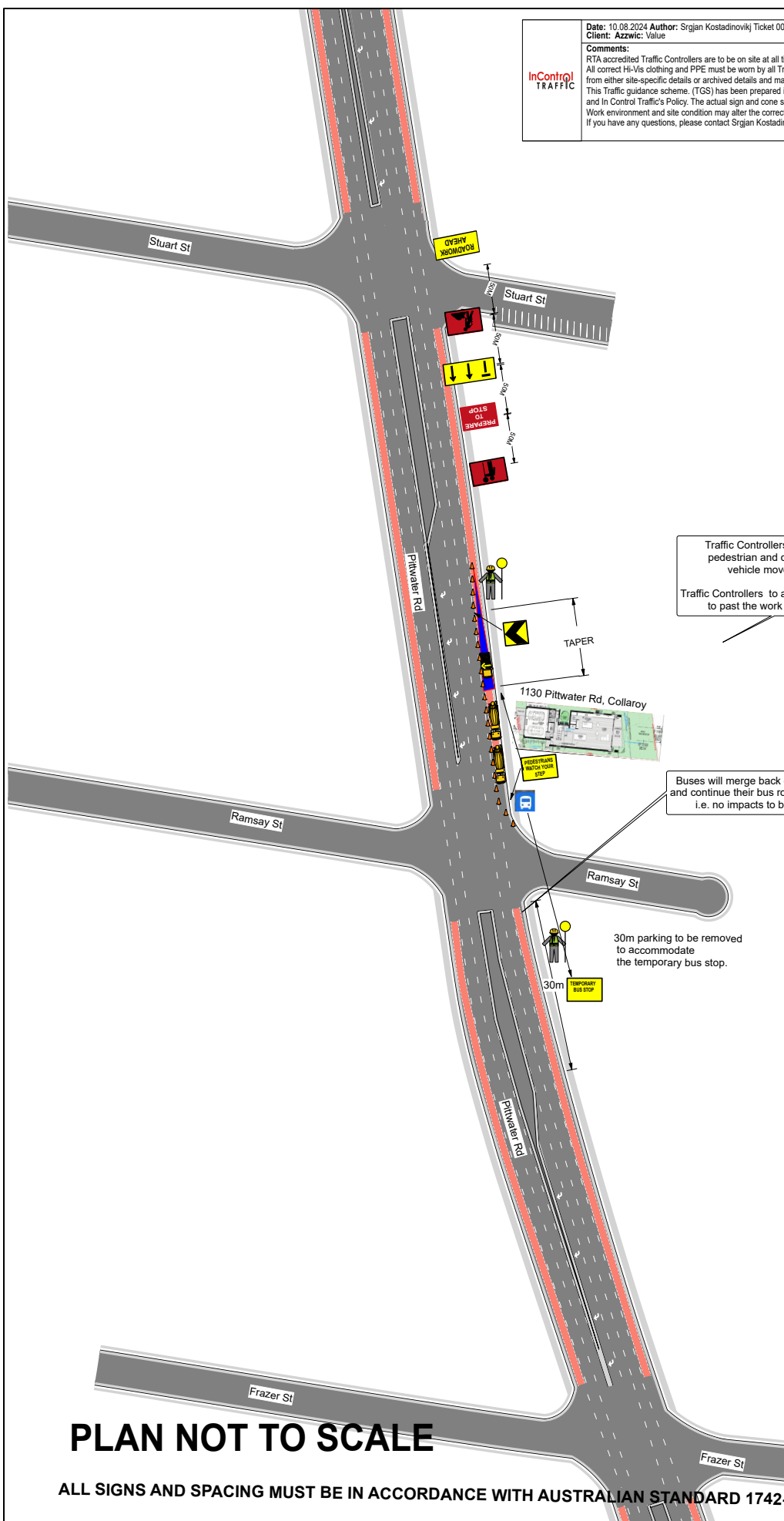

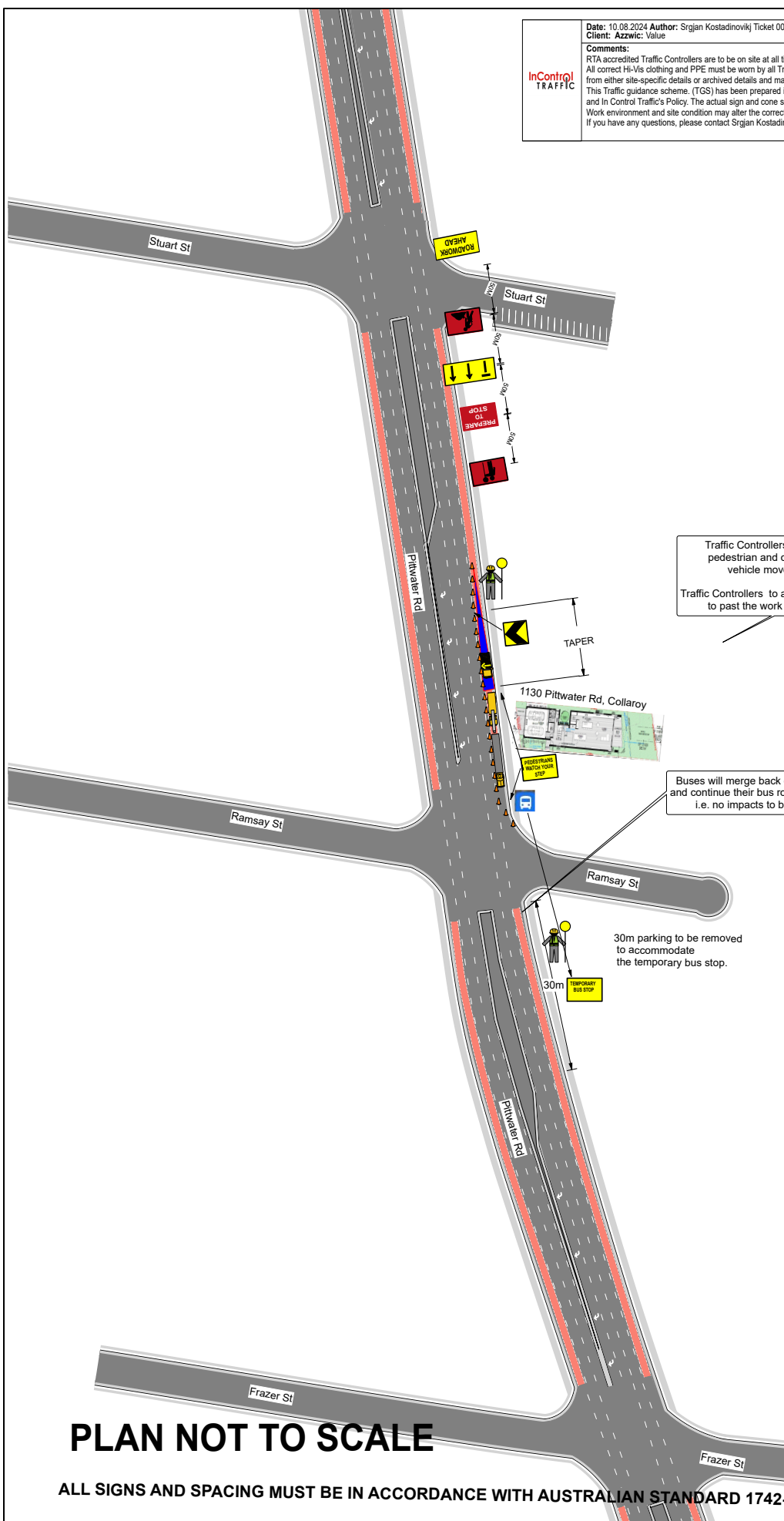
