PROPOSED DEVELOPMENT IN DETAIL

The proposed development consists of alterations and additions to a dwelling house. Specifically, the works comprise the following:

Level 2:

- Enclose existing balcony to provide additional floor area.
- New balcony to the eastern rear

Level 3:

- Enclose portion of existing balcony to the eastern rear and northern side to increase the size of the living/dining room.
- Reconfigure existing pantry/laundry to provide larger pantry.

• Enclose existing drying court to provide laundry and internal courtyard.

A submission was received requesting clarification regarding the "Galv Steel Brace" annotated on the plans. The submitter is unclear whether this is a brace or an unspecified roof structure. It has been confirmed that this element is a steel angle brace, not a roof structure, providing structural stability to support the privacy screen to the proposed balcony.

Comment:

The proposed development comprises alterations and additions to the existing dwelling largely maintaining the existing building footprint. The proposed development is not likely to cause an adverse impact on the above matters.

 - a) the development is designed, sited and will be managed to avoid an adverse impact referred to in subsection (1), or

2.12 Development in coastal zone generally—development not to increase risk of coastal hazards

The underlying objectives of the 4 Environmental Living zone

• To provide for low-impact residential development in areas with special ecological, scientific or aesthetic values.

Comment:

The proposal comprises minor alterations and additions to the existing dwelling house providing low-impact residential development.

To ensure that residential development does not have an adverse effect on those values.

Comment:

The proposal has been supported by Council's Bushland and Biodiversity Team, Riparian Lands and Creeks Team, Development Engineering Team, Coast and Catchments Team, Parks, Reserves, Beaches, Foreshore Team and the Aboriginal Heritage Office. As such, the proposed development does not have an adverse effect on the special ecological, scientific or aesthetic values of the area.

• To provide for residential development of a low density and scale integrated with the landform and landscape.

Comment:

The proposed development is sited within the existing building footprint and is of a low density and scale. The building continues to step down with the slope and is integrated with the landform and landscape.

 To encourage development that retains and enhances riparian and foreshore vegetation and wildlife corridors.

D1.11 Building envelope

Detailed description of non-compliance

This control requires buildings to be sited within an envelope determined by projecting plans at 45 degrees from a height of 3.5m above ground level at the side boundaries. Where the building footprint is situated on a slope over 16.7 degrees (ie 30%), variation to this control will be considered on a merits basis.

The proposed development encroaches both the northern and southern side building envelopes as shown below.




Figure 2 - South elevation showing envelope breach in red

The building footprint is situated on a slope over 40% therefore qualifying for a variation.

Merit consideration

With regard to the consideration of a variation, the proposed development is considered against the underlying outcomes of the control as follows:

To achieve the desired future character of the Locality. (S)

Comment

The proposal maintains the low density residential form of the area and achieves the desired future character of the Locality.

 To enhance the existing streetscapes and promote a building scale and density that is below the height of the trees of the natural environment.

Comment:

The proposed additions sit below the required height limit and existing roof line. The proposal promotes a scale and density that is below the height of the trees of the natural environment.

 To ensure new development responds to, reinforces and sensitively relates to spatial characteristics of the existing natural environment.

Comment:

The proposal maintains the existing building footprint with the level 2 balcony sited over the existing terrace and the level 3 addition involves enclosing the existing roofed balcony. As such, the breach on the northern elevation is limited to the new glazed windows to enclose the

balcony. The breach on the southern elevation is limited to the privacy screen to the new balcony.

The bulk and scale of the built form is minimised. (En, S)

Comment:

The proposed development sits below the required building height and provides compliant side setbacks. The existing building footprint is maintained along with the existing landscaped area. As above, the non-compliant elements are limited to the new windows to the enclosed balcony and the privacy screen to the new balcony. These elements do not generate significant bulk and scale to the built form.

Equitable preservation of views and vistas to and/or from public/private places. (S)

<u>Comment</u>

The proposal equitably maintains views and vistas to and/or from public/private places.

 To ensure a reasonable level of privacy, amenity and solar access is provided within the development site and maintained to residential properties. (En, S)

Comment:

The proposal provides privacy screening to the southern edge of the new balcony to mitigate overlooking. Additionally, the proposal retains the existing building lines ensuring sufficient spatial separation is provided to maintain a reasonable level of privacy, amenity and solar access.

Vegetation is retained and enhanced to visually reduce the built form. (En)

Comment:

The proposal does not require the removal of any trees of significant vegetation and existing landscaped area is retained.

Having regard to the above assessment, it is concluded that the proposed development is consistent with the relevant objectives of PLEP 2014 / P21DCP and the objectives specified in s1.3 of the Environmental Planning and Assessment Act, 1979. Accordingly, this assessment finds that the proposal is supported, in this particular circumstance.

D1.14 Landscaped Area - Environmentally Sensitive Land

This control requires at least 60% of the site area to be landscaped. The existing site provides 31.5% (203.43m²) landscaped area presenting an existing non-compliance.

The proposed development does not alter the existing landscaped area on site, and as such there is no net loss. In this instance, the proposed development is supportable as it is considered that the proposal meets the outcomes of the control, despite the existing landscaped area variation.

THREATENED SPECIES, POPULATIONS OR ECOLOGICAL COMMUNITIES

The proposal will not significantly affect threatened species, populations or ecological communities, or their habitats.

12. Sediment and Erosion Controls

For developments that include more than 2500sqm of disturbance:

A Soil and Water Management plan (SWMP), in accordance with section 2.3 of the Blue Book, must be prepared and certified by a suitably qualified professional.

For sites larger than 250sqm and less than 2500sqm of disturbance:

An Erosion and Sediment Control Plan (ESCP) must be prepared by a suitably qualified person in accordance with the following considerations and documents:

- Sites that have slopes exceeding 20% (measured in any direction across the site), and/or where works are within the high-water mark or adjacent to a waterway or watercourses are considered environmentally sensitive areas. These sites require a site-specific ESCP which must be prepared and certified by a suitably qualified professional,
- The guidelines set out in the NSW Department of Housing manual 'Managing Urban Stormwater: Soils and Construction Certificate – Volume 1, 4th Edition (2004)' (the Blue Book), and
- The 'Guidelines for Erosion and Sediment Control on Building Sites' (Department of Planning, Housing and Infrastructure).

The ESCP must include the following as a minimum:

- Site Boundaries and contours,
- Approximate location of trees and other vegetation, showing items for removal or retention (consistent with any other plans attached to the application),
- Location of site access, proposed roads and other impervious areas (e.g. parking area and site facilities),
- Existing and proposed drainage patterns with stormwater discharge points,
- Locations and methods of all erosion and sediment controls that must include sediment fences, stabilised site access, materials and waste stockpiles locations, location of any stormwater pits on the site and how they are going to be protected,
- North point and scale,
- Type of erosion control measures to divert and slow run-off around and within the site.

Environmentally sensitive areas (i.e. Sites that have slopes exceeding 20% and/or where works are within the high-water mark or adjacent to a waterway or watercourses) must also consider:

- Identify and mark any environmentally sensitive areas on and immediately next to the site and how you will protect these, including any appropriate buffer zones (for example, marking them out as 'no-go' areas),
- Details on vegetation you will clear, as well as areas of vegetation you will keep (mark no go areas),
- Detail on soil information and location(s) of problem soil types, especially dispersive soils and potential or actual acid sulfate soils,

Run-off and erosion controls must be implemented to prevent soil erosion, water pollution or the discharge of loose sediment on the surrounding land by:

- Erecting a silt fence and providing any other necessary sediment control measures that will prevent debris escaping into drainage systems, waterways or adjoining properties,
- Preventing the tracking of sediment by vehicles onto roads, and
- Stockpiling top soil, excavated materials, construction and landscaping supplies and debris within the lot.
- Identifying any environmentally sensitive areas on and immediately next to the site, and demonstrating how these will be protected (for example, by designation as no-go areas).

Details demonstrating compliance with the relevant requirements above are to be submitted to the Certifier, and the measures implemented, prior to the commencement of works.

Reason: To ensure no substance other than rainwater enters the stormwater system and waterways.

DURING BUILDING WORK

13. Wildlife Protection

If construction activity associated with this development results in injury or displacement of a native mammal, bird, reptile or amphibian, a licensed wildlife rescue and rehabilitation organisation must be contacted for advice.

Reason: To protect native wildlife.

14. Protection of Habitat Features

All natural landscape features, including any rock outcrops, native vegetation and/or watercourses, are to remain undisturbed during the construction works, except where affected by necessary works detailed on approved plans.

Reason: To protect wildlife habitat.

15. Road Reserve

The applicant shall ensure the public footways and roadways adjacent to the site are maintained in a safe condition at all times during the course of the work.

16. Geotechnical Requirements

The sign is to be erected prior to demolition work commencing and is to remain in place until such time as all asbestos cement has been removed from the site and disposed to a lawful waste disposal facility.

All asbestos laden waste, including flat, corrugated or profiled asbestos cement sheets must be disposed of at a lawful waste disposal facility. Upon completion of tipping operations the applicant must lodge to the Principal Certifier, all receipts issued by the receiving tip as evidence of proper disposal.

Details demonstrating compliance are to be submitted to the Principal Certifier when the external structure of the building is complete.

Reason: To demonstrate the proposal complies with the approved plans.

19. Maintenance of Sediment and Erosion Controls

Erosion and sediment controls must be adequately maintained and monitored at all times, particularly surrounding periods of rain, and shall remain in proper operation until all development activities have been completed and the site is in a state where no substance other than rainwater can enter the stormwater system and waterways.

All sediment control measures must be maintained at, or above, their design capacity.

Where more than 2500 square metres of land are disturbed or if the site has a slope of more than 20%, a self-auditing program must be developed for the site. A site inspection using a log book or inspection test plan (ITP) must be undertaken by the site supervisor:

- at least each week
- immediately before site closure
- immediately following rainfall events that cause runoff.

Details demonstrating compliance must be provided to the Certifier during demolition and building works.

Reason: Protection of the receiving environment and to ensure no substance other than rainwater enters the stormwater system and waterways.

All material is to be removed off site and disposed of according to local regulations. The property is to be kept clean and any building debris removed as frequently as required to ensure no debris enters receiving waters.

Reason: To ensure pollution control measures are effective to protect the aquatic habitats within receiving waters throughout the construction period.

22. Aboriginal Heritage

If in undertaking excavations or works any Aboriginal site or object is, or is thought to have been found, all works are to cease immediately and the applicant is to contact the Aboriginal Heritage Officer for Northern Beaches Council, and the Cultural Heritage Division of the Department of Planning, Housing and Infrastructure.

Any work to a site that is discovered to be the location of an Aboriginal object, within the meaning of the National Parks and Wildlife Act 1974, requires a permit from the Director of the Department of Planning, Housing and Infrastructure.

Reason: Aboriginal Heritage Protection.

BEFORE ISSUE OF THE OCCUPATION CERTIFICATE

23. No Weeds Imported On To The Site

No Priority or environmental weeds (as specified in the Northern Beaches Local Weed Management Plan) are to be imported on to the site prior to or during construction works.

Details demonstrating compliance are to be submitted to the Principal Certifier prior to issue of any Occupation Certificate.

Reason: To reduce the risk of site works contributing to spread of Priority and environmental weeds.

24. Stormwater Disposal

The stormwater drainage works shall be certified as compliant with all relevant Australian Standards and Codes by a suitably qualified Civil Engineer.

Details demonstrating compliance are to be submitted to the Principal Certifier prior to the issue of an Occupation Certificate.

Reason: To ensure appropriate provision for the disposal of stormwater arising from the development.

25. Waste Disposal Verification Statement

On completion of demolition work:

- a signed statement must be submitted to the Certifier verifying that demolition work, and any recycling of materials, was undertaken in accordance with the waste management plan approved under this consent, and
- if the demolition work involved the removal of asbestos, an asbestos clearance certificate issued by a suitably qualified person, must be submitted to the Certifier within 14 days of completion of the demolition work.

Reason: To provide for the submission of a statement verifying that demolition waste management and recycling has been undertaken in accordance with the approved waste management plan.

26. Geotechnical Certification Prior to Occupation Certificate

The Applicant is to submit the completed Form 3 of the Geotechnical Risk Management Policy (Appendix 5 of P21 DCP) to the Principal Certifier prior to issue of the Occupation Certificate.

Reason: To ensure geotechnical risk is mitigated appropriately.

ON-GOING CONDITIONS THAT MUST BE COMPLIED WITH AT ALL TIMES

27. Control of Domestic Dogs/Cats

Domestic dogs and cats are to be kept from entering wildlife habitat areas at all times.

Dogs and cats are to be kept in an enclosed area and/or inside the dwelling, or on a leash such that they cannot enter areas of wildlife habitat, bushland or foreshore unrestrained, on the site or on surrounding properties or reserves.

Reason: To protect native wildlife and habitat.

28. Geotechnical Recommendations

Any ongoing recommendations of the risk assessment required to manage the hazards identified in the Geotechnical Report referenced in Condition 1 of this consent are to be maintained and adhered to for the life of the development.

Reason: To ensure geotechnical risk is mitigated appropriately.
