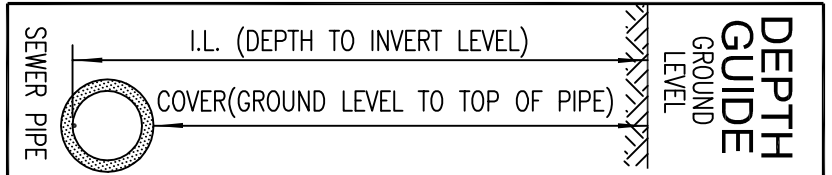


SYDNEY WATER HYDRA PLOT (N.T.S.)
