PRELIMINARY ACID SULFATE SOIL ASSESSMENT PROPOSED RESIDENTIAL DEVELOPMENT 92 NORTH STEYNE, MANLY, NSW

1 INTRODUCTION

Allen Group Developments Pty Ltd ('the client') commissioned JK Environments (JKE) to undertake a preliminary acid sulfate soil (ASS) assessment for the proposed residential development at 92 North Steyne, Manly, NSW ('the site'). The site is identified as SP478 and covers an area of approximately 320m². The site location is shown on Figure 1 and the assessment was confined to the site boundaries as shown on Figure 2.

The assessment was undertaken generally in accordance with a JKE proposal (Ref: EP70529B) of 30 October 2024 and written acceptance from the client by email of 23 January 2025. A geotechnical investigation was undertaken in conjunction with the ASS assessment by JK Geotechnics and the results are presented in a separate report (project ref: 37307Srpt).

The aims of the assessment were to establish whether ASS may be disturbed during the proposed development works, and to assess whether an ASS management plan (ASSMP) is required.

1.1 **Assessment Guidelines and Background**

The ASS assessment and preparation of this report were undertaken with reference to the National Acid Sulfate Soil Guidance (2018) documents and the Acid Sulfate Soil Management Advisory Committee (ASSMAC) Acid Sulfate Soil Manual (1998)1.

ASS materials include potential acid sulfate soils (PASS or sulfidic soil materials) and actual acid sulfate soils (AASS or sulfuric soil materials). These are often found in the same profile, with AASS overlying PASS. AASS and PASS are defined further as follows:

Acid Sulfate Soils Management Advisory Committee (ASSMAC), (1998). Acid Sulfate Soils Manual (ASS Manual 1998)





- PASS are soil materials which contain Reduced Inorganic Sulfur (RIS) such as pyrite. The field pH of these soils in their undisturbed state is usually more than pH 4 and is commonly neutral to alkaline (pH 7–9). These soil materials are invariably saturated with water in their natural state. Their texture may be peat, clay, loam, silt or sand and is often dark grey in colour and soft in consistence, but these materials may also exhibit colours that are dark brown, or medium to pale grey to white; and
- AASS are soil materials which contained RIS such as pyrite that have undergone oxidation. This oxidation results in low pH (that is pH less than 4) and often a yellow (jarosite) and/or orange to red mottling (ferric iron oxides) in the soil profile. Actual ASS contains Actual Acidity, and commonly also contains RIS (the source of Potential Sulfuric Acidity) as well as Retained Acidity.

Further background information on ASS and the assessment process is provided in the appendices.

1.2 Proposed Development Details

The proposed development includes the demolition of the existing residential apartment building followed by the construction of a five-storey residential building with a single basement level. Soil disturbance is expected to occur to a maximum depth of approximately 3m below ground level (BGL) for the construction of the basement.

2 SITE INFORMATION

2.1 Site Information and Description

The site is located within a residential area of Manly and bound by North Steyne to the east. Manly Beach is located approximately 30m to the east of the site, past North Steyne.



The regional topography is characterised by relatively flat low-lying coastal topography. The site is relatively flat with a slight decline to the south-west at approximately 1°.

At the time of the inspection, the site was occupied by a three-storey brick residential apartment building and associated concrete driveways. The open areas of the site were predominantly concrete paved, with the exception of several concrete cut-outs along the northern side of the residential building used for tree planting and minor landscaping.

The site was bound by a neighbouring multi-storey building to the north, a low concrete wall and wood fencing along the southern boundary, low brick wall and wood fencing along the western boundary and open along the eastern boundary. There were no soil instability observed within the site during the inspection.

The vegetation at the site included several exotic shrubs located within the concrete cut-outs along the northern site boundary and weedy vegetation along the western and parts of the southern site boundaries. There were no dieback or phyto-toxic stress observed from the onsite vegetation or the immediate surrounding vegetation based on a cursory external inspection.

The site surrounds included the following:

- North Multi-storey residential apartment with ground floor restaurants;
- South Multi-storey residential apartment buildings;
- East Public access footpath area with North Steyne and Manly Beach further to the east; and
- West Single and multi-storey residential terraces and apartment buildings.

There were no indicators of ASS (i.e. mangroves or sulfidic odours) observed within the site or in the immediate site surrounds during the inspection.

2.2 Regional Geology

The geological map of Sydney (1983)² indicates the site to be underlain by underlain by Quaternary aged deposits of medium to fine-grained marine sands with podsols.

2.3 Acid Sulfate Soil Risk Map

A review of the ASS risk maps prepared by Department of Land and Water Conservation (1997)³ indicates that the site is located in an area mapped as having 'low probability' of ASS occurrence at greater than 3mBGL.

2.4 Manly Local Environmental Plan (LEP) 2013

A review of the Manly LEP (2013) indicates that the site is located within a Class 4 ASS risk area (refer to appendices for further details on each risk class).

3 INVESTIGATION REQUIREMENTS AND ASSESSMENT CRITERIA

3.1 Investigation Requirements

The National Acid Sulfate Soil Guidance (2018) requires sampling to a depth of 1m beyond the depth of disturbance (including the depth of any groundwater disturbance). A summary of the sampling densities and analysis requirements outlined in the *National Acid Sulfate Soil Guidance: National acid sulfate soils sampling and identification methods manual* (2018) is provided in the following tables:

Note: Small scale is considered less than or equal to 1,000 m³ and does not involve dewatering or groundwater pumping (excluding linear disturbances). Number of samples to be analysed per total volume of soil to be disturbed, not per borehole. Depth of disturbance to be measured from ground surface. Borehole depth must be at least 1 m below maximum proposed depth of disturbance.

The investigation component of this assessment was designed as a preliminary investigation and does not meet the minimum analysis frequency. The low sampling density is considered reasonable given the site access limitations and localised extent of soil disturbance.

3.2 Action Criteria

The action criteria presented in the *National Acid Sulfate Soil Guidance: National acid sulfate soils sampling and identification methods manual* (2018) are summarised in the following table:

The action criteria for coarse textured soils were used for this assessment.

3.3 Field Tests

The soil field tests commonly used for investigations for ASS materials include field pH (pH_F) and field pH peroxide (pH_{FOX}) tests. The pH_F test can help identify Actual ASS. While a pH_F of less than or equal to pH 4 is indicative of the presence of Actual ASS, it is not conclusive of the presence of ASS on its own, as naturally occurring, non ASS soils such as many organic soils (for example peats) and heavily leached soils may also have pH_F less than or equal to pH 4. To identify an Actual ASS other evidence must be presented that indicates the low pH_F has been mainly caused by the oxidation of reduced inorganic sulfur. Such information includes the presence of jarosite in the soil layer/horizon, or the location of other Actual ASS or PASS materials within the sampling location or in the nearby vicinity.

The difference between the pH_F and the pH_{FOX} is helpful in the preliminary identification of PASS. Combined, the pH_F and pH_{FOX} results can be a useful aid with soil sample selection for laboratory analysis. Additional Information in relation to interpretation of the pH field tests is provided in the appendices.





4 INVESTIGATION PROCEDURE

4.1 Subsurface Investigation and Soil Sampling Methods

Field work was undertaken on 3 and 7 February 2025. Soil samples were collected from three locations (BH1 to BH3 inclusive) in conjunction with the JK Geotechnics investigation, to a maximum borehole depth of approximately 6.45mBGL. The sampling locations are shown on the attached Figure 2.

The sample locations were drilled using a track mounted hydraulically operated drill rig equipped with spiral flight augers. Soil samples were obtained from a Standard Penetration Test (SPT) sampler or directly from the auger when conditions did not allow use of the SPT sampler.

Soil samples were obtained at various depths, based on observations made during the field investigation. All samples were placed in plastic bags and sealed with plastic ties with minimal headspace. Each sample was labelled with a unique job number, the sampling location, sampling depth and date. All samples were recorded on the borehole logs attached in the appendices.

The samples were preserved by immediate storage in an insulated sample container with ice and frozen upon return to the JKE office. Samples were subsequently delivered in the insulated sample container (on ice or with ice packs) to a NATA registered laboratory for analysis under standard chain of custody (COC) procedures.

4.2 Laboratory Analysis

Samples for this assessment were analysed for ASS field tests (including pH_F and pH_{FOX}) and using the chromium reducible sulfur (S_{CR}) acid base accounting analytical methods. All tests/analysis were performed at the laboratory and JKE did not carry out the testing in the field due to time constraints. Samples were Analysed by Envirolab Services (NATA Accreditation Number - 2901). Reference should be made to the laboratory report (Ref: 372392 and 372392-A) attached in the appendices for further information regarding the laboratory methods used.

5 RESULTS OF THE INVESTIGATION

5.1 Subsurface Conditions

A summary of the subsurface soil conditions encountered during the investigation is presented in the table below. Reference should be made to the borehole logs attached in the appendices for further details.

Table 5-1: Summary of subsurface conditions

Pavement	Concrete or concrete over brick pavements were encountered in BH2 and BH3 and ranged in thickness from 110mm to 200mm.

Fill	Fill soil was encountered in all boreholes and extended to depths of approximately 0.3mBGL to 0.8mBGL. The fill typically comprised silty sand and contained inclusions of igneous and sandstone gravel, brick fragments and root fibres.
	No organics or odours soils were observed in the fill material during sampling.
Natural Soil	Sand and silty sand (marine) natural soil were encountered beneath the fill in all boreholes and extended to the termination of the boreholes at a maximum depth of approximately 20mBGL. The natural soil was typically yellow brown and grey and contained inclusions of shell fragments from a depth of approximately 5mBGL.
	No odours soils were observed in the natural soil during sampling.
Groundwater	Seepage was encountered within BH1 and BH2 during drilling at depths ranging from approximately 4.4mBGL to 4.8mBGL. A standing water level (SWL) was measured within BH1 at approximately 4.6mBGL following completion of drilling.

5.2 Laboratory Results

The soil laboratory results were assessed against the action criteria adopted for the assessment. The results are presented in the attached report tables and are summarised below.

Table 5-2: Summary of Results

Results	Comments
pH _F and pH _{FOX}	The pH _F results ranged from pH 9 to pH 9.9. The pH _{FOX} results ranged from pH 6.3 to pH 6.9. The maximum difference from pH _F to pH _{FOX} was 3.6 pH units. None of the pH _F results were below pH 4, therefore AASS is not considered to be present within the samples analysed.
pH _{FOX} reaction rates	Reaction rates were reported as low.
	Six samples were selected for analysis of ASS characteristic using acid base accounting methods. The samples were selected based on a combination of pH _F and pH _{FOX} results, and to provide vertical coverage/distribution of the soil profiles.
	We note that the fill material was not analysed using acid base accounting methods due to its relatively shallow depths across the site (maximum encountered to 0.8mBGL) and the fact that no indicators of ASS (i.e. dredged material, odours etc.) were observed in the fill material during sampling.
Net Acidity % S-equiv.	The net acidity results ranged from <0.005%w/w S to 0.01%w/w S. All of the net acidity (%w/w) results were below the action criteria of 0.03%w/w S.
Net Acidity mol H ⁺ /t	The net acidity results ranged from <5 mol H $^+$ /t to 6.2mol H $^+$ /t. All of the net acidity (mol H $^+$ /t) results were below the action criteria of 18mol H $^+$ /t.
S _{CR} %	The $S_{CR}\%$ results ranged from <0.005 $S_{CR}\%$ to 0.01 $S_{CR}\%$. These results indicated that the soils did not contain significant oxidisable sulfur concentrations.
Liming Rate	The liming rate required for neutralisation were all <0.75kgCaCO ₃ /tonne.



6 ASSESSMENT CONCLUSION

Based on the weight of evidence collected and evaluated for this assessment, there is considered to be a low potential for ASS materials (AASS or PASS) to be disturbed to a maximum depth of approximately 6mBGL during the proposed development. On this basis, an ASSMP is not considered necessary for the proposed development described in Section 1.2 of this report to a maximum depth of approximately 6mBGL.

7 LIMITATIONS

The report limitations are outlined below:

- JKE accepts no responsibility for any unidentified AASS or PASS issues at the site. Any unexpected problems/subsurface features that may be encountered during development works should be inspected by an environmental consultant as soon as possible;
- This report has been prepared based on site conditions which existed at the time of the investigation; scope of work and limitation outlined in the JKE proposal; and terms of contract between JKE and the client (as applicable);
- The conclusions presented in this report are based on investigation of conditions at specific locations, chosen to be as representative as possible under the given circumstances, visual observations of the site and immediate surrounds and documents reviewed as described in the report;
- Subsurface soil and rock conditions encountered between investigation locations may be found to be different from those expected. Groundwater conditions may also vary, especially after climatic changes;
- The investigation and preparation of this report have been undertaken in accordance with accepted practice for environmental consultants, with reference to applicable environmental regulatory authority and industry standards, guidelines and the assessment criteria outlined in the report;
- Where information has been provided by third parties, JKE has not undertaken any verification process, except where specifically stated in the report;


SITE LOCATION PLAN

A. Background

Acid Sulfate Soil (ASS) is formed from iron rich alluvial sediments and sulfate (found in seawater) in the presence of sulfate reducing bacteria and plentiful organic matter. These conditions are generally found in mangroves, salt marsh vegetation or tidal areas and at the bottom of coastal rivers and lakes. ASS materials are distinguished from other soil or sediment materials (referred to as 'soil materials' throughout the National Acid Sulfate Soils Guidance) by having properties and behaviour that have either:

- 1) Been affected considerably by the oxidation of Reduced Inorganic Sulfur (RIS), or
- 2) The capacity to be affected considerably by the oxidation of their RIS constituents.

Acid sulfate soil materials include potential acid sulfate soils (PASS or sulfidic soil materials) and actual acid sulfate soils (AASS or sulfuric soil materials). These are often found in the same profile, with AASS overlying PASS. PASS and AASS are defined further below:

- PASS are soil materials which contain RIS such as pyrite. The field pH of these soils in their undisturbed state is usually more than pH 4 and is commonly neutral to alkaline (pH 7–9). These soil materials are invariably saturated with water in their natural state. Their texture may be peat, clay, loam, silt or sand and is often dark grey in colour and soft in consistence, but these materials may also exhibit colours that are dark brown, or medium to pale grey to white; and
- AASS are soil materials which contained RIS such as pyrite that have undergone oxidation. This oxidation
 results in low pH (that is pH less than 4) and often a yellow (jarosite) and/or orange to red mottling (ferric
 iron oxides) in the soil profile. Actual ASS contains Actual Acidity, and commonly also contains RIS (the
 source of Potential Sulfuric Acidity) as well as Retained Acidity.

B. The ASS Planning Maps

The ASS planning maps provide an indication of the relative potential for disturbance of ASS to occur at locations within the council area. These maps do not provide an indication of the actual occurrence of ASS at a site or the likely severity of the conditions.

The maps are divided into five classes dependent upon the type of activities/works that if undertaken, may represent an environmental risk through the development of acidic conditions associated with ASS:

Table 1: Risk Classes

Risk Class	Description
Class 1	All works.
Class 2	All works below existing ground level and works by which the water table is likely to be lowered.
Class 3	Works at depths beyond 1m below existing ground level or works by which the water table is likely to be lowered beyond 1m below existing ground level.
Class 4	Works at depths beyond 2m below existing ground level or works by which the water table is likely to be lowered beyond 2m below existing ground level.
Class 5	Works within 500m of adjacent Class 1, 2, 3, 4 land which are likely to lower the water table below 1m AHD on the adjacent land.



C. The ASS Risk Maps

The ASS risk maps provide an indication of the probability of occurrence of ASS materials at a particular location based on interpretation from geological and soil landscape maps. The maps provide classes based on high probability, low probability, no known occurrence and areas of disturbed terrain (site specific assessment necessary) and the likely depth at which ASS materials are likely to be encountered.

D. Interpretation of ASS Field Tests

Tables A1 and A2 below provide some guidance on the interpretation of pH_F and pH_{FOX} test results, as detailed in the *National Acid Sulfate Soil Guidance: National acid sulfate soils sampling and identification methods manual* (2018):



ENVIRONMENTAL LOGS EXPLANATION NOTES

INTRODUCTION

These notes have been provided to amplify the environmental report in regard to classification methods, field procedures and certain matters relating to the logging of soil and rock. Not all notes are necessarily relevant to all reports.

Where geotechnical borehole logs are utilised for environmental purpose, reference should also be made to the explanatory notes included in the geotechnical report. Environmental logs are not suitable for geotechnical purposes.

The ground is a product of continuing natural and man-made processes and therefore exhibits a variety of characteristics and properties which vary from place to place and can change with time. Environmental studies include gathering and assimilating limited facts about these characteristics and properties in order to understand or predict the behaviour of the ground on a particular site under certain conditions. This report may contain such facts obtained by inspection, excavation, probing, sampling, testing or other means of investigation. If so, they are directly relevant only to the ground at the place where and time when the investigation was carried out.

DESCRIPTION AND CLASSIFICATION METHODS

The methods of description and classification of soils and rocks used in this report are based on Australian Standard 1726:2017 *'Geotechnical Site Investigations'*. In general, descriptions cover the following properties—soil or rock type, colour, structure, strength or density, and inclusions. Identification and classification of soil and rock involves judgement and the Company infers accuracy only to the extent that is common in current geoenvironmental practice.

Soil types are described according to the predominating particle size and behaviour as set out in the attached soil classification table qualified by the grading of other particles present (eg. sandy clay) as set out below:

Soil Classification	Particle Size
Clay	< 0.002mm
Silt	0.002 to 0.075mm
Sand	0.075 to 2.36mm
Gravel	2.36 to 63mm
Cobbles	63 to 200mm

Non-cohesive soils are classified on the basis of relative density, generally from the results of Standard Penetration Test (SPT) as below:

Cohesive soils are classified on the basis of strength (consistency) either by use of a hand penetrometer, vane shear, laboratory testing and/or tactile engineering examination. The strength terms are defined as follows.

Rock types are classified by their geological names, together with descriptive terms regarding weathering, strength, defects, etc. Where relevant, further information regarding rock classification is given in the text of the report. In the Sydney Basin, 'shale' is used to describe fissile mudstone, with a weakness parallel to bedding. Rocks with alternating inter-laminations of different grain size (eg. siltstone/claystone and siltstone/fine grained sandstone) are referred to as 'laminite'.

INVESTIGATION METHODS

1

The following is a brief summary of investigation methods currently adopted by the Company and some comments on their use and application. All methods except test pits, hand auger drilling and portable Dynamic Cone Penetrometers require the use of a mechanical rig which is commonly mounted on a truck chassis or track base.

Test Pits: These are normally excavated with a backhoe or a tracked excavator, allowing close examination of the insitu soils and 'weaker' bedrock if it is safe to descend into the pit. The depth of penetration is limited to about 3m for a backhoe and up to 6m for a large excavator. Limitations of test pits are the problems associated with disturbance and difficulty of reinstatement and the consequent effects on close-by structures. Care must be taken if construction is to be carried out near test pit locations to either properly recompact the backfill during construction or to design and construct the



structure so as not to be adversely affected by poorly compacted backfill at the test pit location.

Hand Auger Drilling: A borehole of 50mm to 100mm diameter is advanced by manually operated equipment. Refusal of the hand auger can occur on a variety of materials such as obstructions within any fill, tree roots, hard clay, gravel or ironstone, cobbles and boulders, and does not necessarily indicate rock level.

Continuous Spiral Flight Augers: The borehole is advanced using 75mm to 115mm diameter continuous spiral flight augers, which are withdrawn at intervals to allow sampling and insitu testing. This is a relatively economical means of drilling in clays and in sands above the water table. Samples are returned to the surface by the flights or may be collected after withdrawal of the auger flights, but they can be very disturbed and layers may become mixed. Information from the auger sampling (as distinct from specific sampling by SPTs or undisturbed samples) is of limited reliability due to mixing or softening of samples by groundwater, or uncertainties as to the original depth of the samples. Augering below the groundwater table is of even lesser reliability than augering above the water table.

Rock Augering: Use can be made of a Tungsten Carbide (TC) bit for auger drilling into rock to indicate rock quality and continuity by variation in drilling resistance and from examination of recovered rock cuttings. This method of investigation is quick and relatively inexpensive but provides only an indication of the likely rock strength and predicted values may be in error by a strength order. Where rock strengths may have a significant impact on construction feasibility or costs, then further investigation by means of cored boreholes may be warranted.

Wash Boring: The borehole is usually advanced by a rotary bit, with water being pumped down the drill rods and returned up the annulus, carrying the drill cuttings. Only major changes in stratification can be assessed from the cuttings, together with some information from "feel" and rate of penetration.

Mud Stabilised Drilling: Either Wash Boring or Continuous Core Drilling can use drilling mud as a circulating fluid to stabilise the borehole. The term 'mud' encompasses a range of products ranging from bentonite to polymers. The mud tends to mask the cuttings and reliable identification is only possible from intermittent intact sampling (eg. from SPT and U50 samples) or from rock coring, etc.

Continuous Core Drilling: A continuous core sample is obtained using a diamond tipped core barrel. Provided full core recovery is achieved (which is not always possible in very low strength rocks and granular soils), this technique provides a very reliable (but relatively expensive) method of investigation. In rocks, NMLC or HQ triple tube core barrels, which give a core of about 50mm and 61mm diameter, respectively, is usually used with water flush. The length of core recovered is compared to the length drilled and any length not recovered is shown as NO CORE. The location of NO CORE recovery is determined on site by the supervising engineer; where the location is uncertain, the loss is placed at the bottom of the drill run.

Standard Penetration Tests: Standard Penetration Tests (SPT) are used mainly in non-cohesive soils, but can also be used in cohesive soils, as a means of indicating density or strength and also of obtaining a relatively undisturbed sample. The test procedure is

described in Australian Standard 1289.6.3.1–2004 (R2016) 'Methods of Testing Soils for Engineering Purposes, Soil Strength and Consolidation Tests – Determination of the Penetration Resistance of a Soil – Standard Penetration Test (SPT)'.

The test is carried out in a borehole by driving a 50mm diameter split sample tube with a tapered shoe, under the impact of a 63.5kg hammer with a free fall of 760mm. It is normal for the tube to be driven in three successive 150mm increments and the 'N' value is taken as the number of blows for the last 300mm. In dense sands, very hard clays or weak rock, the full 450mm penetration may not be practicable and the test is discontinued.

The test results are reported in the following form:

 In the case where full penetration is obtained with successive blow counts for each 150mm of, say, 4, 6 and 7 blows, as

> N = 13 4, 6, 7

 In a case where the test is discontinued short of full penetration, say after 15 blows for the first 150mm and 30 blows for the next 40mm, as

> N > 30 15, 30/40mm

The results of the test can be related empirically to the engineering properties of the soil.

A modification to the SPT is where the same driving system is used with a solid 60° tipped steel cone of the same diameter as the SPT hollow sampler. The solid cone can be continuously driven for some distance in soft clays or loose sands, or may be used where damage would otherwise occur to the SPT. The results of this Solid Cone Penetration Test (SCPT) are shown as 'Nc' on the borehole logs, together with the number of blows per 150mm penetration.

LOGS

The borehole or test pit logs presented herein are an interpretation of the subsurface conditions, and their reliability will depend to some extent on the frequency of sampling and the method of drilling or excavation. Ideally, continuous undisturbed sampling or core drilling will enable the most reliable assessment, but is not always practicable or possible to justify on economic grounds. In any case, the boreholes or test pits represent only a very small sample of the total subsurface conditions.

The terms and symbols used in preparation of the logs are defined in the following pages.

Interpretation of the information shown on the logs, and its application to design and construction, should therefore take into account the spacing of boreholes or test pits, the method of drilling or excavation, the frequency of sampling and testing and the possibility of other than 'straight line' variations between the boreholes or test pits. Subsurface conditions between boreholes or test pits may vary significantly from conditions encountered at the borehole or test pit locations.





GROUNDWATER

Where groundwater levels are measured in boreholes, there are several potential problems:

- Although groundwater may be present, in low permeability soils it may enter the hole slowly or perhaps not at all during the time it is left open.
- A localised perched water table may lead to an erroneous indication of the true water table.
- Water table levels will vary from time to time with seasons or recent weather changes and may not be the same at the time of construction.
- The use of water or mud as a drilling fluid will mask any groundwater inflow. Water has to be blown out of the hole and drilling mud must be washed out of the hole or 'reverted' chemically if reliable water observations are to be made.

More reliable measurements can be made by installing standpipes which are read after the groundwater level has stabilised at intervals ranging from several days to perhaps weeks for low permeability soils. Piezometers, sealed in a particular stratum, may be advisable in low permeability soils or where there may be interference from perched water tables or surface water.

FILL

The presence of fill materials can often be determined only by the inclusion of foreign objects (eg. bricks, steel, etc) or by distinctly unusual colour, texture or fabric. Identification of the extent of fill materials will also depend on investigation methods and frequency. Where natural soils similar to those at the site are used for fill, it may be difficult with limited testing and sampling to reliably assess the extent of the fill.

The presence of fill materials is usually regarded with caution as the possible variation in density and material type is much greater than with natural soil deposits. Consequently, there is an increased risk of adverse environmental characteristics or behaviour. If the volume and nature of fill is of importance to a project, then frequent test pit excavations are preferable to boreholes.

LABORATORY TESTING

Laboratory testing has not been undertaken to confirm the soil classification and rock strengths indicated on the environmental logs unless noted in the report.



Where D_{10} , D_{30} and D_{60} are those grain sizes for which 10%, 30% and 60% of the soil grains, respectively, are smaller.

- 1 For a coarse grained soil with a fines content between 5% and 12%, the soil is given a dual classification comprising the two group symbols separated by a dash; for example, for a poorly graded gravel with between 5% and 12% silt fines, the classification is GP-GM.
- Where the grading is determined from laboratory tests, it is defined by coefficients of curvature (C_c) and uniformity (C_u) derived from the particle size distribution curve.
- 3 Clay soils with liquid limits > 35% and ≤ 50% may be classified as being of medium plasticity.
- The U line on the Modified Casagrande Chart is an approximate upper bound for most natural soils.

Laboratory Acceptance Criteria

Duplicate sample and matrix spike recoveries may not be reported on smaller jobs, however, were analysed at a frequency to meet or exceed NEPM requirements. All samples are tested in batches of 20. The duplicate sample RPD and matrix spike recoveries for the batch were within the laboratory acceptance criteria.

Filters, swabs, wipes, tubes and badges will not have duplicate data as the whole sample is generally extracted during sample extraction.

Spikes for Physical and Aggregate Tests are not applicable.

For VOCs in water samples, three vials are required for duplicate or spike analysis.

Duplicates: >10xPQL - RPD acceptance criteria will vary depending on the analytes and the analytical techniques but is typically in the range 20%-50% – see ELN-P05 QA/QC tables for details; <10xPQL - RPD are higher as the results approach PQL and the estimated measurement uncertainty will statistically increase.

Matrix Spikes, LCS and Surrogate recoveries: Generally 70-130% for inorganics/metals (not SPOCAS); 60-140% for organics/SPOCAS (+/-50% surrogates) and 10-140% for labile SVOCs (including labile surrogates), ultra trace organics and speciated phenols is acceptable.

In circumstances where no duplicate and/or sample spike has been reported at 1 in 10 and/or 1 in 20 samples respectively, the sample volume submitted was insufficient in order to satisfy laboratory QA/QC protocols.

When samples are received where certain analytes are outside of recommended technical holding times (THTs), the analysis has proceeded. Where analytes are on the verge of breaching THTs, every effort will be made to analyse within the THT or as soon as practicable.

Where sampling dates are not provided, Envirolab are not in a position to comment on the validity of the analysis where recommended technical holding times may have been breached.

Where matrix spike recoveries fall below the lower limit of the acceptance criteria (e.g. for non-labile or standard Organics <60%), positive result(s) in the parent sample will subsequently have a higher than typical estimated uncertainty (MU estimates supplied on request) and in these circumstances the sample result is likely biased significantly low.

Measurement Uncertainty estimates are available for most tests upon request.

Analysis of aqueous samples typically involves the extraction/digestion and/or analysis of the liquid phase only (i.e. NOT any settled sediment phase but inclusive of suspended particles if present), unless stipulated on the Envirolab COC and/or by correspondence. 


