## Planning Proposal – Land Within Manly Warringah War Memorial State Park

Dear Brownlee

Thank you for the opportunity to comment on the planning proposal to rezone land within the Manly Warringah War Memorial State Park under *Warringah Local Environmental Plan 2011* (LEP) from R2 Low Density Residential to RE1 Public Recreation.

Based on the information provided, we have reviewed the planning proposal against our records and note that there are no identified impacts on any items listed on the State Heritage Register. We do note that the proposal site has been identified as being close to, but not within, an Aboriginal heritage site.

Additionally, we note that the proposal site is located within the Manly Dam and Surrounds Heritage Conservation Area listed under Council's LEP. As the HCA is listed under your LEP, Council is the consent authority, and the assessment and consideration of any impacts on this HCA rests with Council.

Council has indicated that, at least in part, the purpose of this planning proposal is to reduce the likelihood of damage to this heritage by significantly reducing the range of permitted uses. As such, we consider that the planning proposal will have a positive heritage outcome.

Prior to finalisation of the proposal, Council should be satisfied that all necessary due diligence and heritage assessments have been undertaken and that any impacts have been sufficiently addressed. Council's assessment should include, but not be limited to, a search of the State Heritage Inventory (<a href="https://www.heritage.nsw.gov.au/search-for-heritage/search-for-nsw-heritage/">https://www.heritage.nsw.gov.au/search-for-heritage/search-for-nsw-heritage/</a>).
