Parking issues and tree destruction and overdevelopment and doing things illegally and more.

Officer comments

The proposal cannot be supported for the following reasons:

- 1. The front and rear setbacks have been breached with bay-windows and roofed over bbqpatio respectively.
- 2. The rear 25% of site which should be single storey has a living area proposed at 4.7m floor to ceiling height which will give the impression of a two-storey built form.
- 3. The separation gap between the two building blocks should be a clear 3 to 4m landscaped strip to

read as a proper break to reduce the bulk and scale of the development.

- 4. The proposed 30% landscaped area takes into account narrow strips of landscaped area that is 0.4
- to 0.9m wide. Only landscaped area of 2m width should be counted. The proposed linear 0.4m wide

strip next to the driveway should be increased in certain areas to create a more interesting and adequate planting buffer zones.

The proposal is therefore unsupported.

Recommended Heritage Advisor Conditions

I am back.

The council talks about keeping the canopy and we are not allowed to cut trees in our gardens except for 10% for pruning and it seems that this is something that greedy developers, can just avoid. (Donald Trump style).

There will be trees of high amenity value that will be destroyed. Very high amenity value BRUSHBOX 17 metres High Amenity value. Silvertop Ash 11 m Paperbark 12 m Old Man banksia 7 m Macadamia 6m

What about the Duffy's forest ecological community including Waratah and Woody Pears over 70 years old? that will be taken down
