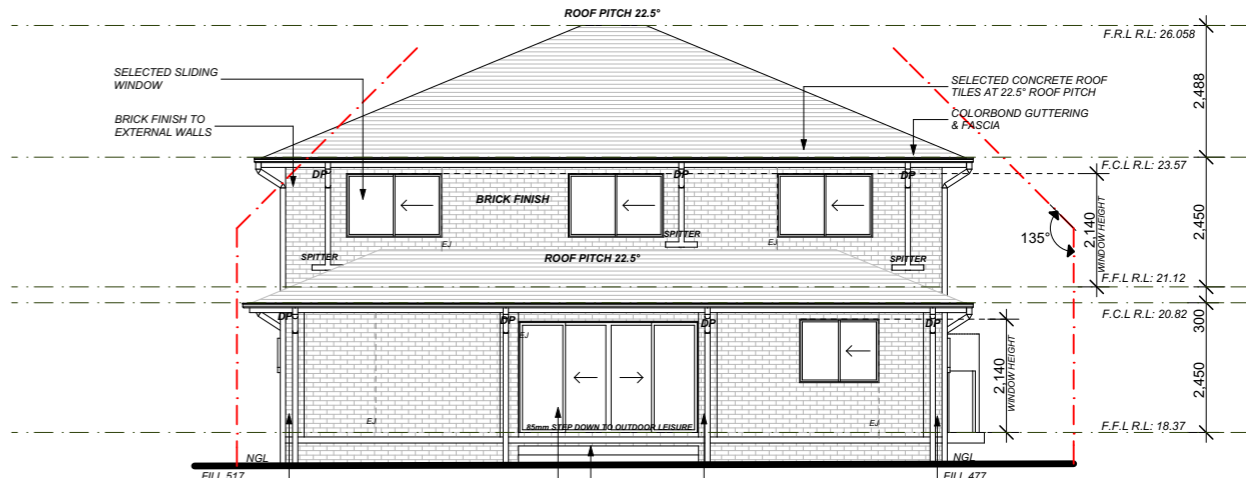

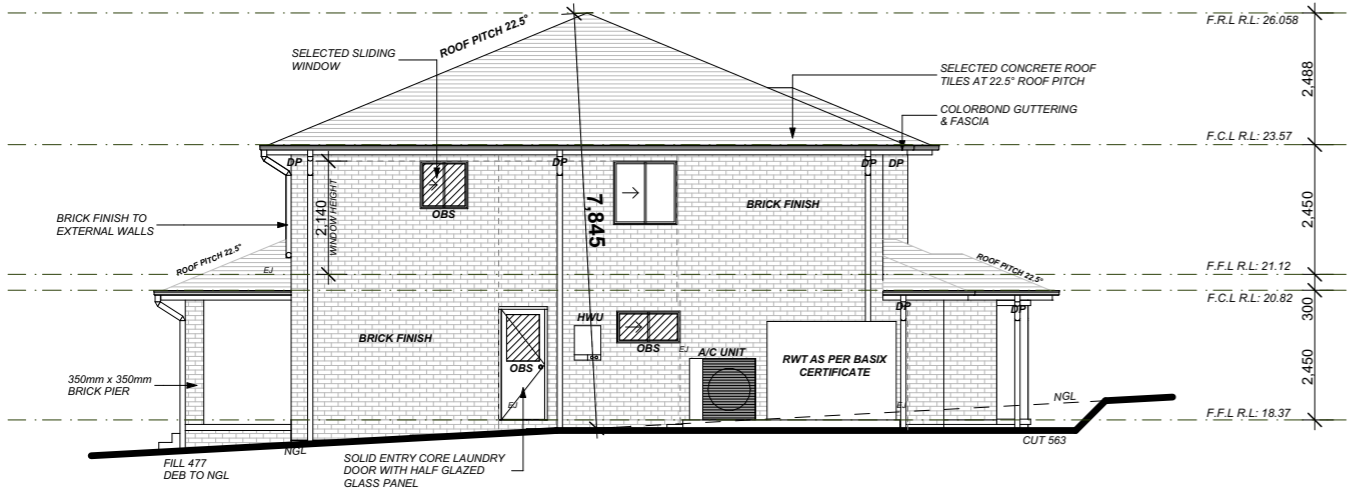
SITE PLAN

REAR/WEST ELEVATION



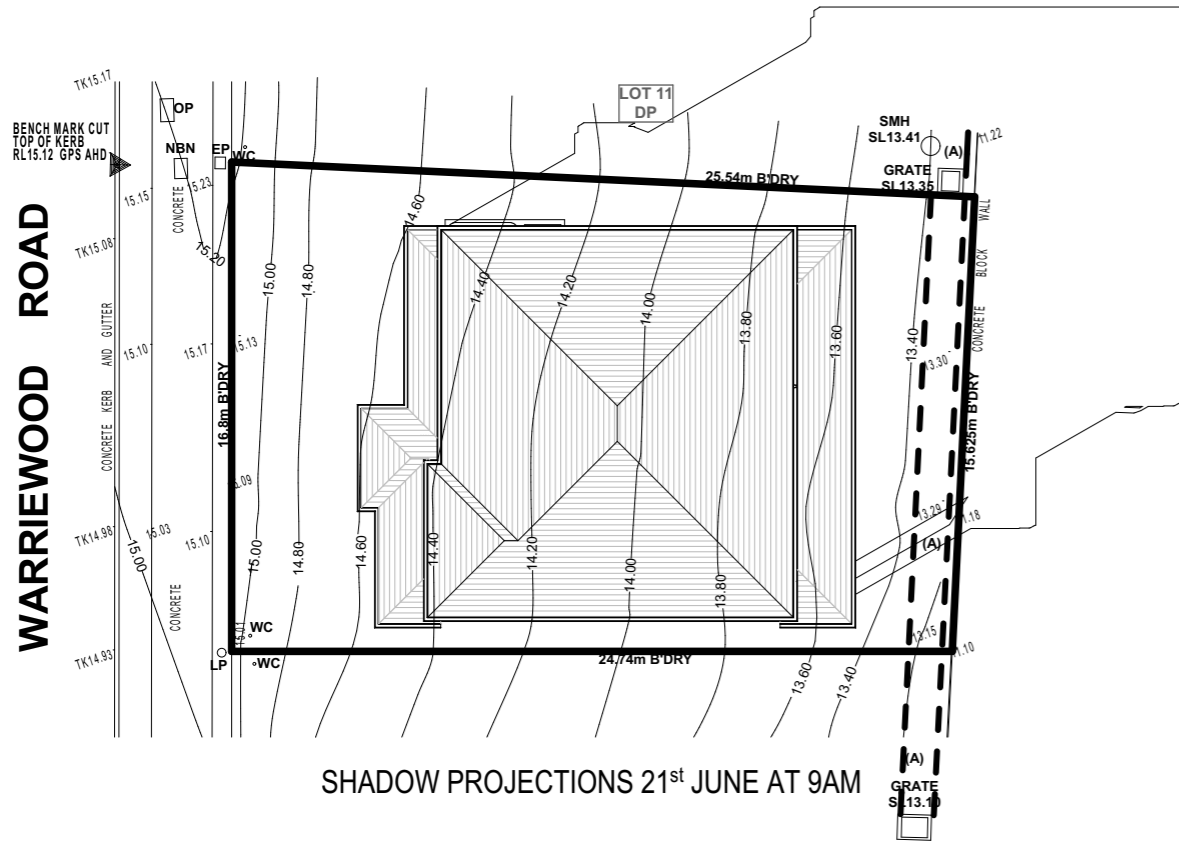
LEFT/SOUTH ELEVATION

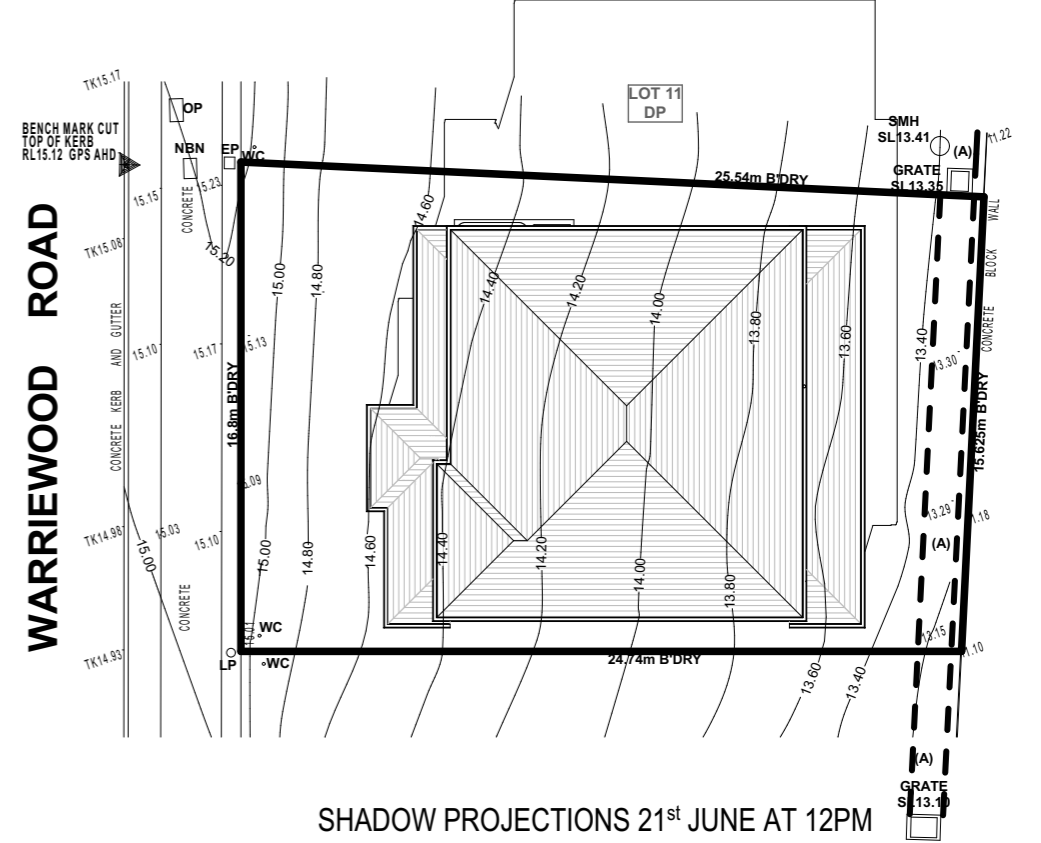

SHADOW PROJECTIONS 21st JUNE AT 9AM

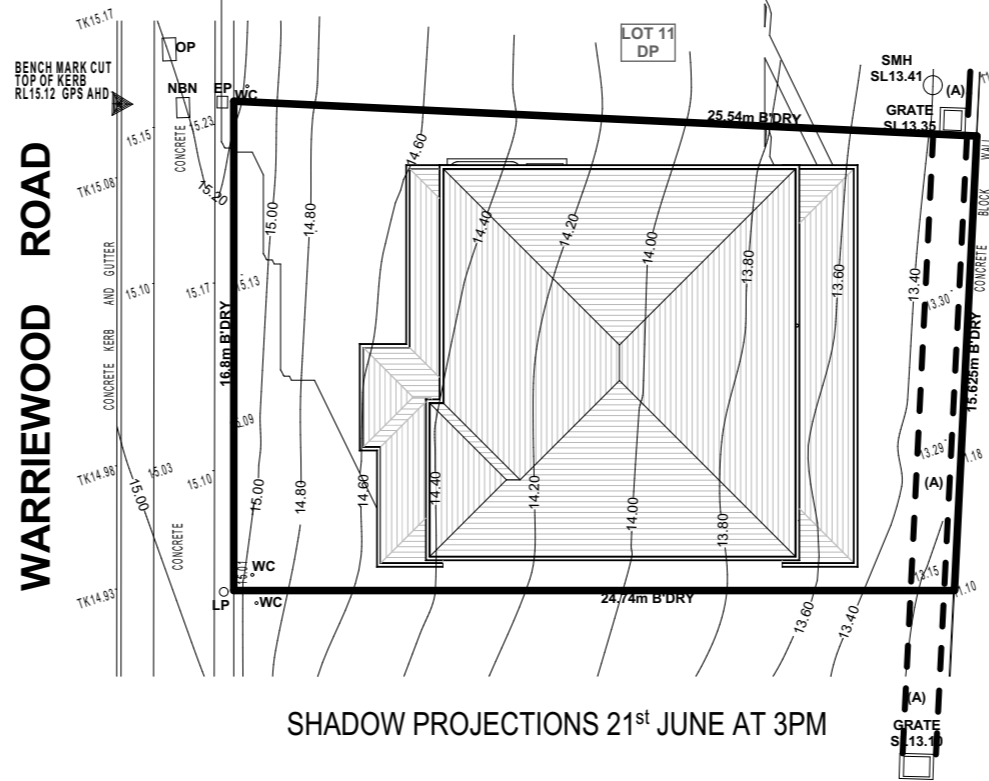
