Subject: Frenchs Forest Town Centre – Section 7.11 Contributions Plan

Dear Mr Phillips

I am writing in relation to the 'Frenchs Forest Town Centre – Section 7.11 Contributions Plan', which Northern Beaches Council submitted to the Independent Pricing and Regulatory Tribunal (IPART) for assessment. I also note representations made by the Council about the Plan to the Minister for Planning and Public Spaces, the Hon. Paul Scully MP (2023/327371). I am responding on his behalf.

IPART has completed its assessment and made 8 recommendations in relation to the Plan, including 2 relating to matters raised in the Council's representations. As nominee for the Minister for Planning and Public Spaces, I have considered IPART's recommendations, and the concerns raised by council, and have accepted the recommendations in full or with amendment. In particular:

- Recommendation 3 of IPART's final report has been amended so that it is only the embellishment costs already met by grants received that must be removed from the Plan.
- Recommendation 4 continues to require the construction costs of the community hub building to be removed.

I note the Council's request for an exemption from the essential works list to allow these costs to be included. I understand that these costs represent a small proportion of the costs of infrastructure proposed to be funded under the Plan. There is no scope for exemptions to the essential works list for individual plans under current policy settings.

I also note Council's request for changes to the essential works list to include the construction of community facilities generally. This is not consistent with current government policy and would represent a significant change. The Department of Planning and Environment (the department) continues to explore opportunities for improvement in local infrastructure contributions but is not pursuing significant changes to the way councils collect them.

Once the amendments required by **Attachment A** have been made and the Council has finalised the plan, it will be considered as having met the requirements of being an IPART reviewed contributions plan within the meaning of clause 5(3) of the *Environmental Planning and Assessment (Local Infrastructure Contributions) Direction 2012.*
