1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of Stage 2 of the Jamieson Park Sports Amenities Building project conducted between 3 April to 12 May 2024.

In 2022, we asked the community for their input on what the new sports amenities building at Jamieson Park should include to ensure it meets the needs of the community and the clubs who use the site. During Stage 2 of community consultation, we presented the concept design and gathered feedback to assess its alignment with community priorities.

Feedback gathered indicated a strong level of support for the proposed concept design where we received 89% 'Yes' or 'Yes with changes'.

Key considerations captured in those responses saying 'Yes with changes' (44% out of 89%) suggesting:

- preservation of the park's natural character / open space
- consideration be given as to whether a café is viable and whether it would impact on local businesses
- environmental sustainability and flood resilience building design
- · to consider onsite parking capacity / traffic management
- to enhance public amenities

Overall, the feedback reflects a strong community support for the proposed development. This input will help refine the design, support the development application and be used as evidence for grant funding.





2. Background

In 2022, we asked the community for their input on what the new sports amenities building at Jamieson Park should include to ensure it meets the needs of the community and the clubs who use the site.

Since that time, we worked closely with the Narrabeen Lakes Sailing Club and the appointed architects to produce concept plans that capture the main elements of what we heard from the first round of community engagement.

We are now asking the community what they think of the proposed concept design and whether it meets the needs of the community in the second round of community engagement. The feedback received is intended to inform a consultant brief to be included in tender documents for engagement of a design consultant team. This team will be responsible for developing the proposed concept design into a development application which may also be used for grant funding applications.

3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities
- provide accessible information so community and stakeholders can participate in a meaningful way
- provide balanced and objective information to assist in understanding the problem, alternatives and/or solutions
- identify community and stakeholder concerns, local knowledge and values.

4. Engagement approach

Stage 2 of community and stakeholder engagement for the Jamieson Park Sports Amenities Building took place from 3 April to 12 May 2024. This phase included a series of activities that provided opportunities for community members and stakeholders to contribute their insights.



The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022).

A Your Say project page was established with information provided in an accessible and easy to read format. Key stakeholders, resident groups, and local residents were sent notification letters inviting their feedback on the proposed concept design. The project was primarily promoted through our regular email newsletter (EDM), media channels, and signage in the area to effectively reach individuals frequenting the location.

Feedback was collected through an online comment form embedded on the Your Say project page. This form included a question that directly asked respondents to indicate their level of support for the proposed concept design and whether it aligns with the community's needs. Two onsite pop-up events were held (weekday and weekend) where our project team was present at the proposed location to gather feedback and encourage community participation. We also invited comments through email and in writing.

4.1. Reaching diverse audiences

In support of the two stages of community engagement seeking to understand the needs of the whole community, a stakeholder mapping exercise was conducted to identify the key user - Narrabeen Lake Sailing Club as well as other community groups including Dragon Boat Club and Maritime Model Club of NSW (Narrabeen) for feedback on the proposed concept design.

Community participation and awareness were encouraged through a series of activities conducted including:

- information was provided on Council's Have Your Say project page
- two community pop-up events with the project team
- letterbox drops to neighbouring residents
- displays of onsite notification posters
- Mayor's weekly e-news.

5. Findings

The proposed concept design has been positively received, with 89% of participants indicating support, either unconditionally or with suggested changes. The community engagement process has provided valuable insights into local priorities and considerations which suggest:

- preserving the park's natural character / open space
- assessing the viability and impact of a café on local businesses
- incorporating environmental sustainability and flood-resilient building design
- addressing onsite parking capacity and traffic management
- enhancing public amenities.

The process has also captured issues, change requests and other considerations that are noted in Table 1.



In conclusion, strong community support and constructive feedback have been received for the proposed concept design. The input will help to refine the design, support the development application and be used as evidence for grant funding.

Building size and park's character preservation	While majority of the community appreciates the modern aesthetic of the proposed concept design, some respondents commented that the structure may be too large for the site, and that it may potentially be encroaching on valuable open space and impacting on the park's peaceful and family-friendly atmosphere. Some respondents also indicated a preference of maintaining as much open space for recreational activities as possible and suggested reducing the building footprint to preserve open space and potentially lower building cost.	The building size proposed in the concept design was dictated by a number of project requirements including the needs from the community and key stakeholders. Feedback has been noted and we will continue to work on balancing competing needs, project opportunities and constraints in the next design development stage.
Cafe inclusion	The inclusion of a café received mixed feedback. Supporters see it as an enhancement to the park experience, while others expressed concerns about increased traffic, parking pressures, and competition with existing local businesses. This division highlights the importance of carefully considering the cafe's role and potential effects on the broader community.	Feedback has been noted. A feasibility study will be considered to assess the café's viability and local impacts, with findings to inform the next design stage.
Building Design	Environmental sustainability emerged as a priority. Respondents suggested ecofriendly features such as solar panels, rainwater harvesting and flood-resilient designs. Suggestions also included lighter-coloured roofing materials.	Feedback has been noted and will be reviewed in the next design development stage.
Community group requests	Community members, particularly water sports enthusiasts, highlighted the need for improved storage facilities. Requests included space for equipment and watercraft such as dragon boats.	Feedback has been noted and will be reviewed in the next design development stage. Public amenities	There was a desire for improved facilities identified from the community feedback for more public amenities, including larger and more toilets, a family-friendly change facility, outdoor showers, and covered picnic areas, to support recreational use of the park. Timeline and process	Some community members called for more clarity about expected timeline and project updates.	Unfortunately, there is a shortfall in funding for this project; therefore, the project has been temporarily paused until additional funding can be identified. When a clear funding path has been determined, progress will be subject to further community consultation, stakeholder feedback and planning constraints. Once Council are in a position to commence construction, it is expected to be a 12 month construction period, weather permitting. Any project updates will be published on the Your Say

3	First impressions, good design with good use of space. Good quality clean toilets are essential to the area. A shower would be good as well. So long as the cafe and toilets remain for public use, and aren't made exclusive to the Sailing Club, then it has my support.
	Would be good to do something about keeping traffic one way through the carpark and loop as I too often see cars going the wrong way.
4	I personally feel the proposed development is too large for the site. It has traditionally been a relaxed place for family barbecues, etc. A large structure in the centre of Jamieson park would reduce the open space significantly and change the open ambience of the area. Also, unless a care-taker is employed continuously, vandalism could be a serious concern. Could Sailing Club afford one or would the Council pay? Local residents should be informed if haven't already been so as it will affect the value of their properties with increased traffic, parking and noise from functions at night as proposed.
5	This current design satisfies the wishes of the sailing boat community but does little for the Narrabeen Dragon boat club. During the on site consultation there was a discussion on possibly including a separate shelter for the dragon boats. This would be a positive outcome otherwise the dragon boat club will require more space in the new building. I have been a northern beaches ratepayer for over 20 years and I have seen other clubs (eg sailing, kayaking/ canoeing and scouting) have been provided permanent shelter but very little help provided to the dragon boat clubs. In comparison many other councils around the country have encouraged the sport by providing a club house. This is very disappointing considering the large community participation in this active sport domestically and internationally. In summary the Narrabeen dragon club club requires a large permanent position in the new the new building or a external shelter to house our boats.

7	Hello NBC, The proposed concept design appears to provide enhanced facilities for the Narrabeen Lakes Sailing Club which are much needed given the old facility had outlived its 'fit for purpose' role. This once in a lifetime opportunity to build a new facility should be maximised by: - increased public space in and around the front of the facility for sailboat rigging and general public use (eg kids parties, family gatherings etc) by moving the building footprint back (south) as far as possible. - ensuring efficient use of boat storage space for the sailing club by ensuring a design which maximises floor to ceiling space to enable internal boat storage racks and other storage (eg no roof lines that compromise design aesthetics over usable space). Design should also be simplified to maximise use of available budget.

Boat rigging ('boat prep' on the plans) needs more buffer space between the boats and the public than is evident on the plans, for the safety of the public. It would be better to set the barbeques further away from the building and from the boat access way. If the whole building was set a little further back from the water there would be more space on the Northern (lake) side of the building for boat prep and barbequers alike.

56	I'm not at all sure you have properly factored in the amount of space required for dragon boats. They can be 12m in length, and as they can also weight as much as 350kg, they are not easy to move about, and don't really 'stack' well without overhead crane type facilities. I understand the loop road an dparking has not yet been finalised, but it would be desirable to have 'nose in thrpough parking' for boat and trailer combos, for visiting sailors to park, and some sort of connection to the ramp and shoreline for vehicles and trailers to traverse. I am a member of a different sailing group that does on occasion use narrabeen and we need this facility. Otherwise, the plan look good. Cafe is a good idea. Jamieson Park Sports building concept design – NLSC feedback

The purpose of this document is to provide the Narrabeen Lakes Sailing Club's feedback on the Jamieson Park Sports Amenities Building concept design that was released in April 2024 to the community.

High-Level Considerations:

The proposed design is a positive step forward and broadly meets the sailing club's needs as well as those of the broader community. The sailing club committee and its members appreciate the effort put by council and the architects into creating a facility that can enhance local activities and help the club thrive. We have structured our feedback into key high-level considerations which could substantially improve the final result for the community and lower level considerations that are more designed to improve the result for the sailing club.

Key points for consideration:

- Simplify Design: Recommend keeping the building design simple to manage costs while maintaining visual appeal. Specifically, we recommend minimizing elaborate features like complex roof lines to keep construction expenses reasonable.
- Optimal Building Placement: Explore shifting the building slightly south to maximise open space, rigging area and community gatherings, while also reducing wasted public space.
- Include Sustainability Features: Request the integration of sustainable elements such as solar panels, rainwater storage, and energy-efficient systems to align with our club's commitment to environmental responsibility. The inclusion of these features would enhance the building's long-term efficiency and environmental impact.
- Clarify Collocation Plans: Seek detailed information on contingency plans for commercial spaces, such as a proposed coffee shop, in case of vacancy. Understanding these plans is crucial for evaluating the long-term viability of collocated operations.

Detailed Design Considerations:

- 1. Room Functions and Layout:
 - Boat Storage Consideration: Compared to previous concept designs, the latest plans lack modelling for boat storage. Given the altered shape of Room G.01, it is recommended to assess if this new layout accommodates and facilitates boat storage effectively, similar to earlier concept designs.
 - Room G.04 (Multipurpose Space): Explore the possibility of relocating Room G.04 to enhance visibility and optimise usage within the building layout. By strategically

placing this multipurpose space, we can ensure better integration with other areas and improve overall functionality for club activities.

- 3. Room G.05 (Canteen): Evaluate the layout and capacity of the canteen area (Room G.05) to ensure it can efficiently serve the needs of sailing club members and cater to visitors passing by. Focus on storage capacity, functionality and accessibility. As a counterexample in the previous club design, an additional fridge had to be installed in the office to ensure sufficient storage.
- Room G.06 (First Aid Room): Verify that the first aid room (Room G.06) meets but doesn't exceed regulatory standards for safety and emergency response.
- Room G.07 (Office): Assess the proposed office space (Room G.07) to ensure it fosters efficient administration of club operations.
- Rooms G.08 and G.12 (Accessible Toilets): Explore the possibility of consolidating
 the designated accessible toilets to serve both sailing club members and members of
 the public efficiently. Deduplicating these spaces can optimize usage and ensure
 accessibility for all users without the need for separate facilities.
- Outdoor boat racks: those racks on the north westerly section of the design is new compared to previous concept designs. Please confirm intended use.

2. Other Key Areas:

- Ramp Inclinations: Ensure practical ramp designs and ramp inclination to facilitate safe boat handling during all weather conditions, without the use of cars or powered winches.
- Storage and Facilities: Seek clarity on intended storage areas for amenities such as cafe furniture storage, to optimise space and functionality.
- Fire Protection Standards: Emphasize the importance of robust fire protection measures to prioritize the safety and security of everyone within the building.

As the long ignored Dragonboat club at Narrabeen continue to attempt to continue, without proper coverage for boats, and storage for life saver equipment, no matter how hard they try to

	build, without proper (or even any) support from the council and the build, they will struggle to prosper. The current build is very 'glass'. The Dragonboat club doesn't need the world, and potentially can source sports grants to assist with the funding of the build, yet have seemingly been left out of the equation in the design. 	This design is a commercial facility (Cafe) with a Sailing Club boat house behind whereas the previous building was a Club boat house with a commercial facility behind.
	I am concerned that with this configuration the distance required to get boats from the water to the boat house is excessive and that any commercial operator may be inconvenienced by boats and vehicles in front of there facility.
	Careful design of the ramps from the water to the boat house will be required to ensure safe and easy access each way.
	The Club also requires considerable space as a rigging area outside the boat house. In the past we have been able to use the beach at the water but for some considerable time this beach area has been degraded and unusable. We now use the large grassed area where the building used to be. With the position of the proposed building space appears to be limited taking into account we need space free of tree overhang because of boat masts.
	Other concerns with the internal layout of the proposed building are: • Will the Club amenities include showers. • The public amenities appear quite small. Will they include showers.
	 Access to the Club's area must be limited to the Club's side with no access from the commercial facility. What is the expected use of the Watersport facility.
	 The layout of the boat house needs amendment. We do not need a separate workbench room or storage room. These ares would be better as part of the open space of the boat house to allow for movement. Shelving on the walls would suffice for storage.
	 A separate first aid room does not seem necessary. The Club has existed for 124 years without this luxury. This space would be better as part of an office. Externally – who is the Loading Bay for.

I wish to express my strong disagreement with the concept design.

This is consuminging too much ground space of this vital environmental access for small sailboating and kayaking.

There are no other natural access areas on the notherm beaches for people with modest financial resources and small sailboats to access placid waters with sufficent clear winds to enjoy a day out.

This is a location where many young children have been safely introduced to sailing. Sydney Harbour does not offer this due to rougher wave action on the Harbour and boat wash and boat traffic. Pittwater has very expensive parking and no suitable launching and parking areas for small sailboats.

We need parking space for the car, space to manouver a small trailer, space to rig the boat. Dragon boats belong on pittwater and inner harbour not Narrabeen Lagoon.

Also the southern end of the Lagoon at Middle creek reserve is too shallow to use a centreboard and Jamieson Park is the ideal access.

I'm astounded by how over-engineered the design is for the proposed Jamieson Park Sports Amenities Building. Whilst the proposal building looks beautiful, it's my understanding that there is not sufficient project funding to pay for such an elaborate structure. I'm also concerned about vandalism given the somewhat secluded position of Jamieson Park.

I understand that previous community consultation and stakeholder feedback was largely skewed towards what the Sailing Club were asking for, which I understand as they've been an important club in the area for years. They are however, not the only sports club to use this building and I think a wider lens needs to be applied to community needs.

I've been a competitive dragon boat paddler at Jamieson Park, Narrabeen for over 4 years now. My business is a sponsor of the Narrabeen Lakers Dragonboat Club and I'm actively involved in attracting new local members to join us, which is hard work without a solid base for our club.

I appreciate that proposed space has been allocated for "Model and Dragon Boat Storage" in the proposed floor plan (G.13), but with our dragon boats being 12 meters in length, constructed of solid

teak and weighing approximately 680kg, I'm assuming that the storage allocated is for our paddles, life jackets, defibrillator, paperwork, cleaning gear etc., and that our boats will remain resting on the grass near the creek. If this is the case, every time the lake floods we are putting our club members in danger sending them into flood waters to retrieve the boats and drag them up to higher ground.

What we need is:

- a) Storage for our valuables in a dry and secure place a storage room.
- b) A covered structure to house our boats which is accessible to the lake, on a concrete base, secure from vandals.

The proposed building as displayed, in no way resembles the original structure. Therefore, the "like for like" insurance regulation will not be acceptable. As someone who works in the building side of the insurance industry, replacing structures with the "like for like" constraints, this does not conform.

It is also unnecessary for the requirements of the groups that need the space for their various activities. The sailing club require the most storage space, yet are only there 3 hours on a Sunday for 6 months of the year. The Narrabeen Dragon Boat Club, who I have been paddling competitively with since 2020, paddle there year round and keep our boats out in the open next to the creek. They are susceptible to flooding and vandalism. All we need is a covered, locked up paved or concreted area where we can wheel them into position and store some paddles and safety equipment. The boats weigh over 650 kg, and are 12 metres long, so lifting them onto racks is not an option.

I feel that the "up market" dining area proposed will be a magnet to late night underage drinking and vandalism. Thus, increasing the danger to our equipment. There appears to be way too many unnecessary rooms to accommodate a few sporting clubs. It probably only needs lots of open space for storage and a kitchen.
