### **Design and Operation of Skin Penetration Premises**

The ongoing operation of the skin penetration and beauty salon premises including all associated equipment must be maintained in accordance with the relevant and current guidelines including:

- Public Health Act 2010
- Public Health Regulation 2012
- Schedule 2, Local Government (General) Regulations 2005

- AS/NZS 4187:2003 Cleaning, disinfecting and sterilizing reusable medical and surgical instruments and equipment, and maintenance of associated environments in health care facilities.
- Disposal of clinical waste according to Protection of the Environment Operations (Waste) Regulation 2014.

Reason: To ensure compliance with legislation and to protect public health and safety.

#### **Registration of Skin Penetration Business**

The skin penetration businesses must be registered with the Appropriate Regulatory Authority.

Reason: Skin penetration premises are required to be registered with the Appropriate Regulatory Authority (Council).

### Skin penetration and beauty salon premises fit out certification

Prior to the issuing of any interim / final occupation certificate, certification is to be provided from a suitably qualified professional that the design, construction and fit out of the skin penetration and beauty salon premises is compliant with the relevant and current guidelines including:

- Public Health Act 2010
- Public Health Regulation 2012
- Schedule 2, Local Government (General) Regulations 2005
- AS/NZS 4187:2003 Cleaning, disinfecting and sterilizing reusable medical and surgical instruments and equipment, and maintenance of associated environments in health care facilities.

Reason: To ensure compliance with legislation and to protect public health and safety.
