SUBJECT SITE: 9 Rowan Street Mona Vale, NSW

Alterations and additions to dwelling house including a garage

The document discusses five (5) subject site trees. The subject site is known as 9 Rowan Street Mona Vale, NSW 2103.

The purpose of this letter is to provide the requested information (Tree Management) linked to the Return of Application letter the from the consent authority, the Northern Beaches Council.

We were provided by project architect (Leigh Graham) representing the subject site property owners with numerous documents relative to the process of progressing the to the next phase of proposed DA works for *Alterations and additions to dwelling house*'.

The subject site was inspected on Tuesday, 18 February 2025 by Kyle hill & Ao Wang as the representatives for the Growing My Way Tree Consultants practice.

One (1) Jacaranda mimosifolia (Jacaranda) is located within the front yard of the subject site, the other four (4) trees are located within the subject rear yard, they are identifie to be a Triadica sebifera (Chinese Tallow), Lophostemon confertus (Brush Box), Melaleuca quinquenervia (Broad-Leaved Paperbark) & Eucalyptus resinifera (Red mahogany).

The *Jacaranda mimosifolia* (Jacaranda) & *Triadica sebifera* (Chinese Tallow) are exempt species & therefore are only required to be acknowledged as such, refer to the Northern Beaches Council Pittwater 21 DCP. Only these two (2) exempt trees are potentially impacted by the as lodged DA proposal.

The other three (3) trees are more than 5 meters from the proposed works. On this basis, no discussion relative to any potential impact is required to be discussed.
