## Reasons for referral

Council's Water Management Officers are required to consider the likely impacts.

## **Officer comments**

Not supported This application was assessed in consideration of:



- Supplied plans and reports;
- Northern Beaches Water Management for Development Policy (WMD Policy); and
- Relevant LEP and DCP clauses.

The stormwater treatment chain proposed is insufficient. Table 5 – General Stormwater Quality requirements of the WMD Policy apply. Evidence that the proposal meets the table 5 requirements must be provided. Refer to WMD Policy section 4.1.3 Demonstrating Compliance.

The proposal includes a basement. The geotechnical report provided indicates that the proposal is likely to intercept groundwater and a tanked basement is recommended. Referral to WaterNSW is required and this will make the proposal Integrated Development. A Council permit for dewatering will also be required but can be attained prior to construction.

The proposal is therefore unsupported.
