We have had a good look now and the application seems relatively thorough and the design and colour scheme of the secondary dwelling looks like it would be a reasonably suitable for its surrounds.

We note that the visual amenity at a street level seems to have a low impact as the contours drop away leaving about 1 - 2m visible from the street.

However, the screening of the car park in front of the secondary dwelling would need to have careful attention so it actually screens the car parked behind...I can imagine a situation where a half baked attempt of plantings hardly covers a brightly coloured car behind it.

Also, what would be helpful is a visual perspective from our property sight line. Our kitchen view looks directly across at the secondary dwelling and it would be good to see what that looks like and the potential impact to the view to be able to provide our support or rejection of the application.
