## Reasons for referral

This application seeks consent for the following:

- All Development Applications on land, and located within 40 metres of land, containing a watercourse, or
- All Development Applications on land containing a wetland, or located within 100m of land containing a wetland,
- All Development Applications on land that is mapped as "DCP Map Waterways and Riparian Land".

And as such, Council's Natural Environment Unit officers are required to consider the likely impacts on drainage regimes.

#### Officer comments

This application has been assessed under:

- SEPP (Coastal Management) 2018 (Coastal Environment Area)
- Pittwater 21 DCP B5.8 (Stormwater management water quality)

- B4.14 (Development in the vicinity of wetlands).

All three can be met by complying with Pittwater 21 DCP B5.8.

The application can meet the requirements of Pittwater 21 DCP B5.8 if it complies with the following that are conditioned.

A silt arrestor pit must be incorporated into the stormwater drainage line prior to stormwater being discharged from the land. It is recommended that the 600x600 pit located just inside the land to be acquired by the RMS be upgraded for this purpose.

Sediment and erosion controls must be installed prior to any soil disturbance on site and maintained until all work is complete and groundcover is re-established.

# Water Quality - Low Density Residential



To comply with Pittwater 21 DCP B5.8, the applicant must install stormwater quality improvement measures as follows:

- Pre-screening of organic matter (eg. leaf litter) prior to the collection of rainwater in the rainwater tank - filtration of stormwater to capture organic matter and coarse sediments prior to discharge from the land.

Provision must be made for maintenance access.

Details demonstrating compliance are to be submitted to the Certifying Authority for approval prior to the issue of the Construction Certificate.

Reason: Protection of the receiving environment (DACNECPCC1)

# CONDITIONS THAT MUST BE ADDRESSED PRIOR TO ANY COMMENCEMENT

## Installation and Maintenance of Sediment and Erosion Control

Sediment and erosion controls must be installed in accordance with Landcom's 'Managing Urban Stormwater: Soils and Construction' (2004).

Techniques used for erosion and sediment control on site are to be adequately maintained and monitored at all times, particularly after periods of rain, and shall remain in proper operation until all development activities have been completed and the site is sufficiently stabilised with vegetation.

Reason: To protect the surrounding environment from the effects of sedimentation and erosion from the site (DACNED06)
