I object to the proposed Optus phone tower and associated infrastructure being erected on the northern bank of Curl Curl Lagoon or in any other part of John Fisher Park in the future. The whole area is still recovering from the catastrophic decisions made by authorities decades ago when there was little understanding about the consequences of their actions.

Thankfully, we now live in a more enlightened society. None the less the rehabilitation programme will continue for many years into the future.

#### Results of ignorance

Until the middle of last century, Curl Curl Lagoon was a lush pristine wetland with meandering creeks providing habitat for fish and birdlife, flora and fauna.

In the 1950's authorities, in their ignorance, allowed the area to be used for landfill. The pristine wetlands were offered up to become the local tip resulting in the waterway and surrounding lands becoming heavily polluted.

Over the last 50 years, with the benefit of state and federal funding, Council has worked with local community groups to rehabilitate that wasteland. Over time and with much toil, it was gradually transformed into the valuable recreational asset it is today.

However, the reality is that we cannot yet claim success - this is not the end of the story. The water and subsoil are still heavily polluted. Experts say it will take 100 years before the area recovers from the degradation caused by past practices and poorly informed decisions.

#### Restoring Pride in Curl Curl Lagoon

As part of ongoing efforts to improve the lagoon surrounds, Northern Beaches Council is currently rehabilitating the northern bank with \$100,000 funding from NSW Environmental Trust. The three-year '*Restoring Pride in Curl Curl Lagoon*' grant is supported by James Griffin, MP.

The images below provide a visual representation of progress made so far with Stage 1 and Stage 2 of the '*Restoring Pride in Curl Curl Lagoon*' rehabilitation works.

Also depicted is what the same northern bank could look like if construction of the tower and infrastructure – **located within metres of the current rehabilitation works** - is approved.

There can be no justification for wilfully allowing the proposed development to inflict even more damage on this fragile space still in recovery. It would be adding insult to injury.
