I hope this letter finds you well. My name is Mark Dover and I am a concerned resident of 41 Roseberry Street, Manly Vale. I am writing to formally express my opposition to the proposed development application submitted by McDonald's to construct a 24/7 restaurant in our residential area. As someone who values the well-being of our community, I believe that this development poses several serious concerns that must be addressed before any approval is granted.

Firstly, our residential area, specifically in that area of Roseberry Street, Kenneth Road and Condamine Street is already grappling with significant traffic congestion issues. The addition of a McDonald's operating 24/7 will undoubtedly exacerbate this problem. The increase in human traffic, as well as the influx of vehicles and delivery trucks, will contribute to further congestion on our streets, leading to longer commute times and increased frustration among residents.

Secondly, the continuous operation of a McDonald's restaurant will likely result in heightened levels of air pollution, noise pollution, and rubbish pollution. The constant flow of traffic and the presence of a fast-food establishment will introduce more exhaust fumes, noise from vehicles and patrons, and litter from discarded packaging. These environmental impacts will degrade the quality of life for residents, particularly those living in close proximity to the proposed site.
