


NORTH EAST ELEVATION




SOUTH EAST ELEVATION

External wall: framed (weatherboard, fibro, metal clad) — R1.30 (or R1.70 including construction) Roof: foil backed blanket (55 mm)
Flat ceiling, flat roof: framed — ceiling: R1.58 (up)
Roof colour: medium (solar absorptance 0.475 — 0.70)
