Planning Proposal PP0002/13

We wish to object in the strongest terms to what is proposed in the above application with regard to the rezoning of lands along Warriewood Road and Macpherson St that could allow development densities to substantially exceed those defined in the recently adopted Warriewood Valley Strategic Review.

With all the effort that went into the Strategic Review on the part of Council, the NSW Department of Planning and Infrastructure (DoP&I), the consultants involved, and the community, it is beyond belief that such a proposal has been submitted. The community were outraged over the earlier proposals that were submitted and subsequently approved by the PAC, and the Warriewood Valley Strategic Review was subsequently instigated by DoP&I and the PAC before any further approvals would be considered. The Strategic Review has now been completed as a joint exercise between DoP&I and Council. The Strategic Review, following extensive consultation, determined that the maximum density that should be allowed in any area of the Warriewood Valley was 32 dwellings per Hectare. The Strategic Review was subsequently endorsed by DoP&I and adopted by Council. We therefore fail to understand on what possible grounds this application has merit.

There are many reasons why this application is quite inappropriate in the Warriewood Valley, including:

- 1. Lack of adequate infrastructure to support such increased dwelling density.
- 2. Increased risk of flooding.
- 3. The inappropriate bulk and scale of the proposed built form in this application, given what has already been recently built in the Warriewood Valley, based on the planning framework in place at the time.

There are many other reasons that have been properly addressed in the recent Strategic Review, and the many submissions that were received by Council and DoP&I on that review.

Suffice is to say, that the Strategic Review is the proper document against which this application should be assessed, and by any test, even density alone, this application fails completely, and must therefore be rejected if the community is to have any confidence at all in the planning approval process.

Making a planning application to a council

- (b) all gifts made to any local councillor or employee of that council.

Making a public submission to a council

Under section 147(5) of the Act a person who makes a *relevant public submission* to a council in relation to a relevant planning application made to the council is required to disclose the following reportable political donations and gifts (if any) made by the person making the submission or any *associate of that person* within the period commencing 2 years before the submission is made and ending when the application is determined:

- (a) all reportable political donations made to any local councillor of that council
- (b) all gifts made to any local councillor or employee of that council.

A reference in sections 147(4) and 147(5) of the Act to a reportable political donation made to a 'local councillor' includes a reference to a donation made at the time the person was a candidate for election to the council. **How and when do you make a disclosure?**

The disclosure of a reportable political donation or gift under section 147 of the Act is to be made:

- (a) in, or in a statement accompanying, the relevant planning application or submission if the donation or gift is made before the application or submission is made, or
- (b) if the donation or gift is made afterwards, in a statement of the person to whom the relevant planning application or submission was made within 7 days after the donation or gift is made.

What information needs to be in a disclosure?

The information requirements of the disclosure are outlined in the Act under section 147(9) for political donations and section 147(10) for gifts.

Pages 3 and 4 of this document include a Disclosure Statement Template which outlines the relevant information requirements for disclosures to a council.

Note: A separate Disclosure Statement Template is available for disclosures to the Minister or the Director-General of the Department of Planning.

Warning: A person is guilty of an offence under section 125 of the *Environmental Planning and Assessment Act* 1979 in connection with the obligations under section 147 only if the person fails to make a disclosure of a political donation or gift in accordance with section 147 that the person knows, or ought reasonably to know, was made and is required to be disclosed under section 147. The maximum penalty for any such offence is the maximum penalty under Part 6 of the *Election Funding and Disclosures Act* 1981 for making a false statement in a declaration of disclosures lodged under that Part.
