² A Site Analysis Plan (essentially Drawing S02), Erosion and Sediment Control Plan and Waste Management Plan (Drawing S04), Landscaping Plan (Drawing S03) and Section Plans (Drawings S10 and S11, which also show excavation and fill) are incorporated into these Plans.



With regard to Item 2.8(b) of the DA form, please note that Daniel Thomas is a Director of the Trustee Company, Regada Nominees Pty Ltd, which owns the property at 1174 Pittwater Road. Daniel is an employee of Northern Beaches Council (he is a Life Guard at Manly Swimming Pool).

With regard to Item 3.3 of the DA form, 1174 has ticked "trustee". Although 1182 is a strata property, it is a duplex that does not have an Owners Corporation, so no common seal is applicable, nor minutes on strata management letterhead.
