## 2. Background

The number of people playing sports in the Northern Beaches is growing. Council recognises the broad health and wellbeing benefits of being active and playing a sport. Through the implementation of our Sportsground Strategy in 2017, we are continuing to work towards increasing the capacity of our sporting facilities to meet this growing demand.

Preliminary research and consultation with stakeholders and community in 2016 found support for the installation of new lighting to make better use of existing sportsgrounds to enable more use. Passmore Reserve was suggested for consideration as a potentially suitable site for sports lighting (*Sportsground Needs Analysis Dec 2016*).

During consultation for the draft Sportsground Strategy in 2017, many comments were received in support of the option to install lights at Passmore Reserve as a way of increasing sportsground capacity and enhancing the viability of existing facilities.



## 3. Engagement objectives

Building on the strong community support for increasing capacity of existing playing fields evident during the Sportsground Strategy engagement, the aim of the Sportsground Lighting engagement for Passmore Reserve was to gauge the sentiment of the lighting proposal from the local residents, sporting clubs and the community more broadly and to understand and address any concerns regarding the project prior to the Development Assessment phase.

The engagement objectives of the project were to:

- build community and stakeholder awareness of project objectives and information and how to get involved
- target stakeholder participation to identify concerns, viewpoints and local knowledge
- provide accessible information via a variety of channels so community and stakeholders can participate in a meaningful way.

## 4. Engagement approach

Community engagement for the Sportsground Lighting – Passmore Reserve project was planned, implemented and reported in accordance with Council's <u>Community Engagement</u> <u>Matrix</u> (2017).

The Community and Stakeholder Engagement Plan established the approach to promote the project engagement, identify risk, map key stakeholders and identified easy and accessible ways to collect feedback that reflected broad community sentiment including levels of support, opportunities and issues.

Engagement was primarily conducted through the Have Your Say project page with supported by technical designs and Frequently Asked Questions. Behavioural economics principles guided the development of our online content to ensure clear and consistent information was provided to our community.

The engagement was promoted through email updates and newsletters to those who expressed an interest previously during engagement for the Sportsground Strategy or clicked 'follow' on the project page. A notification was posted to 4000 surrounding properties to ensure the residents were aware of the project.

Feedback was collected through an online submissions form on the Your Say project page, with email and written responses also accepted.

Due to social distancing restrictions in place during the consultation period, face-to-face drop-in sessions were not held. An additional activity was added to the engagement approach during implementation to provide an opportunity for community members to book a phone appointment with the Project Manager.

## 5. Findings

Overall, 89 percent of submissions received were in support of the proposed lighting installation at Passmore Oval.

The majority of comments received outlined the benefit of sporting lights to both the general community and sporting clubs including that lighting would allow additional sporting teams more hours in the day to train and to hold matches, particularly in winter.



Local residents and visitors believed they would obtain the benefits from being able to use the reserve for exercise or recreation in the evenings (e.g. after school or work) while the lights are on.

Ten percent of respondents were not in favour of the proposed lighting upgrade, outlining concerns about additional traffic congestion and parking issues on local streets and more noise (e.g. whistles, spectators shouting and other on-field noise).

There were also concerns raised regarding the light spill impacts on adjacent houses and wildlife, particularly birds, bats and nocturnal animals.

One percent of respondents were neutral to the proposal.

Key themes from the feedback have been identified and summarised below, along with a response to the commentary.

Theme	Summary of comments	Our response
Increased sporting capacity	Vast majority of comments agreed that there is currently a shortage of sportsfields in the area with sporting clubs having to compete for training hours on the fields and supported the installation of lights to address the shortfall.	The installation of lighting at the oval allows more teams to train or compete on the ovals, increasing the overall usage of the park. This helps meet the demand for more sportsfields identified in the Sportsground Strategy.
Community recreation benefits	Having the fields lit in the evening allows general recreation opportunities for other people in addition to sporting teams.	Council is committed to providing opportunities for healthy active lifestyles.
Safety	Many respondents said they would feel safer while exercising or waiting/collecting children after training if the area was illuminated at night.	Noted.
Noise impacts	There is a school and units adjacent to the reserve. There are concerns that there will be noise in the evenings due to players, whistles and supporters. Traffic and parking	There is currently limited parking on the local streets. Lack of street parking and traffic congestion will become worse if the reserve is available for longer under lighting.	The lighting upgrades are not anticipated to create additional pressure on parking or increase congestion in the area.
Light spill impacts	Concerns that light from the ovals will spill into neighbouring homes causing disturbance to residents. Also potential impact on nocturnal animals.	Potential light spill has been assessed and is compliant will all relevant Australian Standards for light spill and obtrusive light, including the National Light Spill Guidelines for Wildlife.



# Appendix A - Verbatim responses received online<sup>2</sup>

No.	Comment
1	Could you please confirm that the National Light Pollution Guidelines for Wildlife have been considered in this process? I see that assumptions have been made with regards to AS4282 but not of the guidelines. Given the proximity to wetlands and shorebirds, I imagine this is something that should be recognised. Also, can you provide a diagram, drawing of the fittings that are to be used?
2	There is a serious lack of safely lit sporting space on the northern beaches for community sporting organisations to conduct training and or games at night. As many people that volunteer for these organisations as coaches/trainers etc also work full time, the majority of them cannot be available to be present for their volunteer duties during daylight hours in the cooler months. The local Football Association already struggles to cater for the scheduling of games for nearly 19,000 participants. Another properly lit facility would assist in making this massive task more achievable as the sport continues to grow. Being part of a club that received upgraded lighting a few years ago, it is evident that the new lighting does not encroach on neighbouring properties or cause any issues for them.
3	Lights on the sports fields can only increase the participation of boys and girls in sports activities which can only be a good thing
4	I am the President of Wakehurst Football Club in Belrose. We were actively involved in the review process and we fully support the NBC Sportsgrounds Strategy. We were fortunate to have the vast majority of our local community support the installation of upgraded lighting at Lionel Watts and Hews Parade two years ago. If we want our sports people, from 5 to 55 years old, to be active, healthy and engaged members of our local communities then we need to give them adequate, good quality resources to enable them to play and to train for their chosen sport. The dire shortage of sportsgrounds and sportsgrounds with lighting in the Northern Beaches is a huge problem for many sports clubs. Thankfully the NBC is now addressing this shortfall as part of the NBC Sportsgrounds Strategy. We sincerely hope that the community supports the installation of new lighting at Passmore Reserve. Thank you.
5	Would be wonderful addition to the after hours sport facilities. Soccer never has enough pitches for after work training and this will provide a further 3 fields that can be used by clubs
6	This will greatly assist allocation of grounds for teams training during winter.
7 8	Appropriate lightning will benefits the long term success of our kids in several sports discipline. I am a current player/supporter of the St Augustines Football Club. The Club is currently only able to train at its home ground between 4pm and dark during the season due to the lack of lights at Passmore. The installation of these lights will not only be a benefit to the 650 registered players at our Club, but also the more than 19,000 registered football players on the Northern Beaches together with other sporting groups by freeing up sportsfields, increasing field usage, improving the overall quality of sportsfield and providing another amenity to be utilised by the broader community.
9	It will provide a place for all saints teams to play
10	To reduce the cost of this upgrade to rate payers will council be undertaking this upgrade under the NSW Governments Energy Savings Scheme, which is offering rebates for energy efficient LED lighting upgrades when accredited LED lights are installed to replace old inefficient lighting
11	Passmore also needs much better drainage
12	Critical for Football training and games to be played in the evening.

27	Hi, Passmore oval is long overdue for lighting. With the number of teams fighting for training
	grounds its only natural this oval should extend beyond daylight hours. The oval is also utilised by
	the surrounding residents with its playground and bike track.
	Lighting at Passmore is essential when you consider all the others that have been installed.
28	This is LONG overdue with the shortage of fields for the children. Having lights open up fields for a
	longer period of time for all to enjoy.
29	As an owner of a unit at 2 Campbell Pde Manly Vale which immediately adjoins the sports field
	I object to the proposal on the grounds the lighting will cause undue annoyance after sunset for
	those rooms including bedrooms that face the sporting field.

30	1. The council seems to be changing its mind about what is the best use for Passmore Reserve.
	Several years ago (10?) council wanted to build basketball courts and flood lights, along with
	hundreds of car parking spaces on the reserve. Now it obviously deems soccer, football and cricket
	the most appropriate uses.
	2. The public hearing for the previous flood light proposals had the Mackellar Girls school (now
	secondary college) Principal giving evidence that the combined flood lighting, the extra cars parked
	on the reserve and in adjacent streets, the activities themselves, the hours they would be
	training/playing and, most importantly, the noise they would be making (shouting, screaming,
	whistles blowing) would be extremely detrimental to the school's operations. In fact she said it
	would, and I quote, "spoil the professionalism of the school". This school has a very high ranking and
	reputation in the education community, and it was her opinion that the proposals would diminish its
	value and performance severely.
	3. We understand the noise and whistles will disturb significantly their nighttime activities of the
	school as they have a significant number of these happening frequently after normal school:
	performances, plays, public meetings on education matters, parent teacher interviews, and out of
	hours general school business. All of these require car parking at night, and as this is a wide
	catchment school, requires spaces at night on the border parking bays of the reserve.
	4. The noise from the Calabria Club further along Campbell Parade, has night time soccer under flood
	lighting and whistles often blowing till late. To add more whistles, and shouting directly opposite the
	school with this proposal seems quite ludicrous.
	5. Campbell Parade, Gordon St. and Quirk Rd are completely full of cars when the school has events.
	Combined with offstreet car parking for many residents in Campbell pde, the traffic movements and
	requirements are hectic, to the point of being potentially dangerous.
	6. Large service vehicles for the shops, services and outlets along the nearby Condamine shopping
	strip use Campbell pde and Quirk rd to do loops as there is limited turning manoeuvres off
	Condamine after delivery. These are often large trucks and semis and these roads are only
	residential streets, not distributor roads. Serious traffic issues!
	7 Many school buses, including extended buses use Quirk rd and Campbell parade, causing
	conflicting movement directions when special pickups are needed. We live opposite the school and
	just hold our breath at times as a lot of these events come together.
	8. The idea that more lights are needed, just for "training" purposes, over the broader area seems
	far fetched. The flood lights are very high (25 to 30 meters- more professional than amateur to me),
	and these are required for training?? The Miller and Nolan reserves have a total of 23 of these flood
	lights covering grounds on Condamine and Pittwater rd. This should be the limit for the area. Or
	create some more open space as the population is building.
	9. Considering all of these factors, it seems plain that the general area is very constrained by a
	number of factors (highlighted), and there exists a substantial number of flood lit fields in the area
	already.
	10. Summary: car parking, noise, high school- major reasons to say no.
31	This is outrageous! The high powered lights will shine directly into the bedrooms and loungerooms
	of residents opposite and adjoining Passmore Reserve. They will be on for up to six nights a week
	from dusk until as late as 9.30pm.
	The traffic will be horrific - it is already a nightmare as cars detour and go "the back way" to get to
	and from Condamine Street. There is not enough parking in Campbell Parade and neighbouring
	streets as it is, with visitors to the Calabria Club with its patrons and Footsall courts as well as

	The noise will be intrusive, excessive and unbearable for residents not only directly opposite
	Passmore Reserve but in neighbouring streets, noise pollution caused by whistles, cheering and

	Parking is limited due to all the apartment blocks and the residents from the blocks use the parking alongside the reserve in the evenings. Additional lighting will make it challenging for people to find parking in the evenings when returning home.
	The additional congestion created by sporting events is abominable , with the intersection of Campbell Parade and Condamine Street jammed due to the slow traffic lights at the best of times. Frankly I would be forced to support an alternate party for state government if you proceed. The sporting fields on the Freshwater side of the reserve have LESS residential housing surrounding the fields and are a viable alternative.
	The high density living in the apartments we live in means it is tough at the best of times to enjoy peace and quiet, and now you are throwing in an additional noise factor.

83	I am highly concerned by this proposal due to the foreseeable negative impact on the hundreds of
	residents in Campbell Parade. The concerns relate to:
	1. Very loud noise from whistles and players (screaming and yelling) until as late as 9.30pm of an
	evening, six days per week. In fact the noise would likely continue after 9.30pm as many people
	socialise after matches and make their way to vehicles. Aside from the many adults who resign to
	bed of an evening from 8.30pm onwards, there are many young children who live in Campbell Pde

I noticed that the open air basketball area on Nolans has been fenced off and cannot be used any more. I would support your plans for floodlights at Passmore if you also provided a basketball area on Nolans or Passmore.
107	It was extremely disappointing to learn that our local Council is, once again, considering installing light towers in Passmore Reserve, Manly Vale. The issue of installing lighting in the Reserve was first raised by Warringah Council (WC) in 2009 and conclusively dismissed in 2010. Even so, the Council tried to re-introduce the lighting in 2014, but like before, it did not proceed because of local resistance. To avoid spending more undue time writing why I believe the proposal should once again be dismissed in 2020 by the Northern Beaches Council, I have attached pertinent documents from 2010 and 2014 to make my case. At Passmore Reserve, however, I do not support the use of ratepayer funds to upgrade the lighting or provide other significant upgrades. My reason for this is very simple - Passmore Reserve is home field for teams from St Augustines College in Brookvale. St Augustines is a private school and, although their teams generally compete
	in local competitions, they do so as representatives of the school as part of the school's mandatory sporting program. At the time of writing there are more than 360 submissions to this proposal. Unfortunately I can't find a way of viewing, but my guess is that the St Augustines school community has been asked to show their support for this proposal. If St Augustines wishes for these facilities to be upgraded, then I believe that they should be contributing financially rather than asking Northern Beaches ratepayers to foot the bill.
162	Given the amount of sporting interest and community involvement by the youth of the area Soccer the provision of lights to Passmore Reserve will enable larger participation which is a benefit to the Northern Beaches Community as a whole. It fosters and deepens community connections.

### To whom it may concern

I write in relation to the proposed erection of new lighting in Passmore Reserve, Manly Vale.

As Principal of Northern Beaches Secondary College Mackellar Girls Campus, I welcome the opportunity to respond and make comment on the proposed lighting of Passmore Reserve.

Whatever happens at Passmore Reserve has a great impact on Mackellar Girls and is of great interest to the school, considering that the school directly faces the whole length of the Reserve. We are the Reserve's largest neighbour, and so are affected by any proposal of change to Passmore Reserve.

I have grave concerns and am vehemently opposed to the lighting proposal. My main concerns about the lighting are fourfold:

1. The school conducts many evening events in our School Hall on Campbell Pde throughout the year. Each usually involves whole year groups of 250 students, therefore up to 250 parent cars to be parked in the street, plus teachers' cars - we have no night parking available in the school grounds. Parents must rely on street parking for a school of 1 300 students. If night time team training or competitions are facilitated by lighting Passmore Reserve, then that will make it impossible for the school community for parking. The lighting will create even greater traffic congestion and noise, given that parking spaces are already at a premium. We already have difficulties with school events coinciding with sporting events at Passmore Reserve, and if this use of the reserve was extended to continue to a later time, this conflict will be severely exacerbated.

It is difficult to believe that anyone who has experienced the drastic traffic and parking congestion in Campbell Pde and its insufferable impact on local residents, the school and those in vehicles when Passmore Reserve is used for sport, would consider it appropriate to make it worse for longer periods, on each or most days of the week, by lighting the reserve at night.

2. There is also the reality that team sports' loud, incessant, overbearing noise, particularly from football with constant shouting and screaming from players, coaches and spectators, will greatly disturb our ceremonies, information events, musical performance nights and drama theatre nights. Our most important school events will be adversely affected by noise from Passmore Reserve.

On every Mondays and Wednesday, classes for Years 11 and 12 continue until 6.00 p.m. Again noise from Passmore Reserve would adversely affect the teaching and learning of our HSC students. In fact, this proposed night time use of the reserve could be quite disastrous for us.

3. There will always be times when the lighting is on, and no intended sporting activity is occurring, for various reasons. The lighting will then encourage antisocial gatherings and resultant antisocial behaviour, vandalism, noise and damage to the reserve and



	school. Graffiti and vandalism that occurs on the weekends and some evenings have increased over time, and I am concerned that providing lit, somewhat isolated gathering spots for adolescents at night, which are unsupervised, is paving the way for more destruction to the school and our neighbours. Even when sport is happening, the summer sheds and playground area in the north-west corner of Passmore Reserve will become a haven for congregating and loitering teenagers if the grounds are lit.
	4. Lighting would allow weekend sport on Passmore Reserve to commence at 8.00 am and continue for over 13 hours, until curfew, with more of the same five nights a week. The unbearable noise, traffic congestion, air pollution, hoon driving and tooting will create a diminution of lifestyle for residents. Desirability to live in the area will be downgraded considerably, which will adversely affect the school and its surrounds.
	In 2010 when lighting of Passmore Reserve was proposed, I expressed my concern about probable outcomes of having Passmore Reserve well lit at night. Mr Kevin Short, DA Officer at Warringah Council informed me that any activities that occurred in the park as a result of the lighting was totally irrelevant to the decision to erect the lighting. If there was a negative impact on Mackellar Girls or local residents or the park itself as a result of the lighting, that had nothing to do with any decision about the actual lighting. I must say, I found that perspective to be perplexing and confounding, and left me very concerned about fairness and transparency and listening to the community's voice in this process.
	This new Council must work to support and benefit the local residents and community. Care for the community is paramount, as is due process that is intelligent and honourable.
	I am a great supporter of sport. Mackellar Girls has been the Champion Sports School in all of Sydney North for the past two years. We have innumerable students who represent in State, National and International teams and as a school, we do all we can to foster a love of sport, physical activity and well-being. My intention is not to hinder participation in healthy activities. However the proposed night lighting of Passmore Reserve can only be to the detriment of Mackellar Girls, a school of over 1400 residents and the largest school on the Northern Beaches, which will be most adversely affected by night lighting. I point out the existence of Nolans Reserve, which has 6 playing fields as opposed to the much smaller Passmore Reserve. There is likely to be far less objection and much less impact on the neighbouring properties when these fields are night lit instead of Passmore Reserve.

	As resident of Campbell Parade area, I write in opposition to proposed Sportsground Lighting development at Passmore Reserve.
	Passmore Reserve is a well-used common community area, frequented by families on a regular basis for picnic, exercise, learning how to skate/bike and play. I view proposed changes may have a negative impact on the family community use and on local residents, not leaving many other reserve areas to enjoy/use as most other grounds are also already limited through use for sports.
	Please find my concerns outlined below. Concerns:



	<ul> <li>Increased Traffic Congestion &amp; Injury Risks – In addition to the business park commercial traffic and regular evening school activities. Campbell Parade has in the last two years experienced significant increases in evening traffic due to the following changes: <ul> <li>a. Calabria – increased traffic as patrons use Calabria since closure of North Manly bowling club.</li> <li>b. Calabria Futsal – increased traffic since upgrade of Calabria playing surfaces and floodlights from two futsal courts to four courts. Games are now every night of the week, 6PM till late.</li> <li>c. B-Line car park – since opening, the evening traffic utilising Campbell Parade to turn right onto Condamine street is significant, including traffic jams going back past Quirk Road.</li> </ul> </li> </ul>
	The has led to increased danger for Children/Families, around crossings and parking areas, which I fear will both continue if not get significantly worse should the council add more traffic load to the area. In particular, traffic related to proposed changes will move every 60 mins for games and training. For example, this is experienced today with the increase in Calabria futsal game traffic every 60 mins on weekday evenings.
2.	<ul> <li>Decline in Family Use – Passmore Reserve is predominantly used by families for picnics, walking/exercise, play and learning how to skate and ride. This is both during the week and weekend.</li> <li>The use of these fields for increased evening soccer will likely lead to a decline in the use of the Reserve by families and residents. This has been observed today whereby local soccer clubs are using Passmore Reserve for Pre-Season Training in evening daylight hours between Jan and Mar each year. During this time: <ul> <li>a. Parking – families/residents find it very difficult to find accessible parking</li> <li>b. Field Use – families/residents cannot use the grass fields</li> <li>c. Increased Litter and antisocial behaviour – lots of rubbish, including glass beer bottles, which is a concern for children and pets.</li> </ul> </li> </ul>
	These limitations in access and use, may turn families away from using Passmore Reserve.
3.	<b>Increased Difficulty for Resident Parking</b> – the proposed use of these fields in weekday evenings will have a negative impact on resident parking. Residents currently utilise the bottom half of Campbell parade for weekday and after-hours parking, opposite Mackellar Girls Campus. This will add to already heavy current use, as parking is regularly used through the week by the School, additional School evening functions, Calabria Club Sports Patrons, and families whom frequent Passmore Reserve.
4.	<b>Increased Noise on Weekdays</b> – there will be increased noise on weeknights with a high certainty that this will impact residents living in Campbell Parade, Gordon Street, Lovett St and surrounding areas. Currently on winter weekends, noise derived from sport, is loud. This noise is mainly associated with games including referees, however also includes traffic, players walking to/from cars, and drinking alcohol afterwards. However, today it is only two weekend days, and during the daytime hours. My concern is what this will be like every evening of the week till late.
5.	<b>Increased Anti-Social Behaviour</b> – added to the Noise concerns, the drinking of alcohol after games, regularly includes the use of foul language, or aggressive yelling. On some occasions after matches, I have confronted players urinating in the park and surrounding private property. This behaviour has continued to occur even though the public toilets are



<ul> <li>pointed out to players for their appropriate use. This behaviour is extremely off putting for families, and residents. This proposal increases the risk of this behaviour in our neighbourhood on weekday and weekend evenings.</li> <li>6. Field Overuse – Passmore reserve fields are in poor condition through winter after use for weekend soccer. If this extends to weeknights, the grounds will be of no use for anyone through the daytime, in-particular families. Even grounds with good drainage such as LN Graham Reserve and Keirle Park become trodden in winter. Passmore reserve will likely be worse given the drainage.</li> </ul>
7. Existing Field Utilisation – the existing fields at Nolan Reserve and Millers Reserve have sufficient lighting and are both under-utilised, particularly Nolan Reserve. Often, I have exercised on these parks during weeknights, whereby lights are on, and fields are empty This is particularly the case through Winter months. I understand the long-term sport ground planning initiatives, however given the proximity of these locations, would it not make sense to ensure both these fields are more utilised across sporting codes prior to considering or implementing any changes to Passmore Reserve?
am writing to you, to show my support for the implementation of lighting at Passmore Reserve. support the submission of lighting, as a member of the St Augustine's College Football Committee, as volunteer Club Registrar, as parent of two St Augustine's students and football blayers, and as a resident of Freshwater.
Through the implementation of lighting it would be desirable that Passmore Reserve Oval were designated as a Home Ground for St Augustine's Football Club.
<ul> <li>For St Augustine's College FC, it would provide the following immeasurable benefits:</li> <li>After 55 years as part of the MWFA, St Augustines College FC would finally have a dedicated home ground, like all other Football Clubs in the MWFA competition.</li> <li>ALL Saints teams could train at the one location, instead of sharing 3 fields (Millers, Grahams &amp; Nolans) with other clubs, and using a field with no lighting for the remaining of our training sessions (Passmore reserve).</li> <li>More efficient use of training resources, and consistency across training, as our technical director and other training staff could all dedicate their time to one location.</li> <li>Cost savings would be achieved, as transporting boys to 4 different training venues will be reduced to one venue.</li> <li>Greater interaction and visibility of our Senior club to our junior club members as training and games could follow on the same field. 	4	I am writing this submission as a long standing member of the football community, previous President of Manly Warringah Football Association and Life Member of Manly Warringah Football Association.
		The MWFA is the largest sporting body on the Northern Beaches with 18 clubs and more than 19,000 registered players. The MWFA is currently the biggest football (soccer) association in NSW. With a large female participation rate and catering for players from the age of U6 to Over 45. The Association is growing every year and this will continue with the hype that will be created with both the Olyroos and the Matildas representing Australia at the Tokyo Olympics.
		With the increase in numbers comes the need for fields, especially training fields.
		Currently with no floodlights on Passmore Reserve, teams in Winter can only train until dark which is usually 5pm. This means that from $5pm - 9.30pm$ three fields are unavailable for training. Currently, the teams that would use this area for night training are impacting on other fields thus overloading the amount of use on field in the vicinity, that are already at full capacity.
		Passmore Reserve has been in existence for a very long time (was part of the Manly Warringah District Park precinct). The units built adjacent to the existing field area were obviously aware that these were sporting fields and that the chances floodlighting would be installed was inevitable due to the growing population of the northern beaches area.
		The floodlights are now designed to eliminate spill to adjacent properties. As can be witnessed by the new floodlights installed at Dee Why Oval. Also, the lighting assessment has identified that the proposed lighting is in conformance with standards and that there are no areas of concern and deems the impact of the proposed lighting will have minimal impact on the surrounding residences.
		The positives of installing floodlighting at this location will greatly benefit not only the Club, that currently is allocated training over many fields, it will assist Council by reducing the wear & tear on other fields where these teams currently train.
		I and the many players would appreciate the Council giving the approval for these lights favourable consideration.
-	5	I am writing this submission on behalf of the Manly Warringah Football Association (MWFA), which controls and operates the football (soccer) activities for all registered players on the Northern Beaches.
		The MWFA is the largest sporting body on the Northern Beaches with 18 clubs and more than 19,000 registered players, of which 18,000 reside in the Northern Beaches Council LGA. This also makes us the biggest football (soccer) association in NSW, and hence Australia.
		We are also the most diverse sport, and have a female participation rate of 32% with players ranging in age from U6 (boys and girls) through to Over 45 (men) and over 40 (Women).
		The MWFA works closely with Northern Beaches Council both operationally and strategically to ensure our aligned strategic goals to allow residents of the Northern Beaches can stay healthy by participating in their desired sporting activities. In particular, we are working with the Northern Beaches Council to assist with the implementation of the Northern Beaches Council Sportsfield Strategy, which was released in 2017.
		Since the release of the Northern Beaches Council Sportsfield strategy, football (soccer) has grown by more than 1,600 players with growth in female football and also the "over-age"



competitions for players aged over 35 who play football to stay fit and mentally healthy into their older years.

We therefore need to increase capacity from our participation level in 2017, and to cater for future growth that creates a greater demand for outdoor space for Northern Beaches residents to play organised grassroots sport.

Following the release of the Northern Beaches Council Sportsfield Strategy, MWFA and Northern Beaches Council worked towards a Strategic Plan to ensure football's growth was considered in line with the Northern Beaches Council's stated strategy.

A copy of that strategy is attached to the submission and has been shared with Northern Beaches Council senior management, Mayor Michael Regan and the current CEO (Ray Brownlee) who have all been supporting and worked collaboratively to bring it to life.

A key focus of the strategy has been increasing the capacity of existing sports fields through lighting projects at grassroots sports fields. Some of these included upgrading existing lights but also included installing lights at sports fields that currently do not have lights.

The implementation of new lights is a "step change" project in terms of increasing the capacity of our existing fields.

As an example, when the Passmore Reserve lights are switched on, it will see a weekly increase of 67.5 training hours (assuming the traditional 5pm - 9.30pm timeslot is followed), from three fields used for 4.5 hours for 5 days.

Not only will this assist with training requirements but it will also allow the MWFA to schedule Monday night and Friday night matches, which is a strategy we are using to keep up with the demand for matches on the traditional weekend slots.

As it stands, Passmore Reserve is allocated to football (soccer) and one of our member clubs (St Augustines Football Club) uses the field for their junior players to train from 4pm until dark (about 5.15pm). It's senior players currently train and play at three different ovals, sharing with the member clubs who use these fields.

While the installation of lights will provide an opportunity to dramatically increase the usage of existing facilities it will also help spread training loads at four different field and benefit four different clubs.

This has greater benefits for Northern Beaches Council in terms of wear and tear at the other sportsfields where players currently train.

The successful instillation of lights at Passmore Reserve will directly benefit the following number of players/residents:

- St Augustines Football Club (600 players)
- Brookvale Football Club (1100 players)
- Seaforth Football Club (1500 players)
- Manly Allambie Football Club (750 players)

The flow on effect of re-allocating teams to Passmore Reserve after dark (with lights) will assist the spread of training across the following fields

- LM Graham Reserve
- Manly West Oval



Seaforth Oval

• David Thomas Reserve / Millers Reserve

I am available at any stage to go into further detail of the broader benefits of the instillation of the Passmore Reserve lighting project.

It was extremely disappointing to learn that our local Council is, once again, considering installing light towers in Passmore Reserve, Manly Vale. The issue of installing lighting in the Reserve was first raised by Warringah Council (WC) in 2009 and conclusively dismissed in 2010. Even so, the Council tried to re-introduce the lighting in 2014, but like before, it did not proceed because of local resistance.

To avoid spending more undue time writing why I believe the proposal should once again be dismissed in 2020 by the Northern Beaches Council, I have attached pertinent documents from 2010 and 2014 to make my case. Problems which existed back then have substantially increased with more apartments being built locally and increased activity, and lighting, from the Calabria Club, resulting in considerably more night time light, noise and street parking. Back in 2010 submissions from former Premier, Mike Baird, Mackellar Girls School Principal and

and Vice President of Strata Community Australia, and hundreds of local residents were considered by the WDAP on 24<sup>th</sup> April, 2010. Its unanimous vote was 4-0 against the lighting being installed. A majority of elected WC Councillors at the 25<sup>th</sup> May 2010 Council meeting voted to accept the WDAP's decision as final, and Council's Internal Ombudsman advised in writing: "... and that finalises the issue.".

Nevertheless, in 2014 WC tried again when Senior Recreational Planner, Parks, Reserves & Foreshores was given the task. Fortunately, she quickly became aware of what had previously occurred. She understood and respected the concerns of local residents by terminating further action.

### Re: Sportsfield Lighting – Passmore Reserve

Football NSW is the state governing body of football (soccer) in New South Wales. A memberbased organisation we currently have 31 associations throughout the state – 17 of which are in metropolitan Sydney and 14 which are in regional NSW. Recent Federal Government research, 'AusPlay' has put football as the largest team participation sport with some 1.3 million players nationally and over 600,000 players in NSW.

In October 2019 the National Sports Survey (AusPlay) results confirmed that football is the number one organised sport in Australia with more than 1.8 million participants, a 13% increase on the previous year. The AusPlay figures also highlight that football has almost twice as many participants as any other football code.

The Northern Beaches is a large football region in terms of participants in NSW, it therefore brings enormous benefits to the community. In fact, our recent analysis shows that the economic contribution of football is valued at over \$30 million in the state electorates of Davison, Manly, Pittwater and Wakehurst. Our full report on the Community Impact of Football in NSW can be found <u>here</u>.

Manly Warringah Football Association (MWFA) is 1 of our 31 local football associations across the state and are responsible for governance, competition management and the development of grassroots football in the Northern Beaches region. MWFA was the largest football association in Australia in 2019 with 18,559 registered participants. In addition to this 6.9% of the Northern Beaches participate in football, giving the council area the second highest participation rate in NSW.

Football is active in every corner of NSW, football transcends race, religion, and gender to create community connections. Football plays an unrivalled role in bringing together the different cultures in Australia. Most pleasingly, the growth of female football in recent years across the state has been remarkable, since 2015 women's participation in football has grown by 21%. Today we see female footballer's make up almost a quarter of all participants across the state.



Research evaluating the first year of the NSW Government's Active Kids program showed that almost 167,000 children redeemed the \$100 registration voucher for football almost three times the next ranked sport. On a participation basis we are growing at more than 5% per annum strengthening our position as the number one participation sport in the state and country, and the sport of choice for many families.

To address the future of the game Football NSW, Northern NSW Football and Capital Football have undertaken a comprehensive NSW/ACT facilities audit to determine the current state of play, develop a plan and provide decision-makers with a clear picture of where there is the greatest need.

Our recent state-wide facilities audit identified that:

- 28% of all playing fields in NSW do not have sports lighting
- 46% of all playing fields in NSW do not have sports lighting or have lighting below 50 lux
- Only 21% of all playing fields in NSW have 100 lux (or greater)
- In the Northern Beaches, 21 fields do not have lighting

The Audit revealed the challenges that Footballs growth is putting on our facilities. Pitches across NSW have an average of 183 players per pitch, the Northern Beaches Council area has an average of 1:256 which is above the state average and one of the highest players to pitch ratios in NSW.

The population of NSW is expected to increase to an estimated 9.9 million in the next 20 years with the population in the Northern Beaches expected to increase by 18%, which equates to over 46,000 residents. This projected population increase once again highlights the need to increase the capacity of sporting fields across the Northern Beaches.

Where absent, provision of playing field lighting is a proven method of increasing participation capacity. Sports lighting allows players of all ages and abilities to train safely at night and can provide the opportunity to play competition football providing flexibility in scheduling.

Football NSW fully supports Northern Beaches Council lighting upgrade at Passmore Reserve. The addition of lighting at Passmore reserve will allow this sporting field to be used after the hours of 5pm during the winter season where currently it isn't. New lighting at Passmore Reserve will add 20+ hours of potential usage during the week which is greatly needed for the local football community. Increasing the capacity of football fields in the Northern Beaches will certainly assist in reducing the strain on other football facilities across the LGA and provide much needed facilities for the community in the future.

Football requires additional football facilities generally across NSW as our recent facilities audit unveiled. We urge Northern Beaches Council to continue increasing the capacity of all sporting fields across the LGA as the population steadily grows over the next 20 years. Football NSW and the MWFA looks forward to the installation of floodlights at Passmore Reserve.

Football NSW congratulates Northern Beaches Council in implementing the recommendations that were presented in the Northern Beaches Sportsground Strategy, particularly increasing the capacity of sporting fields across the council area.

Re: **SPORTSGROUND LIGHTING** - Passmore Reserve Lighting – Submission – St Augustines Football Club ('the Club')

The Club is writing this submission **in support** of the proposal to install lighting at Passmore Reserve, Manly Vale in time for the 2021 winter sports season. It is felt, for the reasons outlined below that the lights will have a positive impact on not only our Club, but the broader Northern Beaches community.

### BACKGROUND

St Augustine's Football Club currently has 31 teams and over 650 registered players competing in the Manly Warringah Football Association ('MWFA') competitions. The Club has been a long standing member of that association and actively supports the ongoing development of football throughout the Northern Beaches, including sponsorship of the Manly United Football Club (NPL). The Club has traditionally been made up of school students enrolled at St Augustine's College, Brookvale and since the early 1990's school alumni who continue playing football post-graduation. The Club provides teams from Under 11 through to Premier League and currently has seven Under 18 teams competing in 2020. From Under 11 through to Under 18, the Club is one of the largest clubs in the MWFA.

It is noted that the Club has no official ground which can support it including things such as an official standalone home ground, canteen facilities and change rooms that can be operated by the Club to improve financial outcomes and allow investment in training aids to support the Club. The Club currently relies on the goodwill of numerous local families to ensure that the Club continues to run successfully.

### 2020 SEASON

The Club is currently the only MWFA Club that has a side competing in Under 12 to Under 18 Division 1 together with both Premier League and Amateur League 1. The Club has further grown this year by 2 junior sides and 2 additional senior sides however has not been provided with any additional fields with which to provide adequate facilities for these teams.

The Club has invested significantly in providing qualified coaches to teams that compete in the MWFA competition (above and beyond that provided by other Clubs), however cannot adequately provide training sessions due to the lack of practical grounds available to it.

### PLAYING FIELDS

The Club currently has access to limited training and playing facilities which are shared with other Clubs locally. The Club during the winter sports season uses the following fields:

Grahams Reserve – Monday and Wednesday 4pm to 10pm (including lights). Shared with Brookvale FC

Passmore Reserve – Monday to Friday 4pm to dark



Millers Reserve – unofficial ad hoc agreement for usage around Manly Allambie Football Club requirements

As noted above, the Club is required to have unofficial agreements with other clubs to ensure that it has enough capacity for team trainings and games.

### PASSMORE RESERVE

Currently with no floodlights on Passmore Reserve, teams in Winter can only train until dark which is usually 5pm. This means that from 5pm – 9.30pm three fields are unavailable for training which would normally be assigned to our Club and alleviate the need for other arrangements to be made to access fields.

It is hoped that with the installation of lights, further works can be done in the future to improve the drainage of the fields, relocate the cricket pitches to improve functionality, resurface and regrade the field, improve the change rooms and install canteen facilities at the ground.

### IMPACT OF NO LIGHTING ON GROUND NETWORK

Currently, the teams that would use this area for night training are impacting on other fields thus overloading the amount of use on fields in the vicinity, that are already at full capacity. This has the dual effect of increasing wear and tear on already strained field resources and also limiting the ability of Clubs to provide Football to its registered players to the standard that is now expected.

### IMPACT ON LOCAL AREA

Passmore Reserve has a long existence that pre-dates the building of adjacent unit blocks (part of the Manly Warringah District Park precinct). The units built adjacent to the existing field area were obviously aware that these were sporting fields and that the chances floodlighting would be installed was inevitable due to the growing population of the northern beaches area.

The floodlights are now designed to eliminate spill to adjacent properties. As can be witnessed by the new floodlights installed at Dee Why Oval. The Club notes that the lighting assessment for Passmore has identified that the proposed lighting is in conformance with standards and that there are no areas of concern. That assessment further states that the proposed lighting will have minimal impact on the surrounding residences.

The Club notes that Passmore Reserve is bordered by two distinct facilities, District Park Complex (across the creek) and the Manly Vale Calabria Club. These facilities are interesting in that both have lighting available which is used until 10:00pm daily with lighting installed prior to the development of the current brand of lights used on Northern Beaches sports fields which eliminate light spill. In the case of the Calabria Club, these lights are used for a commercial purpose directly adjacent to Passmore.

The installation of lighting at Passmore Reserve would not adversely impact the local community to any degree greater than the lighting currently operated at these 2 sites.



### CONCLUSIONS

The positives of installing floodlighting at this location will greatly benefit not only the Club, that currently is allocated training over many fields, it will assist Council by reducing the wear & tear on other fields where these teams currently train and provide a proper home for our Club to continue its growth and support Football on the Northern Beaches

The Club, its committee, registered players, supporters, community (in excess of 3,000 residents) **support the proposed installation of lighting at Passmore Reserve**. The installation will further provide benefits to the over 20,000 registered players and coaches of the wider MWFA community.
