## **MOD2020/0175 – Objection to Extending Trial Period by 3 Months**

DA2019/0123 allows for this 'on-trial' food market to only operate for **42** days in 12 months.

While the Market Operator's Environmental Impact Statement (page 1) indicates that "the market went into hibernation in response to the current coronavirus pandemic on Sunday 29 March and reopened on Sunday 3 May" – a total of **4** x Sundays in April.

It is worth noting that the Market Operator 'chose to close' this food market and was not required or instructed by Northern Beaches Council or the NSW Government to do so.


As the following Table reveals, **3** of **5** available Sundays in August will get the market to **42**.

**Important Note:** All of these Table details can be confirmed by Mr Damian Ham, Manager, Open Space & Recreation Planning who and/or members of his Team are in week-by-week contact with all market operators within the Northern Beaches Council area.

Hence, I strongly object to the suggestion (page 162) and recommendation D (page 171) to extend the trial period by 3 months to account for the 4 Sundays in April 2020 when the Market Operator himself chose to close, as his ability to trade for 42 x Approved Sundays is unaffected!
