Part 2 (Terms)

Terms of easement numbered one in the plan creating easements.

- 1. Full and free right for the owner of the benefitted lot and every person who is at any time entitled to an estate or interest in the benefitted lot or any part thereof and every person authorised by such person to:
- (a) by any reasonable means pass across the lot burdened with or without animals or vehicles or both, but only within the site of the easement, to get to or from the lot benefitted, and
- (b) do anything reasonably necessary for that purpose, including:
 - entering the lot burdened, but only within the site of the easement, and
 - taking anything on to the lot burdened, but only within the site of the easement, and
 - carrying out work within the site of the easement, such as constructing, placing, repairing or maintaining trafficable surfaces, driveways or structures.
- 2. In exercising those powers, the owner of the lot benefitted and every person who is at any time entitled to an estate or interest in the benefitted lot or any part thereof and every person authorised by such person must:
- (a) ensure all work is done properly, and
- (b) cause as little inconvenience as is practicable to the owner and any occupier of the lot burdened, and
- (c) cause as little damage as is practicable to the lot burdened and any improvements on it, and
- (d) restore the lot burdened as nearly as is practicable to its former conditions, and
- (e) make good any collateral damage.
- 3. The owner of the lot burdened may install a security gate provided that the owner of the lot benefitted is provided with a security key.
