Amended plans for DA2019/1260 are now seeking approval to remove 3 large established native banksias located on the COUNCIL RESERVE in front of 23 and 21 North Avalon Road,

in order to construct a 1.5m footpath from the front of the site down to Tasman Road. (see photos below) These banksias provide food and shelter to many native birds.

This is a new inclusion in the plans and should NOT be granted approval.

The developer is seeking approval to remove the large established Swamp Mahogany Gum located on the COUNCIL RESERVE directly out the front of this proposed site (see photo)

3 other Swamp Mahogany Gum trees located at the front and rear of the site are also proposed to be removed (See photos)

The huge Spotted Gum located just inside the front fence of 29 North Avalon Road is also proposed to be CUT DOWN!!.(see photo)

This destruction of our beautiful trees MUST be STOPPED!!!

Listed below is the wide variety of NATIVE trees located on the overall site that are proposed to be REMOVED on the "AMENDED" Landscape Plan.

* 4 SWAMP MAHOGANY GUM TREES

* 1 SPOTTED GUM TREE

* 9 CASUARINA TREES- SHE OAKS

* 3 PAPERBARK TREES

* 3 SOUTHERN MAHOGANY GUM TREES

* 1 QUEENSLAND BRUSHBOX

* 1 TALLOWOOD TREE

* 1 LILLI PILLI

* 1 CHEESE TREE

* 1 BOTTLEBOX

* 1 BANGALOW PALM

These plants not only contribute to the “GREENING” of our area, but provide habitat for a wide variety of our native birds and animals.

Along with these native trees, a wide variety of exotic plants are also proposed to be cut down.

Although not native, these plants still contribute to the “GREENING” of these residential blocks, and provide habitat for native birds and animals.

* 1 PHOENIX PALM that was to be RETAINED on the plan. This has already been cut down.

* 1 MACADAMIA TREE

* 1 CLUMP OF KENTIA PALMS

* 4 CREPE MYRTLES

* 1 AFRICAN OLIVE

* 2 MULBERRY TREES

* The RELOCATION of a CABBAGE PALM

Numerous established “exempt” trees have already been cut down!
