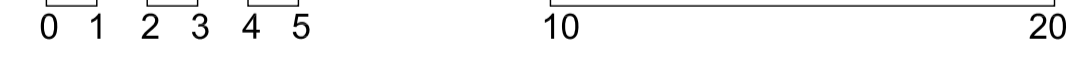


BASEMENT LEVEL B3 FLOOR PLAN

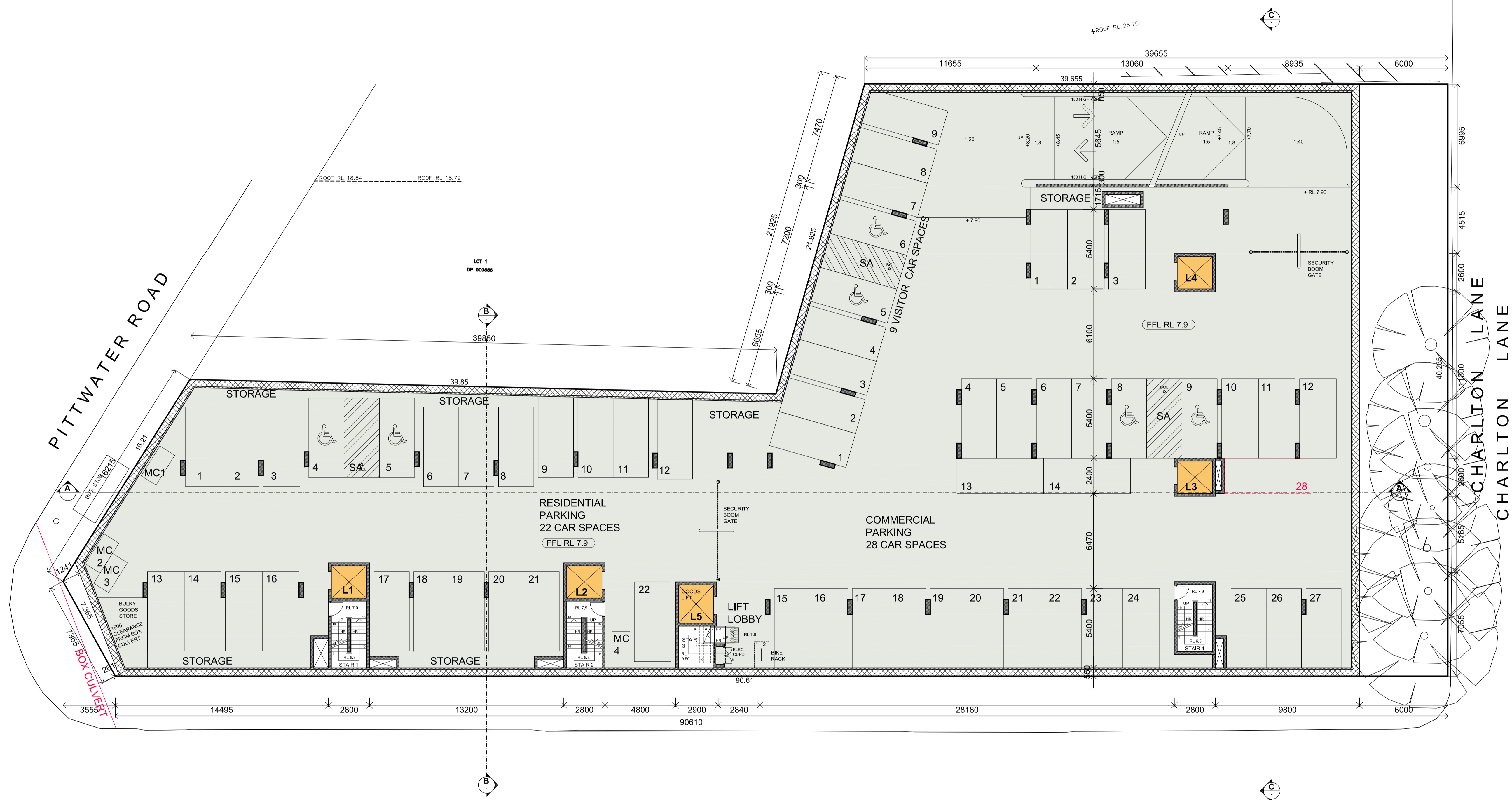

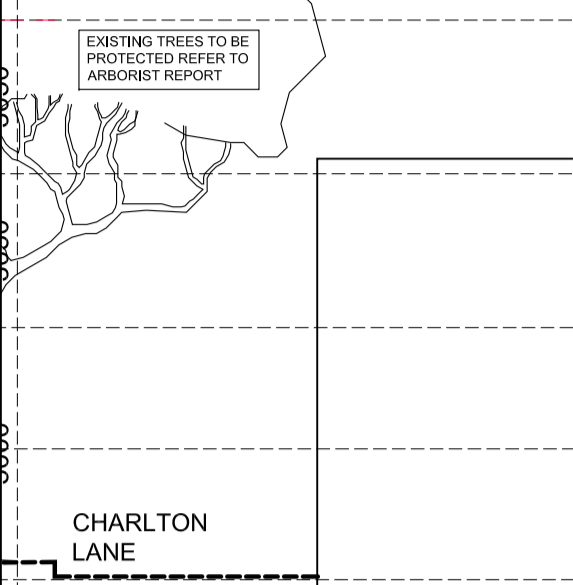

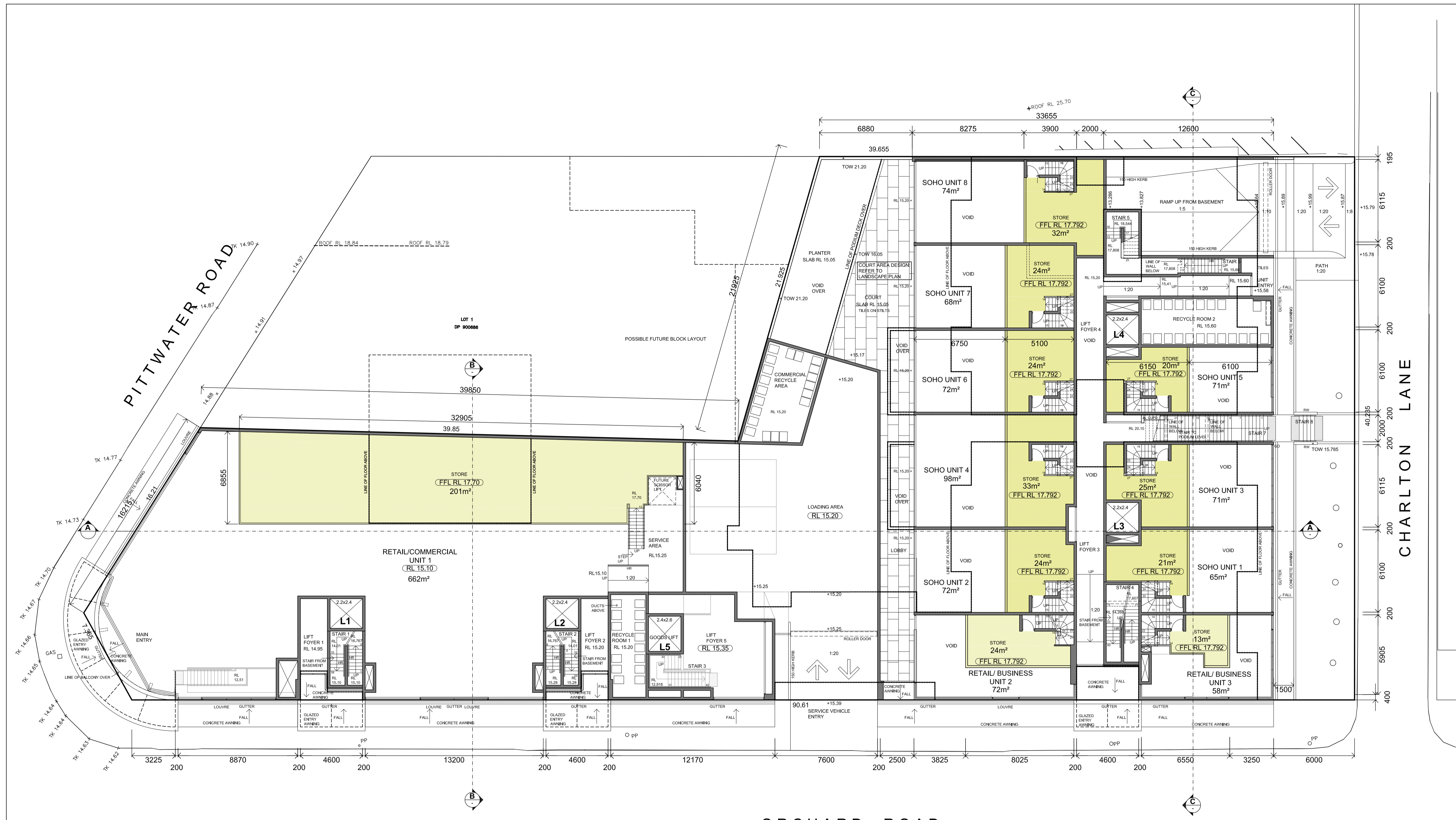
