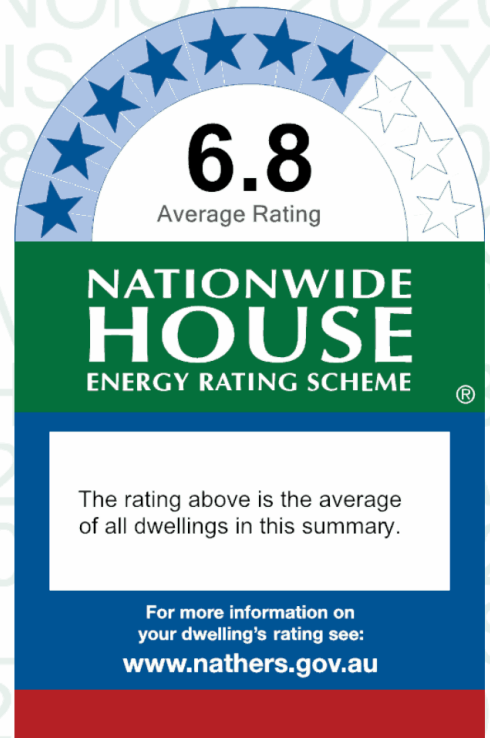

National Construction Code (NCC) requirements

Requirements additional to the NatHERS assessment that must also be satisfied include, but are not limited to: insulation installation methods, thermal breaks, building sealing, water heating and pumping, and artificial lighting requirements. Explanatory Notes

About this report

This summary rating is the average rating of all NCC Class 2 dwellings in a development.
