Consideration of Application		
The Application is for the construction of a four storey health services facility comprising a gross floor area of 2,099m ² . The proposed development intends to accommodate a cancer treatment centre with consulting, imaging and pathology services. Two beds are proposed for anaesthetic procedures and recovery. The facility proposes to provide jobs for 52 staff and accommodate a maximum of 98 patients.		



Matters for consideration are discussed below.

Land Use

No issues are raised with the proposed land use. The proposal is supported as it will contribute towards additional jobs for the precinct. In addition, the uses will support the new Northern Beaches Hospital, the NSW Government's vision for a health and education precinct, and encourage employment growth in the area.

Objectives of the Zone

An objective of the B7 zone is 'to create business park employment environments of high visual quality that relate favourably in architecture and landscape treatment to neighbouring land uses and to the natural environment'. Consideration of the lift overrun should be made as an aspect of the overall building design, particularly when the subject site is viewed from Warringah Road.

In conclusion, the application is supported as it will contribute towards additional jobs for the precinct. In addition, the uses will support the new Northern Beaches Hospital, the Greater Sydney Commission's vision for a health and education precinct, and encourage employment growth in the area. However, a matter for development assessment to consider is whether there could be an improvement in the building design relating to the lift overrun and its presentation to the Warringah Road streetscape.
