
## 1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of a proposal to create a new basketball facility at Winnererremy Bay, Mona Vale.

The feedback collected during consultation revealed a considerable level of support for the proposed recreation space at Winnererremy Bay, Mona Vale with comments citing the anticipated benefits for locals. There were many requests for a full court or more courts in this location to support local demand.

Feedback also suggested Council should consider installing a drinking fountain, additional trees for shade, line markings for pickleball and multi-purpose courts for netball.

There was a moderate number of respondents who were not supportive of the proposal citing loss of green space, loss of parking and noise pollution in the area. Some respondents questioned the need for the ride around track and raised safety concerns with the current design.





## 2. Background

We are looking to create a new recreation space at Winnererremy Bay, Mona Vale for the community to enjoy. Our primary goal is for neighbourhoods to inspire social interaction, inclusion and support health and wellbeing. One of the actions from Let's Play! (our Open Space and Outdoor Recreation Strategy), is to look at improvements for Mona Vale, including the potential for a new basketball hard court facility.

# 3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities
- provide accessible information so community and stakeholders can participate in a meaningful way
- provide balanced and objective information to assist in understanding the problem, alternatives and/or solutions
- identify community and stakeholder concerns, local knowledge, and values.



## 4. Engagement approach

Community and stakeholder engagement for the Let's Play! Hard Court - Winnererremy Bay, Mona Vale was conducted between 2 February and 1 March 2024, and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's <u>Community Engagement Strategy</u> (2022).

A project page was established on our Have Your Say platform with information provided in an accessible and easy to read format.

The project was promoted through our regular email newsletter subscribers, youth newsletter, site signage and letterbox drop to neighbouring residents.

An onsite pop-up event was also carried out where our project team was at the proposed location to gather feedback and to maximise community involvement.

Feedback was captured through an online comment form embedded onto the Have Your Say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

Email and written comments were also invited and have been included in the report.

#### 4.1. Reaching diverse audiences

A thorough stakeholder mapping exercise was completed to identify and understand the needs of the whole community.

It was determined for this project that it was particularly important to hear from youth groups. Information was distributed to this demographic via Council's KALOF newsletter, targeted at young people aged 12-24. We also contacted Pittwater High School requesting they include the project in their school's e-newsletter.

We encouraged community participation and sought feedback on the project through several other activities to attract all the potentially affected people including:

- information was provided on Council's Have Your Say project page.
- a community pop-up event with the project team held on a Saturday morning.
- letterbox drops to neighbouring residents.
- displays of onsite notification posters
- Mayor's weekly e-news.

### 5. Findings

The feedback collected from the consultation provided some key takeaways from the community. Essentially half of respondents, 49 percent, were in support of the proposal and thought it provided highly sought after infrastructure to the Mona Vale area. This positive feedback was represented by all ages.



Some respondents cited they travel from Mona Vale to Avalon and Warriewood locations to use the hard courts and would like to see this local project go ahead.

More than 40 respondents said they would also like to see pickle ball line markings on the court or in the proposed handball space, with the remaining in full support to make the hard courts more multi-use with the addition of a netball hoop.

22 percent of respondents who were in favour of the recreation space said they would like to also see the two half courts be consolidated into one full court or even have two full courts.

A small number of supporters were in favour of the proposal but asked for the location of the recreation space be reviewed.

Those in support of the proposal also requested more shade trees, a bike rack, and a bubbler nearby.

While most community members support the new recreation space, 29 percent are not in favour. Concerns were raised by nearby residents around the impact to parking and noise disturbances. Taking away the open green space was also another factor raised by the community.

During the consultation/exhibition, Council received a number of questions either through direct contact or within feedback received.

Question raised in feedback	Council's answer
Why not put the court at Kitchener Park?	Space at Kitchener Park is at capacity. With cricket in the summer and soccer in the winter months and the tennis courts all year round, this doesn't allow for a safe space for a hard court to be constructed in this park without reducing the size of the popular skate park
Can we have additional courts?	The size has been determined to ensure the open space is not heavily impacted while utilising existing infrastructure to help soften the look.
Will pickleball be included and can it be used by locals?	Pickleball line markings will be considered in the final design. If pickleball lines are installed this will be open for all to use.
Is this the best location in the park?	Council believes this is the best location within the park. It is set a distance away from local residences as well as the foreshore and picnic facilities, utilises existing infrastructure to minimise the aesthetic impact and not in an area where services will be affected.



Question raised in feedback	Council's answer
	The areas between the carpark and bike path were considered, however this area has a large amount of stormwater infrastructure as well as acting as a detention area for overland storm water from the park.
	This location will also not take up a large portion of the open grassed area.
Can this be closer to the playground?	This was considered but was found to take up too much open space and underground services would be affected.
Can the courts be multi- use	Consideration on including additional functionality i.e., netball and pickleball will be made following community feedback.
Where is the water station/bubbler	Water stations will be considered in the final detailed design
Can the courts be extended to include Futsal?	Council is not considering extending the courts to include futsal line markings.
Can outdoor gym equipment be installed?	Council will consider this in a future Delivery Plan.
Why can't Council share nearby school facilities (and parking) instead of spending this money?	Utilising the school facilities still comes at a cost to set up the grounds for public use, including maintenance fees. Access to use this type of facility would be limited as use while school is open, reducing the intended scope for the public.
Why don't we have an Aquatic Centre up this end of the peninsula?	This suggestion is not within the scope of this project
I'm not sure that two is enough. Any wiggle room on the budget?	Two is considered to provide suitable capacity whilst not taking up too much green space.
Would this be able to be used by local schools and other local community groups on a casual basis?	Yes, it will be available for any casual use but will not be available for bookings
Do we need the bike path around the courts?	No, but it provides an additional riding area with small corners for those learning to ride. The Boondah courts have a similar path with no issues.

1	<ol> <li>Parking, there is not enough parking for the park now let alone with more infrastructure to be installed</li> <li>Public transport there is no public transport to travel patrons to the park, the closest bus stop is on Pittwater Road or Barrenjoey Road</li> <li>An Open Plan Park, the park was initially designed and opened by Patricia Giles for the use of an open plan park which we as rate payers agreed to for families and children to enjoy</li> <li>School Excursions, the park is utilised by school children for sporting activities on and around the same area proposed for the Courts, and this will be taken away is the courts are installed</li> <li>Other Options for Council, a better option would be Kitchener Park as there is already available parking, public transport and other sporting facilities in this area</li> <li>Town Planners, Winnererremy Bay as previously stated above was designed and approved by local rate payers to be an open plan park for the use of families and schools in the local area, this was never to be changed as the use of the park is just perfect as it is now please do not change this beautiful area and please do not install the Courts.</li> <li>Winneremmery Bay Park is used for festivals and is perfect as it is.</li> </ol>
2	Absolutely not. Pittwater Council did a very good job re-developing this park several years ago and it has been reasonably well maintained over time, It is well used by locals and others enjoying the ambiance of the area. Parking is already limited creating an overflow onto local streets during weekends and special events, A Basketball hard court is not in keeping with the area or it's users and will encourage night time use for young folk with no where else to go and all the accompanying noise and problems that creates. Why ruin something that works very well and is already widely enjoyed. Why not put this Court at Kitchener Park which is in keeping with the other amenities. I would like to know what happened to the previous proposal to fix and widen the walkway from Roland Park to Gibson Marina. I do not know one person that objected to this proposal. This walkway is badly in need of repair, requiring Walkers to carefully maneuver in parts unless an accident prevails.
3	As a regular Visitor to the park, we do not want to see the open area eliminated especially with a hard court. The area will become too commercial with the lovely walking track overrun with speeding bicycles as has happened around Narrabeen Lakes, furthermore the limited parking area, already overloaded with cars belonging to students at Pittwater High School would be compromised for use by locals to the area and the beautiful dog walking area would be ruined. As a suggestion, why not offer to build the basketball courts within Pittwater High School grounds which would make the school a Centre of excellence for basketball.
4	As a resident in Maybanke ct Mona Vale the noise of a bouncing ball will be heard by all the residents next to the park as it echo's across the park.It will attract people at nights even with no lights. I understand people who don't live nearby will want it since it doesn't affect were they live. Village Park or Kitchener park would be a better alternative.
5	Build in Kitchener park instead so sporting facilities are all together.

6	Dear Let's Play I would suggest the courts be relocated to where the Skate Board area is at Kitchener Park at Mona Vale. The Winneremmy Bay area is passive recreation area. Sporting facilities would be better kept in designated areas as Kitchener Park currently stands.
7	Don't ruin the park, put it near the skate park or tennis courts
8	I believe it would detract from the look of the natural green space grassed area. It will become noisy with bouncing basket balls on the hard surface & against the hoop backboards. It will attract an undesirable youth element & we already have enough social, illegal issues in the Mona Vale area.
9	I cannot comprehend why the tranquility of Winnererremy Bay should be vandalised in this way. Please Council leave it alone! It is a haven of peace to all who use it. Don't commercialise it further!!
10	I do not support this due to the increased noise this will cause for local residents. The noise carries up the hill of Mona St. Noise is already disruptive at night when there are people at the park yelling and celebrating loudly. This would intensify as there will be people at the courts at all hours and it is the rebounding noise of the ball that will carry through to residents. This facility would be better to be built near the skate board park as the youth enjoy this area and it is situated well away from residential homes. Even without lighting the use of the court early morning and during daylight savings will mean that noise levels will be considerable for residents.
11	I do not wish to place anymore buildings of any kind on our green spaces which I view as very precious. Leave our green spaces alone so that we have spaces to walk and just enjoy nature.
12	I feel like it is not an appropriate space for basketball courts. It is such a beautiful open area with so much grass for so many to enjoy. I feel that the basketball courts would ruin the aesthetics of the area and get rid of more natural beauty
13	I oppose the proposed development of Hard Court basketball courts and seating in the Winnererremy Bay parkland. This greenspace was designed as a passive recreation area for families to enjoy the proximity to Pittwater. It attracts families from all over the Northern Beaches and wider Sydney area to relax, picnic and enjoy a large parkland with bicycle and walking paths for younger children. The draft proposal will attract youths, likely without parental supervision to participate in a loud activity. This will spoil the ambience of this greenspace. I believe, that if council feels that more activities should be offered for our youth, these basketball courts should be built in Kitchener park which is a sporting hub that caters for youth with an existing skateboard park and half pipe. It makes much greater sense to place the courts there, where the noise and activity is away from residential areas and younger families enjoying a peaceful day on the edge of Pittwater,
14	II do not support this plan because Winnererremy Park is a passive park area enjoyed because of the quiet open spaces particularly for picnics, dog walking & childrens activities. I think the hard courts would be best placed with other sporting venues because they will obviously attract more cars & the parking is limited at Winnererremy Park. There is already spill over street parking because of the school next door. As hard courts naturally attract young people & their audience, I think courts such as these, which will be used into the evening in daylight hours, will be too noisy adjacent to this quiet, passive activity area.

15	It is an open air park, that has little juvenile delinquency at the moment, it is our belief that with the introduction of these half courts, the problems will increase in bad behaviour and extra litter, as observed there are no rubbish bins up that end of the court and could become a trash pile. Although I believe it would be a great idea for teenagers, I don't think that is the correct area, also thinking of the neighbours who would have to put up with the noise generated after hours. Instead why couldn't council put in adult gym equipment such as they have next to narrabeen lakes please.
16	It prefer to have more trees planted instead of concretewe use this park everyday and it is lovely to have a big green area where we can sit and enjoy a picnic as well as playing.
17	It will spoil a currently wonderful place and reduce green space. A Breyer use of councils money would be to upgrade the fields and drainage at Kitchener Park, or to create some al fresco dining options around the Village Park - similar to what Lane Cove Council has done in the Canopy. I'd like to understand where this idea came from I can't imagine the local community would want this.
18	Looks like a waste of money, the courts are only one-ended, not full basketball courts.
19	Netball is now the third most popular team participation sport in Australia after overtaking Aussie Rules, according to new Ausplay data. Netball is now more popular than Australian Rules Football when it comes to grassroots team participation. A plan that does not include a multipurpose courts- that allow for netball and basketball discriminates against women and girls. Please do better
20	Not enough green space like this in the area. This might be better suited to kitchener park or elsewhere. This is not a sports field, kitchener park is a sports field. The environmental ambience does not support this development in this location.
21	Parking area would not be sufficient for visitors using courts and park. Noise also would be an issue as it is a peaceful and relaxing area to enjoy.
22	Parking is hard enough now when I have been to Winnererremy Bay for a picnic & walk. I would like to see it stay as a great picnic area.
23	Parking minimal. The park is natural, green & inviting. We own directly next door to the new Bayside build. Parking & traffic is already a problem. Keep your courts to already established main road areas.
24	Parking, there is not enough parking now for families who attend Winnererremy Bay for the beautiful large park and bike track There is no PublicTransport close to this Park, the closest Bus stop is on Pittwater Road or Barrenjoey Road The Winnererremy Bay Park was initially designed for a lovely grassed area surrounded by a lovely walking and riding track which utiles by hundreds of people and the Courts will be taking this away from the Park. Winnererremy Bay park was initially designed by Patricia Giles as a open large grassed area for Festivals, Families and local Schools as well as other outdoor enjoyment as a park with large grasslands leading to beautiful Pittwater, there was never any mention of changing this lovely park to a sports facility area. A better alternative would be to install the Courts in Kitchener Park at Mona Vale, there is ample parking facilities and large parks and skate parks and the Public Transport is at the entrance to Kitchener Park. 29	The area doesn't need more concrete. There are other areas more suitable, like the skate park. It is already enjoyed by the community as is. Green space is all that is needed.
30	The erection of concrete facilities of the cost of ever reducing green space must be stopped
31	The green space proposed is used by many, including us, regularly for playing. We do not want our green space turned into basket ball courts. We enjoy the space in a multitude of ways and would not use it if it was concrete. We enjoy getting out onto the grass and enjoying the nature. There are other more appropriate spots in mona vale for basket ball courts - don't ruin our green areas by covering them in concrete. This won't help our health and well-being.

Surely there is a better option of using space at Pittwater High School to develop something that will benefit the school and young people who might be interested. 33	The space is an open safe space for everyone. No need to cement over grassed open space. If more basketball courts are needed let them use the ones at Pittwater High School,
34	The spot is perfect as is and enjoyed by families with young children. I believe if the courts go in it will spoil what we already have there peace and tranquility. Leave it alone !!!
35	There is a cost of living crisis. Save the money, reduce our rates instead. Also, council does not even keep up with maintenance as it is, don't had more to maintenance to the list.
36	There is no need for these basketball courts. They will cause more problems than they solve. Why cannot council share nearby school facilities (and parking) instead of spending this money? Money is needed instead for upgrading the walkway from Mona vale to church point which has caused at least 2 broken bones that I know of. After any rain it is filled with deep puddles and walkers risk balancing on the wall beside Pittwater or getting ticks in the bushes. The wooden part of the walkway collapsed last Christmas throwing the public into the water. It is still unrepaired. The gum tree branch that fell on Pittwater road a year ago did damage to the metal and wooden safety rails yet they are still y repaired. There is a palm tree beside quays marina that has never been trimmed and drops large fronds on the road and pathway. Upgrade what you have. Protect the residents before spending money in shiny new things.

Presumably participants bring their own nets etc I dont know whether this (and perhaps other) alternative public uses would be facilitated by any design changes (perhaps sockets in teh ground for nets used in various games, and line markings in differing colours ), but suggest it be looked into, so the courts facilitate as wide a range of uses as practice.</li> <li>2) At Avalon there is also a practice netball hoop. This and the court hoops are often used for netball/basketball practice or fun, by youths and often by parents with children . However the metal faced rebound surfaces (? the vertical flat surface above and behind the hoops) are quite noisy when impacted by balls, and the slender support poles flex, so the structures tends to reverberate after being struck. 	We are strongly opposed to the proposal to build hard surface basketball courts at Winnererremy Bay. This is one of the very few quiet foreshore reserves where residents can go for peaceful quiet reflection. This is particularly important for anyone who is elderly, stressed or suffering any form of physical or mental distress or illness, to assist in improving mental health, recuperation and/or rehabilitation. This is also essential for the well-being of anyone with neuro diversity or sensitivity. Most other parks or beachfront areas are incredibly noisy and busy or have been provided for off leash dogs. They are not the peaceful environment that was always the intention on the establishment of Winnererremy Bay as part of the Metropolitan Foreshore Network. Winnererremy Bay is one of the very few public spaces that provides accessible access to the shores of Pittwater. The establishment of hard surface basketball facilities would destroy this peaceful environment.
	Far more appropriate areas in Mona Vale for such facilities would be Kitchener Park, to complement existing facilities for teenagers where the skate park complex is situated or Apex Park, given the beach front is also extensively used by teenagers. Both of these areas are well utilised and much more accessible for teenagers utilising public transport.
	Please do not destroy this peaceful waterfront environment! It is a rare gem for the Northern Beaches and for the foreshores of Pittwater.
