Letter of Support – Adequate Sanitary Facilities 1/9-15 Central Avenue Manly

Private Certifiers Australia have undertaken an assessment for compliance with the Building Code of Australia / National Construction Code 2022, Volume 1 in relation to the provision of adequate Sanitary Facilities at 9-15 Central Avenue, Manly.

Based on the indicative plan provided by the applicant in relation to their proposed bathroom/sanitary facilities layout, and review against NCC 2022 Volume 1, we are of the view that adequate facilities have been proposed to suitably accommodate 400 occupants.

Further detail in relation to the NCC Requirements and assessment undertaken in relation to this matter are provided below.

NCC Performance Requirements F4P1 to F4P6 are satisfied by complying with Clauses F4D2 to F4D12 which forms the basis of this assessment.

BCA Classification: Class 6 (Restaurants, Cafes etc.) The proposed sanitary facilities are as follows:

NCC F4D4(5) states that [Employees and the public may share the same facilities in a Class 6 provided the number of facilities provided is not less than the total number of facilities required for employees plus those required for the public.]

Given the number of facilities to be provided for each sex in addition to the Accessible Unisex Sanitary Compartment presented in the table above, it is clearly demonstrated that the 'Design Occupancy' on that basis would be 400 persons including patrons & employees in accordance with NCC 2022, NSW Table F4D4d: Sanitary facilities in Class 6 buildings – restaurants, cafes, bars, small live music or arts venues (excerpt below).

- (1) Sanitary facilities need not be provided for patrons if the total number of persons accommodated in the building is not more than 20.
- (2) Sanitary facilities need not be provided for patrons in a small live music or arts venue that is not a licensed premises.

NCC F4D2 allows for an accessible unisex sanitary compartment required for people with a disability be used to count as (1) for each sex and does not negate the need for ambulant facilities.

With the provision of an Accessible Unisex Sanitary Compartment within the 'Bank' counting as (1) required facility for each sex and based on a Design Occupancy of 400 pax (200 Male, 200 Female).

In accordance with NCC F4D9(2) a washbasin may be an individual basin; or a part of a hand washing trough.

The proposed facilities represented in the layout attached under Appendix A, are considered to be adequate for the Classification / Use of the building, and will accommodate 400 persons as demonstrated above.
