### Construction, Excavation and Associated Works Security Bond (Road works)

The applicant is to lodge a bond with Council of \$10000 as security against any damage or failure to complete the construction on road embankment as part of this consent.

Details confirming payment of the bond are to be submitted to the Certifying Authority prior to the issue of the Construction Certificate.

Reason: Protection of Council's infrastructure.

### **CERTIFICATE**

## **Corten Steel Retaining wall**

The applicant must ensure the proposed corten steel retaining wall is erected completely within No. 114 Whale Beach Road. Whale Beach.

Details demonstrating compliance are to be submitted to the Principal Certifying Authority prior to the issue of the Construction Certificate.

Reason: To protect road reserve

### Submission Roads Act Application for Civil Works in the Public Road

The Applicant is to submit an application for approval for infrastructure works on Council's roadway. Engineering plans for the new development works within the road reserve and this development consent are to be submitted to Council for approval under the provisions of Sections 138 and 139 of the Roads Act 1993.

The application is to include four (4) copies of Civil Engineering plans for the design of driveway and the related retaining wall which are to be generally in accordance with the Council's specification for engineering works - AUS-SPEC #1. Any other retaining structures must be located within the property.

The plan shall be prepared by a qualified civil engineer. The design must include the following information:

- 1) the detailed structural design of the retaining wall
- 2) a 900 mm wide concrete dish drain shall be designed at the road edge
- 3) a 6 metres wide concrete driveway at the dish drain
- 4) the driveway must be designed in comply with Australian Standard AS 2890.
- 5) all utilities services on road reserve must be plotted on the submitted plan
- 6) a landscape plan on rad reserve must be included tree protection and proposed vegetations

The fee associated with the assessment and approval of the application is to be in accordance with Council's Fee and Charges.

An approval is to be submitted to the Certifying Authority prior to the issue of the Construction Certificate

Reason: To ensure engineering works are constructed in accordance with relevant standards and Council's specification.

## CONDITIONS TO BE COMPLIED WITH DURING DEMOLITION AND BUILDING WORK

#### **Road Reserve**

The applicant shall ensure the public footways and roadways adjacent to the site are maintained in a safe condition at all times during the course of the work.

Reason: Public safety.
