Hi Rhiannon, Re Road Safety Audit accepted by Council for DA2019/0863;

We write to make it clear and to confirm our concern, that the "Road Safety Audit" does not in any way refer to the safety issue raised in our submission to DA2019/0863, regarding NOT installing a crash barrier between properties and the imminent and ongoing danger to 49 Grandview Drive Newport.

NOTE; This Road Safety Audit document has been listed in Mod2020/0475 and not in the DA2019/0863 as was indicated as part of that approval.

Regarding this Road Safety "Audit";

1. The "Road Safety Audit" by the "Traffic Engineering Centre" in no way refers to the safety of 49 Grandview Drive as per the submission, as well as the risk of <u>NOT installing a safety barrier</u> as it poses to our family/property.

2. The Road Safety Audit by "Traffic Engineering Centre" only refers to the safety of entering and 51

Grandview Drive? And safety concerns relating to that property ONLY.

- **3.** This road Safety Audit does not take into account the <u>line of travel by vehicles down the hill</u> <u>straight into this area of impact</u> into 49 Grandview Drive?

- 5. It also in no way refers to the "DIRECTIONAL arrow " on the crash barrier requested by Council in our previous DA approval? (This directional arrow has since been crashed into so many times, it was gone long ago). Note that we have notified council a number of times to reinstate and fix this barrier.
