#### 1. Summary

In response to a request from the Northern Beaches Volleyball Association (NBVA) Council publicly exhibited a plan to install up to two additional permanent courts on Manly Beach between the northern most permanent court and the stairs opposite Carlton Street (see map at Appendix 2). The exhibition period was from Wednesday 18 May 2022 to Sunday 19 June 2022.


During the exhibition period 1063 responses were collected - 1050 unique submissions (excluding duplicates) through a Your Say page online comment form and 13 unique submissions via email / letter. 56% of responses were supportive of two additional courts in the proposed location, 41% were not supportive of any additional courts in the proposed location, 1% supportive of one additional court in the proposed location, 1% neutral / prefer not to say, 1% other. 

## 2. Background

Beach volleyball is a popular activity on Manly Beach played socially for fun and competitively for sport using permanent and temporary courts.

For over twenty years, Council has permitted permanent volleyball courts (the courts) to be located on Manly Beach. Currently there are eight permanent courts on the sand between Steinton Street and Raglan Street (Appendix 2). The posts and nets stay up at all times unless removed for matters such as beach maintenance, beach conditions and surf lifesaving, surfing and other events.

The public and the Northern Beaches Volleyball Association (NBVA) are the main users of the permanent volleyball courts on Manly Beach. The NBVA is a non-profit organisation formed in 1989, based at Manly Beach. The NBVA use these courts for training during the week (morning and afternoon) and some weekends (morning) and competitions and events on weekends (currently up to 14 weekends all day).

Due to the lack of permanent courts the NBVA also use the beach area adjacent to the existing courts (between Carlton Street and Raglan Street) for temporary courts on competition days to accommodate for the number of teams and players.

The NBVA have requested that Council consider installing additional permanent volleyball courts on Manly Beach to meet the increasing demand for more courts for their training,



competitions and events and for the public. The NBVA propose that any new courts would be made available to the public when not used by the NBVA.

In response to the NBVA's request Council publicly exhibited a proposal to install up to two additional permanent courts on the beach between the northern most permanent court and the stairs opposite Carlton Street (Appendix 2). This proposed location has been used by the NBVA to play volleyball with temporary courts for many years.

It was important to understand community views on the proposal prior to considering their proposal.

#### 3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities
- provide accessible information so community and stakeholders can participate in a meaningful way
- identify community and stakeholder concerns, local knowledge, and values

#### 4. Engagement approach

A plan to install up to two additional permanent volleyball courts at Manly Beach was publicly exhibited on Council's Have Your Say Online Hub from 18 May to 19 June 2022.

This engagement consisted of activities that provided opportunities for community and stakeholders to contribute and respond.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Matrix (2017).

A project page was established on Council's Your Say online platform with information provided in an accessible and easy to read format.

The project was primarily promoted through Council's regular email newsletter (EDM) channels, local media publications, site signs and resident notification letters. Contact was made with key stakeholders including; Manly Beach Running Club, Northern Beaches Volleyball Association, Beachvolleyball.com.au, Manly Surf School, North Steyne Board riders Club, Manly Malibu Board riders Club and Northern Beaches Surf Lifesaving Branch (and clubs via the branch), Queenscliff, North Steyne and Manly Surf Life Saving Clubs.

An aerial map was provided on the Your Say page to identify the current and proposed court locations (Appendix 2).

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents if they supported the plan for up to two additional courts. Respondents also had an option to nominate whether they supported one or both courts. An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

Email and written comments were also invited.

## 5. Findings

During the exhibition period 1063 responses were collected - 1050 unique submissions (excluding duplicates) through the Your Say page online comment form and 13 unique



submissions via email / letter. 56% of responses were supportive of two additional courts in the proposed location, 41% were not supportive of any additional courts in the proposed location, 1% supportive of one additional court in the proposed location, 1% neutral / prefer not to say, 1% other.

Key stakeholder feedback includes:

- North Steyne Surf Lifesaving Club –raised concerns that the proposed additional courts may impact on the club's patrolling area and activities such as nippers. Also, the increasing use of the beach by the public for ball sports with temporary nets impacts the club's activities including occasionally blocking access to their building.
- Manly Surf Lifesaving Club raised no objection to the proposed additional courts.
- Queenscliff Surf Lifesaving Club raised no objection to the proposed additional courts.
- The North Steyne and Manly Malibu Board Riders raised concerns about the amount of temporary and permanent volleyball courts on Manly Beach and the space this activity takes up as well as the impact on their use of the beach and other beach use.

## Appendix 1 Verbatim community and stakeholder responses\*

#### Verbatim comments collected through Your Say page

The people who use the beach volleyball courts leave a lot of rubbish on the sand. This is a consistent problem that will only get worse with more courts attracting more people.

This is a great initiative. That area of the beach is hardly used apart from people putting up portable beach volleyball courts anyway so this will make it easier for the entire community to use the space instead of only those people with their own volleyball nets.

It's great to have a beach space where people are encouraged to be active and stay fit. Most people just use the area between the corso and south steyne surf club for sunbathing to be closer to the flags and the area is usually marked as dangerous currents so it's better not to have sunbathers in that area anyway. It's also good to see that the proposal is to have the courts available for use by the not for profit volleyball association and the public, and not the for profit company that operates on some of the courts as well as there is stiff competition to use the courts anyway, and adding courts for the beach volleyball school to use wouldn't make sense.

I don't believe that additional public beach space should be permanently allocated to one sport. The beach is a public area which should remain so for the broader benefit of all.

I also have concerns of the possible negative impact the additional space may have in surf life saving activities. This encompasses patrol, competition and junior SLS (nippers).

Covers too much beach

Exclusive use of even more space by only one small group will further reduce already crowded space on busy days while existing courts often remain unused often (whoie at the same time still blocking the space for others' use).

On summer days the volleyball courts already take up a very large portion of the beach, making it inaccessible for other beach users. Adding two more courts would exacerbate this problem.

Beach is a shared resource for many sports and activities. Permanent volleyball courts obstruct this for others, including nippers, lifesaving clubs and other similar activities. We already have a significant beach space dedicated to volleyball.

More permanent courts make no sense, they already have a significant portion of the beach as it is. Nippers at North Steyne, recreation at North Steyne, Surf competitions, Nippers State competitions every year are very important community, not for profit activities that would be stymied if this goes ahead.

Please do not allow permanent courts in the proposed area

Beach volleyball is great for the Manly's community and businesses. Courts provide a great meeting points for players and not, providing a plaza-like feeling for the community.

More than often people using the courts when finish to play gather at local business for food or entertainment providing great input for the economy. The sport is growing and at the moment, the permanent courts are always busy at peak times (early morning and lunch times during the week and the entire day during the weekend) and the community has to resort to portable courts with sometimes no space for them.

Two additional court will definitely help to define the space for beach volleyball player and help reduce the amount of portable courts across the beach.

There is not enough information to make an informed decision. The area highlighted looks larger than two courts, there is no mention as to time of use, temporary courts and the area taken up exclusively for one beach group. How do they propose to work with surfing groups, beach goers, the flagged bathing area, surf clubs and the broader community?? There is no information or apparent consultation.

There are eight courts now and that is sufficient . There is also a\need to limit pop up courts.

would love to play a casual game of volleyball with friends after work sometimes. Maybe Manly rate payers could have priority every now and then- just a suggestion!

Concerns:

1. Already significant occupation of beach space. both in area and beach esthetics.

2. Court space does not represent complete occupation space. You should consider also surrounding area as part of the area occupied due to wayward balls and outside of court play. Competitions also block beach assess.

3. Beach depth has narrowed in recent years and limits other users between courts and waters edge. This has become more limiting when you consider point 2 above.

4. Rather than expanding volleyball at Manly, has other beaches like Freshwater etc been considered now that the entire northern beaches coast is under one council.

There are currently a lot of fixed volleyball courts and several temporary courts that get installed all weekend.

Enough of the beach is already designated to volleyball and I do not agree with adding any additional courts. This will reduce the available beach area for all other users and nippers clubs.



There are already a number of permanent volleyball courts on the beach. When these were approved by Manly Council, it was on the basis that there would be no additional courts.

The area proposed fro the new courts has been used for surf and board riding carnivals from time to time. Also during the summer holiday season, when conditions require it, the North Steyne Surf Life Saving flags are set up in this area. All of these activities would be hampered by the existence of permanent volley ball courts.

Of more importance is the general amenity provided by this segment of the beach for residents and visitors. The establishment of more volleyball courts would severly degrade this amenity.

The beach is a community resource for all to share. Currently there appears to be 8 permanent courts and at any given time, most particularly the weekends, there can be up to another 8 temporary courts erected. While I applaud the community fitness aspects of learning to play beach volleyball I note that the usable sand area has shrunk significantly this year and a very significant percentage of this available beach is already taken up by beach volleyball courts. In my view we should be ensuring that there is sufficient space away from the flagged swimming areas for other activities including, but not limited to, beach tennis, football, frisbee and other pursuits.

I am concern that it might reduce the space for the kids to do other activities on the beach such as nippers

The courts take up a lot of room on the beach for a relatively small number of people. I could support temporary non-permanent courts over winter but for the rest of the year, the existing courts surely represent a fair share of the beach for the numbers using the space.

The North Steyne nippers need the room. We need more Lifesaver training on our beaches, not more volleyball,

This one sport is being given far too much exclusive use of a beach that should be open to ALL.

As a parent of North Steyne Surf club Nippers program, I believe the additional Volleyball Courts to be an oversupply for this particular sport....Free beach space for Surf Club members and indeed residents and visitors to beautiful Manly beach front , should be preserved...Your sincerely

The proposal appears to suggest that the permanent volleyball courts will be close to North Steyne SLSC. As a member of the club and a nippers parent i am concerned that the courts will hinder the ability of NS SLSC to run the fantastic nippers programme that it currently does and which is an intergral and much loved part of the Manly beach community and a vital programme to establish a love and respect for lifesaving and the sea which is needed to encourage the next generation of Surf lifesavers - some of the most important people on the whole NSW coast.

Permanent courts (of which there are already a significant number on the beach) would prevent the area from being used for anything else and (even as a volleyball player) it seems unnecessary to erect additional ones on this stretch of beach.



I object to the proposal and have outlined my reasons in the attachment and what I believe may be some alternatives.

I would like Council to remember the beach is for everyone not just a small minority.

Please consider the local, general public and ratepayer.

They should come first

Two permanent volleyball courts are restricted it from all of us to use the beach. This will restrict the beach space that family/nipper activities can occur. Direct access from the Children's promenade playground to the beach will be compromised.

From Nippers perspective the Increased Footprint will:

Restrict the area available to run Sunday Nippers south of the club.

Prevent Nipper Board Training in large surf from being relocated to a safer section to the south of Club.

Unrestricted locations of Pop-Up Volleyball Courts along our beach could interfere with Sunday Nippers.

Impact the ability to host Nipper Carnivals will be restricted as sprint tracks will be unable to be set up south of Club (e.g. State Champs).

Impact the ability to conduct patrols to the south of the Club which may restrict flags to be erected at North Steyne. If flags can't go up, we would then be unable at Sunday Nippers to conduct any water activities.

There are already a large number of permanent courts available for volleyball players. The beach is accessible for everyone and this would greatly restrict the prime beach area that is available for all to use for a variety of sport and recreation activities.

I have the following concerns as a Manly resident and member of North Steyne SLSC:

• Fact that Council is prepared to give one sport exclusive use of 25 % of the beach and restrict it from others to use.

• This will restrict the beach space that family activities can occur.

• Direct access from the children's promenade playground to the beach will be compromised.

From Nippers perspective the increased footprint will:

• Restrict the area available to run Sunday Nippers south of the club.

• Prevent Nipper board training in large surf from being relocated to a safer section to the south of club.

• Unrestricted locations of pop-up volleyball courts along our beach could interfere with Sunday Nippers.

• Impact the ability to host Nipper carnivals will be restricted as sprint tracks will be unable to be set up south of the club (e.g. State Champs).

• Impact the ability to conduct patrols to the south of the Club which may restrict flags to be erected at North Steyne. If flags can't go up, we would then be unable at Sunday Nippers to conduct any water activities.

It is unclear why the courts need to be concentrated at this location at this beach. To grant the request would be to prefer the interests of one user group at the expense of all others (particularly having regard to the safety points listed above).

The history of proposals and approvals for this group should be reviewed in the context of this latest proposal.



There are too many courts as well. Find another beach. It's ugly. Stop flogging Manly beach enough is enough.

Please only allow one new court if you have too. There are plenty already erected and already causes blockages on the pathway above.

It can be hard enough to find space for families when the beach is busy. There should not be more of the beach blocked off for exclusive volleyball use. It is not only the area where the court is that becomes inaccessible for the public but a significant area around the courts due to the likelihood of being hit by a ball or sand, as well as equipment taking up more room.

Also, as a North Steyne SLSC Nippers parent, the courts would further reduce access to safe areas when the water is hazardous.

I am strongly opposed to this proposal.

This area is already used by Nippers at North Steyne

I support all the reasons outlined by Bernie Burrows. Namely that this proposal if accepted will :

Restrict the area available to run Sunday Nippers south of the club. Prevent Nipper Board Training in large surf from being relocated to a safer section to the south of Club.

Unrestricted locations of Pop-Up Volleyball Courts along our beach could interfere with Sunday Nippers.

Impact the ability to host Nipper Carnivals will be restricted as sprint tracks will be unable to be set up south of Club (e.g. State Champs).

Impact the ability to conduct patrols to the south of the Club which may restrict flags to be erected at North Steyne. If flags can't go up, we would then be unable at Sunday Nippers to conduct any water activities.

It will restrict prime beach space for families.

They already have enough beach space.

Not reasonable to dedicate this much public beach space for one sport.

Will negatively impact options for nipper activities and patrol activities & possibly limit where flags can be positioned south of the club.

Safety. Prams, children on the beach.

Too much space will be taken up by these courts. Space that I think would be better left for everyone to enjoy.

The current volleyball courts takes up quiet a bit space at the moment. With the additional pop up volleyball nets and beach tennis nets, that affects the space for residents and other beach users. The beach should be largely available for beach goers and residents and not taken up by permanent volleyball structures which only service a small portion of beach users.

Love to see the courts we have being used BUT don't want more.



This is a public beach space not a sporting facility. Get a warehouse with sand. The beach is crowded enough in summer without the loss of more sand for people to enjoy.

At high tide the water usually comes up as high as the current volley ball courts leaving little room to walk along the beach. With more courts there will be even less sand to walk along at high tide which is unacceptable as walking along the beach is one of the most important things the beach goers love to do. With ugly man made structures blocking access to the sand is not what Manly beach is about. I and many others will be very disappointed and angry if more permanent courts are put on the beach. It is a beach after all and not a sports field or volley ball court.

As a local resident/beach runner/member of North Steyne SLSC I think the volleyballers take up too much of the beach now, with permanent and pop-up courts! They're also less than courteous to others using the beach, unless you're saving there ball/s from the water... There is always rubbish left in the corridor between the courts and the seawall, as well as unattended sand rakes, that are extremely hazardous in the early hours of the morning.

Some other points:

• Fact that Council is prepared to give one sport exclusive use of 25 % of the World's Best beach and restrict it from all of us to use.

• This will restrict the beach space that family activities can occur.

• Direct access from the Children's promenade playground to the beach will be compromised.

• Restrict the area available to run Sunday Nippers south of the club.

• Prevent Nipper Board Training in large surf from being relocated to a safer section to the south of Club.

• Unrestricted locations of Pop-Up Volleyball Courts along our beach could interfere with Sunday Nippers.

To much beach dedicated to a small number of users. This is public space.

There are already a number of volleyball courts on the beach. The beach should be an area for all communities and not som largely taken over by one sporting group. Two further permeenant courts will significantly alter the free space for families to use the beach. it will also impact other sports' ability to use the beach, the nippers and SLSC which use this area of the beach for nipper training and importantly for carnivals will have their area significantly reduced. Nipper squads and surf life saving are a core part of the beach and anything which impacts them will have significant effects on those children involved with the club and the ability of the club to give a patrolled area of the beach for locals to swim safely. further to this it cuts the ease of access from the promenade and children's play area to the beach. I am firmly against the proposal and feel it is a non-equitable and unfair use of a public beach area.

There are already lots of volleyball courts on the beach area. The beach is for everyone, not just the volleyball players.

Six is more than enough as players take up room running from the court when playing.

During the summer, the courts fill up really quickly and it's hard to acquire one. Two more would be really useful.

Why should any faculty take part of one of our iconic landmarks. Leave it for all the community to enjoy. They already have way too much space and the pop ups should be controlled also. Don't get me wrong I love VB but the beach is for no association to own.

As a parent of a child who attends North Steyne Nippers and a regular visitor to Manly Beach, I oppose the proposal for additional volleyball courts as this will limit the beach availability for other activities, including Nippers, and access for the general public to one of Sydney's iconic beaches for activities other than volleyball

I feel the existing number of courts is sufficient for that activity, leaving room for the many other beach activities that people like to enjoy. It is vital that we avoid ending up with overcrowding of this pristine environment.

The beach is a beach and should be enjoyed by people who take pleasure from what the beach has to offer that is swim, surf, bogey board, exercise and sunbake.

Parking will become impossible so the people who want to visit the beach to enjoy the beach itself eg swim and sunbake wont be able to as they wont be able to park.

I definitely dont want any more volleyball courts on Manly beach.



I strongly object to having more permanent volleyball courts at Manly beach because:

1. The beach should be available to people who genuinely want to use the beach that is swim and sunbake. In summertime most of the beach from Queenscliff to South Steyne is crowded with sunbakers. Adding 2 more volley ball courts will mean that there will be less space / sand for people to sunbake therefore all other areas would become even more crowded for sunbaking making.

2. there will be less parking available for people who genuinely want to enjoy the beach that is swim and sunbake. This is extremely unfair on the genuine beach goers. Parking is already impossible and adding more volley ball courts with people coming to practice and with no intention of using the beach itself will make parking an absolute nightmare.

3. I live opposite the current volley ball courts and it is quite noisy. Adding more courts will make the noise extremely bad and it will be unpleasant to sit on my balcony and enjoy the beach view - which is what the beach is all about.

4. Volleyball has no connection to the beach in any way. It is not surfing, swimming, walking, sunbaking, kayaking, stand up paddle board or bogey boarding. Volley ball is a game that can be played in numerous other locations than a beach. The activities I have listed above can only be done at the beach. 5. alot of the surf schools use the sand where the proposed courts will go to show students how to stand etc on their boards. With volley ball courts there this will mean that they will have to use the sunbaking areas of the beach. Meaning less sunbaking areas for people who want to sunbake. Surf lessons are part of a beach and its culture. Volleyball courts are not part of a beach life or its culture. 6. We already have enough permanent courts. After all Manly beach is a beach and NOT a sports field or a volleyball court.

Concern regarding the amount of beach designated to volleyball and it's proximity to N Styene SLS

Manly (including North Steyne) is a very popular beach for the locals and tourists (over 2 million domestic and international tourists per annum!). This proposal provides one sport exclusive use of the area, and restricts the rest of people to use the area. As a family with a young child, we also avoid the area around the



current volleyball courts to avoid being disturbed by the volleyballs when they were hit outside of the courts.

With the addition of new volleyball places, it will directly impact the North Steyne nippers activities which will be a loss for the community. I strongly believe that the beaches should be an area for families the enjoy the beach and for multiple sports to be exercised. Now, it will look like the beach is only for volleyball.

If this were to go ahead, It would affect families and North Steyne Surf Club. On Sundays, nippers won't be able to be run south of the club, limiting what activities nippers can do. It also means that in the event, it is unsafe infront or north of the club to erect flags, that the beach would have to be closed limiting the amount of people wanting to visit the beach. There are already enough volleyball courts up, and not much beach for those wanting to use it for other activities. It will impact on tourism as people won't want to go to North Steyne to go to the beach, and it will affect parents and children having access to the beach directly from the playground. I believe that there should not be anymore volleyball courts erected on manly Beach for these reasons.

Loss of space for public use and nippers

Giving people the opportunity to exercise and have fun is essential especially outdoors so with the extra courts provided that would give more people the chance to enjoy the facilities and our beautiful beaches.



The Beach is a precious public space and should not be further reserved for exclusive private uses. There are many legitimate claims that could be made for beach use by other clubs and associations, so the existing courts should be considered a privilege.

There are already a significant number of courts on the beach and adding further takes up even more of the beach restricting other activities.

The beach is a public asset and should not taken away from the public and given an exclusive use a small minority

Manly beach serves many purposes to various users, including surfers, families, swimmers, sunbathers, people exercising, meditating, doing yoga, frisbee, beach tennis and other ball games. When the tide is high there is limited dry sand left, which pushes beach users closer together. In my opinion, a decent proportion of the beach has already been made available to volleyball courts. Increasing the court space unreasonably reduces the remaining space at Manly for all other beach activities, users and residents. The volleyball courts permanently change the beach space, unlike a towel or umbrella which is gone after use.

Would the proponents consider a less occupied beach, for example Long Reef?

I'm not against beach volleyball, but keen that we maintain the magic that is Manly beach. One of the wonderful aspects of Australian beaches is how natural beauty is protected. A beach with permanent nets in place has already migrated away from its natural and beautiful state.

It's not sustainable to use our public beaches for private organisations, regardless of whether they are for-profit or not. Such use excludes the general public who are not members of the organisation, and as the Association is obviously growing, then they will further dominate the use of our public space. There is no mention of limiting the growth, nor is there any detail on providing transparency to the booking process and ensuring equitable access to everyone. My family and friends greatly enjoy being free to make use of these nets and it would be unacceptable to make that harder for us to do. Take a look at the inaccessible and secretive Manly & Warringah Water Ski Club that has exclusive use of Manly Dam - a disgusting and shameful use of public recreation space with the council gifting a select few 'license to be elite'.

There are too many courts now and they have taken over large parts of the beach already . Enough is enough the beach is for everyone not just them . They can find counts elsewhere .

Since the March 2022 storms, Manly, North Steyne and Queenscliff Beaches lost approx 1.5m depth of sand. This means that ALL of the sand on these beaches is now INTERTIDAL sand (between low and high tides) rather than BEACH sand (above the high tide levels). This means that the current location of the courts is subject to regular tidal highs (with concomitant erosion and loss of posts). Removing the most southerly 3 courts (where erosion is most common) and adding two new northernmost courts will provide a temporary solution and should be considered. The expense involved with sand levelling can no longer be justified. Perhaps a better solution would be to move all of the courts away from Manly to another beach where the erosion has not yet been as severe? Palm Beach or Whale Beach, perhaps?



The volley ball takes to much of the beach space

Not enough room on the beach in summer already !! Don't agree to closing off more for such a small number of users. Also parking problems already - this is likely to worsen the problem. Local businesses such as cafes losing business already as potential patrons cannot park nearby

There would be too much beach area taken up by the volleyball courts.

Your photo shows a low tide / wide sand area. High tide is the issue when it narrows the beach and on occasion beach walking has limited space forcing walkers too close to the courts & stray balls.

Too much of the beach is already set aside for the beach volleyball. The beach is a public resource that should be shared for all to enjoy and not allocated for the use of a select few.

Especially with the recent tide rising it becomes very difficult and unpredictible to prepare for classes with courts side by side, this is why having the additional courts in line would be important for.

By the way, I've just returned to Australia after two years overseas, and one of the key reasons I've choosen to live in Manly is because the NBVA squads. And I'm very sure that for many others this is also a key aspect for living here and any reasonable request to improve the space for the beach sports should be taken into high consideration by the Council.

Taking more of public space for one group of sport

With the beach tennis and other temporary volley ball courts, the beach is already packed. More courts will benefit a handful of volleyball players and disadvantage the many beach goers looking for somewhere to set up at the beach - away from the risk of being hit with a ball.

good use for the beach and a good facility for all



Community sports should be supported and the impact on other beach users is minimal.

Need to leave space as intended by nature and allowing for other community movement, non restrictive access or additional permanent fixtures in particular. Leave enough space for wkd visitors from areas not within this lga, as usage should be for all.

The area required for the additional courts is modest compared to the benefits for the community

Beach volleyball is something that defines Manly and its beach. Even on the busiest days, there is still sufficient space for general beach users and the two additional courts.

A significant allocation is already granted to a single sport or community group.

#### Couple of points -

The additional demand can be managed with temporary courts that are put up and pulled down on a daily basis, which they currently do and that allows them to use space in winter when there is not the public beach demand and for the space to be free in summer when used by beach goers. Once the permanent courts are up, they are there to stay and don't have flexibility.

- Extra beach allocation in addition to the courts needs to be taken into account. For example a zone of another 20m north of the new courts is an area where bathers can not sit give high velocity balls. My son was hit hard by one at the showers in the middle of the courts. Also when erosion is high and or tide the beach to the east of the courts can not be used by bathers. Again the measurement of 'allocated' space to the volleyball courts should 20m either side of the last courts north and south and to the east. As a percentage of the beach that is a hugh allocation.

- Manly and bondi are Sydney two big tourist destinations. Once travel come back this summer the beach will be extremely busy again. Very important for council to give enough space to tourists and locals to use the beach for their needs.

Leave the beach available for all to use, not just one sporting interest. Volleyball has already taken up a large area of public space on our fabulous beach.

NO MORE.

My son and husband both use these courts and more available would be appreciated.

There are in my opinion sufficient courts as it is. We don't want any more of the beach view blocked by courts. There is more to living at the beach than volleyball. If you continue to extend, there will not be enough available space for other things such as beach cricket, frisbee throwing etc.

The Beach is for all - the area taken up by the existing courts in the image above, is sufficient.

There is already too much beach taken up by volley ball courts, both permanent courts and all the casual courts that keep advancing down the beach.

it would be good for players to have 2 additional courts.

Beaches are for passive recreation and for everyone to enjoy, not for particular interest or commercial groups

It seems to me that even if these are not approved the volleyball players will set up their own courts... as they are doing now, taking more and more beach space for 4 to 6 people at a time. Last weekend there were 6 additional courts. Some by The Corso, some belonging to a Gym, and then 'Beach Tennis' courts also, as well as a surf comp claiming the water. Lucky the Surf Lifesaving clubs were not also vying for beach space!

As owners of property on North Steyne (and hence ratepayers) we are vehemently opposed to any plans to add additional permanent volleyball on Manly Beach. We already suffer regular loss of the beach to surfing competitions (including temporary structures which damage the grass surface) and to consider permanently giving up part of the beach to volleyball players (potentially non rate payers) is ridiculous. Build some courts away from the beach by depositing sand and keep Manly Beach for the use originally intended - swimmers, surfers and sunbathers.

It already has so many courts! It is taking up beautiful beach real estate that the rest of us like to enjoy.

I think the volleyball is already spreading out enough in Summer with additional courts they are putting up. The beach is getting busier and busier every year with more people and now also beach tennis taking over,

At least the courts are in an area where there are usually no flags to swim. The challenge with ball sports is that you can't lie near them as you risk getting a ball on your head.

At least the volleyball courts are in a good position away from the flags and swimming area and with enough distance to them.

But there needs to be space on the beach to just lie and relax without getting a ball on your head or being in a crowd right in front of the flags. The beach should be for recreation for everyone.

Regarding the beach tennis, they often put up their nets too close to the flagged area. During summer Queenscliff area by the flags was very crowded and the beach tennis was too close to the area where people lie near the flags and then risking getting <u>hit by the ball.</u>



Just like Volleyball they should only be allowed to place themselves in the middle between South Steyne and Queenscliff so they don't interfere with people wanting to swim and be close to the flags. Thank you. They have enough! Plus there is now beach tennis down near Queenscliff in summer ! More people can enjoy this beautiful sport Volleyball activity on Manly Beach is a pleasure to watch, unobtrusive and promotes a healthy lifestyle It is great to see so many people involved in an outdoor sport. It is also a good use of public space. Hogging to much beach. dont mind more courts.. there is enough space on the beach. The demand for volleyball is obvious. As a Manly resident and beach user I would prefer less volleyball courts, however that is selfish given the obvious popularity. (I am not a volleyball player.) They are also well located in the less desirable area for swimming / sitting on the beach which is good, although the area of the new courts is pushing into more desirable beach. I do not believe that any more courts than this should be approved as they would encroach into the swimming areas ie where the North Steyne and southern Manly flags are placed. Finally, I believe that the feedback of the North Steyne Boardriders and Longboard riders should be given considerable weight, as their monthly competitions are likely the most significantly impacted aspect of the current beach use. It maybe that an agreement not to use one or two courts on their competition day is appropriate. (I am not a member or participant in the surfing competitions.) The existing courts have taken up a lot of public space for a single sport. We should use the area to promote other sports to add diversity and more users

can enjoy.

Why would you not allow this proposal. ! go beach volleyball

There are many courts there already and the beach should be open for all users not just volleyballers

They already take up so much of the beach. Whilst it's a great healthy sport on our beach, they are a visual and physical blocker for accessing the beach. Surely temporary courts can be erected when required?

Manly beach is already a very busy beach. The courts take up a lot of space, and they already have a lot of courts on the beach, so I dont think adding more is very fair for other users of the beach space.

Over the past months the courts have stretched out further towards the front of the Novotel. (Larger spacing between courts). The portable courts are actually erected by the volleyball association. So on most weekends they have anything up to 17 courts. Associates also bring their dogs onto the beach; I thought that was a no go. All these courts make it difficult for locals to enjoy their immediate beach. I personally would like all the courts moved to the Queenscliff end, which is only very sparsely used.

Attached is one of the portable courts in which you can see the association coaches are clearly using.

Beach volleyball is a great entertainment for walker and fitness activity to promote the healthy lifestyle of the Northern Beaches

The area is already loved by too many people. The beach is very narrow at that point and, at weekends, with so many people walking along the pathway it has become very dangerous as its such a high traffic area. The last two weeks bicycles have started using the path as well riding through the crowds. On Saturday there was a surfboard happening, plus the playground, and a sunny morning with and many people out watching the waves. An absolute nightmare to try to get through. What happened to social distancing? This morning there was a volley ball court set up next to North Steyne Surf club and another opposite the Hotel Steyne as well as the permanent courts. Often there are courts set up at Queenscliff - at least the sand is a bit wider at the northern end. Each time I walk past the courts all I can only think about is Skin Cancer specialists in 20 years time treating skin cancers and melanomas on the scantily clad girls that play the sport. Please, choose another area for additional courts to be installed before a serious accident takes place between Babies in strollers, dogs on leads, older folk slowly walking, joggers, surfboard riders with surfboards, international visitors, plus so many others out to enjoy Manly.

Strongly against any more courts it's our beach as well and the courts take over

I believe the nets already take up too much of the available beach space. The beach is supposed to be a neutral shared space for all, however the volleyball people take over a huge swath of the beach, not just where the permanent nets are but they also set up temporary nets to either end and to the sides, generally spanning almost the entire width of the beach.

I believe theee are already enough courts there. They take up too much of the beach and are quite unattractive

Limited beach space in summer. If it's based on weekdays only for the 2 courts, that's fine.

Beach volleyball is a fun, inclusive and high-energy sport that brings the community together. It's also a safe, low impact activity that's suitable for all ages.

By allowing two additional courts, Manly will join other world-class beaches like Manhattan, Copacabana and Waikiki advancing the sport and producing future Australian Olympians.

The beach is a natural ecosystem. Not a space for sporting fixtures. The Volleyball draws large crowds and spectators which already congests the promenade. They are also installed on the level sand which prevents joggers



running the length of the beach. The courts interfere the natural beauty of the beach.

The community has grown, it has a positive impact on the overall community and the beach is wide enough that it won't be a problem for non volleyball players.

Beach volleyball is already the beneficiary of a significant stretch of the beach which no other sport or activity has the same benefit of. The beach should be available for all forms of activity and should not be the subject of further permanent infrastructure for the sole use of one group. Further, with recent erosion the sand between the courts and the waterfront is no limited enough without further sand being reserved for exclusive use.

The beach volleyball community brings a wonderful energy to Manly Beach and ensures the beach gets lots of use all year round. The draw of people from other parts of Sydney and the flow on benefits to local businesses is significant.

I have no problem with more volleyball courts but all courts need to be situated well away from any stairs leading into the beach. The end of the court needs to be at least 5 metres away from any steps. The reason is that the court in the southern side of the stairs just north of the shelter is too close to the stairs. Nearly every morning the volleyballers use this court for spiking practice and as a result we have been hit will balls and are continually having to dodge them coming at us. The courts need to be spaced so that other beach users can access the stairs to the beach without being in fear of being hit by volleyballs

I have written in before, however I have additional information that will hopefully help with your decision.

Every time I politely voice my opinion about how I don't think these courts are a good idea I'm met with extremely aggressive responses from people who are obviously for the courts.

If you scroll through the social pages such as manly living for instance and have a look at the replies people are getting. This is a perfect demonstration of the rude and aggressive attitude and behaviour that we don't want in our community. I live on carlton street, own my property and have young children that play at the beach at the end of the street. I'd like to protect my family and the integrity of Manly beach.

There are more than enough taking up too much room already They're too permanent Find elsewhere Beach is squishy enough



It also generates a strong economic benefit for council considering the state and national tournaments that bring dozens of players into manly on a monthly basis.

The beach should be for varied recreational use and should not be over weighted to one activity

The existing volleyball courts take up a significant proportional already, extending this to the benefit of a single user group and more specifcally an sporting association is not equitable or fair.

Beach should be for the enjoyment of all people and activities and not overly weighted to one

They have a generous provision and allocation already

The growing volleyball community is in desperate need of more permanent courts.

6 out of 8 courts are typically used by nbva and there is little room for social play, especially during peak times.

There are already a large number of courts taking up private room on a public beach. This additional space should remain public and open for surfers/beach goers.

No more volleyball courts, and keep all court sports in the massive area allocated. Enforce the rules, and keep the rest of the beach clear.



I love seeing people enjoying themselves on Manly beach - surfing, jogging, sunbathing, swimming, playing volley ball and beach tennis. Everyone should be able to enjoy Manly beach in a variety of ways, but no sporting group should be allowed to permanently install fixtures or essentially permanently claim sections of the beach for their own use. I assume VBA must be offering some sort of financial incentive for this to even be being considered at all, because this certainly is not good for the wider general use of the beach. Saying the beach will be available for community use when not in use by the VBA, sounds like a reasonable compromise at face value, but in reality they are using the beach space in ideal sunny daytime conditions for training, casual matches, weekly matches and competitions. This really means many of the best times of the day, you are only able to walk along the wash zone of the beach for that entire section for much of the week. Extra courts will make that zone even longer. The courts also require the beach to be roughly level over a wide area. So VBA need to keep the sand built up flat, which results in a steeper sand shelf near the water. That steep beach causes stronger wave surges up the beach, where all bypassers are forced to walk, and also causes reflected waves back out into the incoming surf for surfers, Furthermore there are permanent large wooden posts sticking up out of the beach at all times. In the recent storms, the posts closest to the beach washed away and the natural slope of the beach was restored and rendered the entire playing area unusable. This is a natural process and will keep happening, exacerbated by the beach court leveling.

The beach should be for ALL to enjoy, including VBA, but they should not be allowed to set up permanent courts, let alone additional ones. Temporary ones are fine and I've seen how fast they can set them up.

Our beach is a world class tourist attraction, and should not have any areas permanently configured as sporting courts. All of Manly beach should be protected for all to enjoy. We do a great job with beach-front events, with no permanent presence. This should be handled in the same way.

Set up, play, pack up. Leave nothing but footprints!

The beach front is for all to enjoy. Can be quite intrusive to other beach goers especially young children .I have experienced this with my grand children feeling intimaded and uncomfortable.

This is a public beach for everyone not just for a one sport to take up all that beach I have seen arguments on the beach regarding these players who have no regard for anyone else but themselves ! I wouldn't even let them keep all 8 they have now ! Go elsewhere and play your sport

I think there are too many courts already. Once we get to summer, which will hopefully not be Covid impacted, we will realise just how much of the beach has been taken over by these courts occupying space that used to be for families having a day at the beach.



There's already plenty of courts that take up excessive beach space. They also set up numerous temporary courts in additional rows that nearly reach the waters edge. No other community groups take up this much beach space, they absolutely do not need a centimetre more. If they want additional courts they can and will set up temporary ones. Additional permanent courts are completely unnecessary and unfair to the rest of the non beach volleyball community.

The proposed area is popular for sun bathers given the access to the beach via the stairs. Having volleyballs flying around will push sun bathers out of this area and further down the beach towards Queenscliff.

Can I suggest that instead, council consider conversion of part of an exiting grass recreational ground to a sand section that provides facilities for this growing sport.

Encroaching too much on space for passive beach use which aids in communities mental health.

There are already too many courts, there should be shorter sessions times or better booking systems to accommodate demand, rather than taking up more space that obstructs regular beach use.

I've recently started playing beach volleyball after lessons at Manly. Often the courts are full on a sunny morning or afternoon so one or two extra nets would help give more people the chance to play.

Why have you allowed them to have so much beach? They are noisy and disruptive when walking along the beach and spoils the iconic view of Manly beach

Difficult to find a quite space

It's a commercial group charging money for classes etc No one else can take over a beach as they please

Manly Beach, including the sand and the ocean, is an increasingly precious sanctuary from the hustle and bustle of our built environment. The simple experience of being on the beach is a world away, even compared to a couple of metres away on the paved area above the wall, from the stresses of daily life. Beach volleyball could hardly be more incongruous to the vital tranquillity otherwise provided by the beach. I would prefer to see discussion on reclaiming this important, wonderful, natural asset rather than further inroads of permanent, built infrastructure.

I use the beach regularly for soft sand running and already have divert a large enough portion of the run around the existing courts dodging balls.

The beach has always been the local Manly communities backyard.We have raised two children on Manly Beach, enjoying all the freedoms of space that a beach provides .In an increasingly crowded and hectic society please keep open space for locals and tourists alike to enjoy.One group should not lay exclusive claim to this much public space.Thank you

They already take up enough room on the beach and will impact the running of the surf clubs



This will significantly impact other social activities that happen on the beach. Our family avoids the areas where volleyball is played as it is intimidating and often minimizes space to play on the beach. Particularly when there is less sand.

It also impacts activities for nippers and SLS training.

Also impacts that ability to view the beach without infrastructure in the way.

The volleyball courts already take up a sizeable portion of the beachfront, making that section of the beach effectively unusable by other beach goers. Adding more permanent courts will take away even more of the beach from others, and seems overly weighted towards volleyball as the only activity on the beach.

Already takes up too much space on the beach. In summer with all the nippers it's way too full already

The beach is already busy enough with beach volley ball, board rider clubs and nippers. Adding more courts would impact those other users and also would mean less

Space for the public to enjoy the beach.

No more volleyball courts are needed on the beach. Keep all court sports in the massive area already allocated. Enforce the rules, and keep the rest of the beach clear for those who want and need to use the space for other purposes such as training for the Manly Surf Club beach and water teams.

To whom it may concern,

Respectfully I must strongly disagree with the proposal for the extension of volleyball courts.

The proposed extension will encroach on various OH&S, general public health access, lifesaving and recreational sports activities that are already existing including but not limited to:

Lifesaving functions Surf sports Family Beach areas Surf Club activities from North Steyne

The courts will remain mostly unused for a majority of the week as they stand currently. Extending the court capacity for demand at certain times of the week is not a good use of beach space.

I would welcome a off beach area be set up for beach volleyball similar to other countries where specfic areas (nearby beaches) are set up as purpose built courts for beach volleyball practice. There are various areas in and around the beaches that could take on this capacity.

The most concerning aspect of the extension of the court space is that it may affect the safety of the general public by eliminating access and training areas for the surf lifesaving club at North Steyne. Increasing liability for the council in regards to protecting locals and visitors alike. I would imagine for this reason alone the council should cancel the porposal and look to alternatives to imporve opportunity for the Volleyball club to grow outside the regular beach spaces.



The sand on the beach is for people to relax and enjoy so it's not there for permanent formal organized sport that doesn't actually need a beach. So, while it is probably 'ideal' (& a luxury), beach volleyball doesn't need to take up permanent space on a public beach, it can be played on sand elsewhere, unlike other beach sports which require 'a beach'.

There are way too many courts already- so much of the beach is taken up.

With 3 surf clubs, a surf school and 2 surfboard rider clubs, we are already at capacity in utilising the space when we have surf conditions to contend with. It would be unrealistic to think that the volleyball courts could utilise that much beach real estate in comparison to all the other activities. Let alone ruining such a hub of leisure area infront of the north steyne cafes by having volleyball courts there. It's not just the courts but the surrounding area of the courts that then doesn't get used, as no one wants a stray ball hitting them. The wall along North steyne (south of the club) is enjoyed by all ages interacting with the pathway and the beach. The volleyball courts would ruin this.

The beach should be for all, not just volleyball. They are eye sores and there are already enough

They have Enough court as it is

You can't go for a soft sand beach as the volleyballers are taking up too much space already.

There are enough courts. There is already an impact on other users of the beach so i think it's fair to cap the number of courts at where they are currently.

As a non volleyball player I actually enjoy watching from the wall and see how many people enjoy the game. It's a manly staple and given this proposed area I somewhere where swimming flags are never put up it makes sense. Thank You

The beach is a community space. Additional courts will significantly reduce community space - the balls end up going well beyond the bounds of the courts so effectively the courts take up more space than just the court boundary.

The beach is for everyone to enjoy. The additional volleyball courts will take up too much of the beach. There is already a significant section of the beach off limits due to the volleyball courts. Please do not add more courts.

The current volleyball courts are more than enough. If they want to expand go to another beach.

Families which enjoy the beach are significantly impacted by the volley ball courts and any expansion would further impact people ability to enjoy space on the beach. With nippers, SLSC events and the surfing competitions all of which are a great tradition will also be impacted with more space being taken by the expansion of courts.

This area is for the public to relax, swim and sun bake away from the noise and crowd of South Steyne. The volleyball courts bring both crowds and noise that impedes on the relaxation and ambiance enjoyed by beach goers. I also think there are enough volleyball courts already. Just because it's become popular shouldn't mean you get to take over more of the beach.

I believe it's best to keep the courts as is and no more additional courts. It is already been so busy and there hasn't been much sand at the beach and the eroding shore area.

Im new in manly and i used play indoor volleyball in japan, and now that im here im wish i could try playing beach volleyball

HAVE YOU THOUGHT ABOUT THE IMPACT THIS WILL HAVE ON PARKING???

There is not enough parking spots as it is....

Volleyball already takes up a substantial amount of space on the beach which is at a premium. The proposed courts edge closer to where North Steyne SLSC sets up its flags and this area does get very crowded during the summer. These courts will further add to that problem.

Another consideration is the constant beach erosion that is happening and how this will work with those new courts, there are constantly exposed rocks on that side of the outlet which will mean they would have to move further towards the ocean. As we are also seeing at the moment the current courts are constantly being washed away by high tides, so the question should be asked whether the beach is a suitable place for these courts at all because with ocean levels rising this will happen more and more. I think it would be irresponsible to build more courts on Manly beach but rather maybe alternative locations should be investigated.

I think volleyball courts should be installed at other northern beaches



This is very, very disappointing.

I'm not against Beach volley ball as such and I recognise it is a popular past time...BUT.....they already use a huge amount of beach (maybe 20-25%?), 365 days a year, for what is effectively "exclusive" use of one sport.

Have you forgotten the problems associated with Beach Volley Ball back in the nineties? (ask someone who was around then, it's an interesting story!), 2 extra courts this year...how many more next year?

This area is already compromised for general beach use on a permanent basis. I'm OK for them to keep what is there and if you really have to, then add a temporary extra court when needed for special events/tournaments, but seriously...more "permanent courts".....definitely not!

What next - flood lights? (which I note from their social media they also want! Great, more issues at night for Manly!).

The proposal will affect general beach goers by further reducing the available beach and access points.

Other local beach Clubs like North Steyne board riders & Manly Mal Club have had events held off Carlton St for years. These would likely be affected. Summer Sunday nippers at Manly LSC & North Steyne SLSC may also be impacted. Based on this year's State SL Champs, I imagine they also would face a loss of beach access for the next two years of their run on the beach as a result of this expansion north.

It is also so disappointing to see the beach strip between Queenscliff and North Steyne Surf clubs has had no remediation of the beach since the recent storms. This left rocks, and concrete reinforcement blocks dangerously exposed, yet bulldozers have already rebuilt the the existing area in and around the current volleyball courts!

I suggest you look after the beach first. There can be no beach volley ball if the beach is not looked after properly.

Has council formally asked the 3 Surf Clubs/Lifeguards & emergency services about how it may affect their patrols, flagged areas and access? Anyone who knows Manly beach knows the area between the south pipe and the area to the north (where the courts currently are) can be exceedingly dangerous for swimmers. Potentially reducing access there may also affect overall beach safety/rescue and first aid.

Sorry NB Council, keep the status quo, but this expansion is NOT in the best interests of the beach or Manly in general. Please reject it.

I support as long as it doesn't interfere with North Steyne SLSC operations and Nippers. There has not been any analysis produced in this yoursay to fully understand impacts so I expect NBC to take impacts to SLSC into account and make the right decision.

There are already too many. They take up most of the beach and particularly when the tide is up there is not even room to walk through. It ruins the feel of the beach and limits access to all



This proposal further encroaches in a public space for a very niche use. That area of the beach is commonly used by walkers along the promenade to for an uninterrupted ovean view, exercise by locals and semi regular spot for local surf comps.

We also use this area for nippers training, especially in poor weather conditions.

Putting more single use permanent structures in the sand is against the public interest. The beach should be maintained in its natural form as much as possible and accessible for many interest groups.

The Volley ball courts already take up a large area of beach, we don't need more.

It is not a very busy part of the beach. The beach volleyball services many community members.

The actual beach is for everybody to use not an elite few. Also in summer when nippers is on and the tide is high there is no where to sit. Also now at north steyne to queenscliff we have beach tennis 2 courts and loud music. Plus the beach is used by a couple of gyms to train. I might add i train on the beach everyday so i see this regularly.

There are already too many organised activities.

The beach is already too crowded with organised activities.

I strongly disagree with the proposal. There is already too much exclusive use of the beach. I would like to see less volleyball courts, not more.

There are already 8 permanent courts at Manly beach .

The proposal to add two more to the north of the current courts would impact nipper training and club training at North Steyne slsc.

The Northern Beaches Volleyball Association could potentially look at expanding it's VB locations , and provisions , across the Northern Beaches , not just at Manly Beach ?

There are many other beaches that other courts could be operated on , and at the same time provide easier access and parking for participants across the Northern Beaches .

Less space on beach for sun bathers, swimmers and surfers. Why do they need all this space.



The current allocation of public beach space in this location for this sport is already adequate if not excessive when you take into account the additional number of temporary courts that are erected every weekend and some weekdays.

I recently counted more than 20 courts between Queenscliff and Manly, many doubled up and taking up the whole width of the beach. The inconvenience this causes is clearly a problem and I have witnessed a lot of frustration and anger from people who are being impacted.

The use of the beach, in particular the area of the beach above the high tide line is limited and there are other activities enjoyed by many who like to use this area of soft sand for their chosen sport/recreation. Unfortunately their ability to do so is being impacted by the presence of these temporary courts that are erected every weekend. This inconvenience is exacerbated by the behaviour of some of the volleyball players who often disregard the rights of others.

The NBVA is not the Manly Beach Volleyball Assoc., so the courts should be spread throughout the Northern Beaches and not all concentrated in Manly.

This is a public beach - they take over with tents, loud music. It's not just the beach they take over but the walk way above the beach They have enough of our beach. Absolutely not. Enough is enough!!

I respectfully disagree with the proposal to add any more permanent volleyball courts on precious beach space. The existing courts already take up substantial room on the beach. At high tide in particular, there can be a lack of space to walk or for families to enjoy the area. Placing two additional courts and the extra room associated through players retrieving balls or placing their gear is selfish and unnecessary.

Additional permanent volleyball courts are not supported, and are not warranted. Installing additional permanent volleyball courts will alienate even more of the beach from public use, and prevent other ad hoc community (or commercial) activities taking place. This is most concerning in high tide. If additional courts are needed on an hoc basis, I suggest temporary courts be used (and only installed for the games/practice needed).

I have lived my whole life at Manly and have always enjoyed a walk along the walkway from Manly to Queenscliff. I am now 96 years old and have to park somewhere close to the beach as I require a walker for support. Over the years parking has become harder and I often go back home without a walk as I can't find a parking spot. Why can't the organisers use other beaches instead of further crowding at Manly? I respect Manly has special events when parking is difficult but adding more permanency is creating too many future headaches.

Please don't allow any more courts.

Less room on the beach for those wanting to sit on the beach and also for those participating in nippers

There is enough of the beach being used by volleyball courts now, add to that the cabana's they also erect. It forces the rest of the beach to become over crowded. Please enough is enough let everyone enjoy the beach.

The beach is for everyone not just volleyball. The surf clubs are far more important.

The volleyball courts have encroached enough on Manly Beach. Manly and Bondi are iconic showcases for international tourists and should not be overcrowded. As with all other sports on the northern beaches they are spread throughout the suburbs.

NBVA should spread their matches and set up competitions on other beaches. CurlCurl has lots of unused areas as do other beaches along the coastline. NBVA should not try and incorporate all games on one stretch.

Mobile courts are also being erected and forcing beach users off soft sand areas and at high tide too far away from Surf Lifesaving patrolled beach flags.

Please spread across other northern beaches and do not overcrowd Manly. Beach parking is already at a premium and adding more volley ball areas just causes more bottlenecks. Some people stroll the promenade and if they can't park to share Manly it's a real shame.

As a long serving surf club member at North Steyne, the addition of these volley ball courts will decrease the amount of people coming to swim at our beautiful beach due to overcrowding and possibility of getting hit by a volleyball. No one wants to sit on the beach with the thought that they are going to get hit in head by volleyball.

I believe my response to be largely superfluous because on any Sunday, temporary volleyball courts are set up far beyond the area covered by the proposed two additional courts, reaching almost to the North Steyne Surf Club. In fact it is not uncommon to see these temporary courts set up north of the Surf Club. The volleyball appear to be allowed to do this without any supervision or control by the Council.

It is believed that no more shared public space should be alienated by private groups.

One overarching issue is that the heavy volley balls are often not controlled and interfere with individuals just trying to walk past on either the beach or the path.

I run on manly beach and feel there are already way too many courts as they seem to set up as many as they like. They take up the whole width of the beach and leave no room for others to enjoy the beach. The beach should not be for just volley ballers.

The existing volleyball courts are used only sporadically mid-week. Manly Beach is rather narrow, particularly in the area where the courts are. If additional courts are needed for competition/practice purposes, why can't these be put in at one of the other Northern Beaches? I believe it would be better to establish a second venue that could be expanded as needed, rather than continue to add courts on



Manly Beach. I object to extending the footprint of volleyball courts on what is, after all, a public beach used by many others.

Absolutely not, during the summer months they put up other temporary courts that take up the whole beach pushing other beach user out of that area

The beach is already too busy with volleyball courts. When there is less sand or higher tides there is little space for sunbaking and relaxing now let alone with extra courts. When you add the number of popup courts that people erect it os a very busy part of the beach and sometimes the steps are blocked and there is no space to lie on a towel

There are already enough permanent volleyball courts .The problem is that there are already out of control balls hitting the general public using the beach. This safety issue will get worse . There is also limited space for beach users at present , it will only get worse with more permanent volleyball courts.

On one occasion My family was told to move by the volleyball players as We were 50 m away from the volleyball courts but kept getting hit by volleyballs . It's not just the courts but also the space where volleyball are being hit to which you breed to consider .

Between the volleyball courts and beach tennis courts they take up enough space on the beach already. Keep manly beautiful and natural please.

The current courts already dominate the beach and do not appear to be fully used all the time. When major competitions are on temporary additional courts are added and that appears satisfactory.

The volleyball courts are already taking up too much of the beach. It's too much exclusivity for volleyball

The beach is for everyone, not these people

Like the old TV show, 8 is enough! I run on the high soft sand almost daily. Volleyball Patrons leave all their gear in the small gap that I have to run past, so I have to dodge all that. They also love standing and chatting in that same small area and rarely move out of the way so I have to duck under the nets to run past. I've been hit in the back a few times as I run past and they spike the ball. There are 8 permanent nets but I have seen up to 12 hoisted with the temporary nets included..., plus the ones who play the other bat and ball game with nets. Far out! Enough!

the beach is much wider to the south and would adjoin the existing courts. The area to the north is cut off from the eisting courts by the storm water flowing across the beach

Our Healthy community requires healthy healthy teams and team sports. More volley ball courts will encourage more mindful movements and less stagnation or depressed emotions. A win win solution.

The Manly ocean beachfront is heavily used on weekends. The beachfront is quite narrow compared with some other beaches, such as Freshwater, particularly around high tide. The NBVA has already alienated a large chunk of the beachfront, so the rest should be left available to the other beach users. Please resist the temptation to have everything going on at Manly Beach. If Council wishes to provide more court space, use on of the other northern beaches that is



not already being "loved to death". This constant growth in use of Manly Beach also makes finding a parking spot along the beach for a surf or swim more difficult.

The courts already exclude a large enough area, taking away more beach from the public is ridiculous. If anything it should be reduced.

The beach is for everybody to use. They do take up a lot of space and will only cater for 8 additional players at a time. I really think the courts are taking over the space that should be available to all.

I'm happy with the current arrangements which support healthy exercise.

However, the existing courts already occupy a significant section of prime beachfront, so I don't support any further extension in favour of a single sport.

I do not appreciate the negative impacts the courts have . Give them 2 more and then they will be wanting more again. Cap it as is. Enough is enough.

The beach is already being taken up with so many courts and it doesn't leave room for the majority of the community to go and enjoy the beach.

Eight permanent volley balls courts is enough. It is easy and quick to erect extra courts when needed. We don't want our beach clogged up with any more permanent courts that only are in use early in the mornings and at weekends.

This will significantly impact the beach space at north Steyne and create even more crowded areas at south steyne. Especially in summer when more tourists visit It also impacts the walk way with balls often going onto the path and nearly hitting pedestrians and spooking animals. By adding courts it is creating greater hazards on the beach and walkways.

It is a good use of the beach and there is still plenty of room for other uses.

Not enough room for the rest of us in summer

The volley ball people constantly bring extra nets with them that they erect beside the existing courts, blocking the entire width of the beach, from the wall right down to the water.

I regularly soft sand run at Manly beach and have to duck and weave under the guide ropes or around the area they have squared off to identify "their" court. I support the extra two courts providing they stop blocking the other parts of the beach so that other people can use it for walking, jogging, etc, without obstacles in our way.

It is wonderful to see so many people enjoying volleyball and using the beach in an active and healthy way. It is also a great spectator or sport. Perhaps we need to clearly understand what are the objections to this proposal? I'd like to know.

A single interest group gets priority over everyone else and permanently? This excludes the extra areas up and down the beach that are also set up, blocking nippers, access to the beach.

I dont see the users giving back to the community- no patrols, no volunteers



Respect the other beach activities such as surf school, Christian surfers and WSL comps

There is lots of volley ball courts and on crowded days there's already lack of space.

To much space taken up already

It's excessive use of public space. No other group is allowed to erect permanent structures on the beach and it serves only a very small group of people

They already take up enough space on the beach.

The beach is public property, as is the water.

If you give all this public space to one user group you should consider all the other user groups along the stretch. The 4 boardriders clubs along the beach do not have sections of the water cordoned off for their monthly competitions. Why should this one group have such space.

I'm sure the boardriders clubs have a lot more community participation than the volleyballers.

Many other groups use these locations for multi- use NBVA already have significant space which serve Volleyball only... keep it open space for more versatility

Other sports using the same space will not be able to continue.

Makes it very hard to run the manly mal club which I absolutely love!!

I am concerned that too much beach is being taken up by businesses like volley ball and beach tennis. They already seem to be spreading out further and further.

I believe the courts take up more than enough space already.

The beach is a public amenity which already has a lot of pressure on it from the public usage, especially at weekends in Summer. More courts are privatising this public space and I am completely opposed to it. There is not much point saying the public can use the courts casually when they aren't used by the Association. When would that be and who provides the volleyball.

Please keep as much of the beach as possible for the public to use as a beach. The Volleyball people already have done very well with the space already privatised for themselves.

Will now permanently take away 350m of prime beach area making it unusable for any other form of beach sports and/or users. This will make parking even more difficult on the beach front and add to congestion.

Has consideration been given to other sports that may like to have access to the sand. i.e. Beach paddle & Ball courts, beach cricket, beach soccer etc... Being public land does Council receive a leasing fee from the Association? No mention in the submission. Does the Association put anything back into the large area they use?

This would take up too much of our public beach for exclusive use by one group. This seems very unfair. The beach should be available for ALL to enjoy. The existing courts are plenty.



There already are a number of permanent courts on that stretch, and apart from certain peak periods (eg lunch times and weekends) are barely used at other times.

For busy periods, and weekend comps etc, a quick and simple solution would be to set up demountable nets and leave the beach as it is to enjoy for everyone at other times

If there really is a need for additional permanent volleyball courts on the northern beaches then surely a different beach such as Curl Curl/ Dee Why/ Collaroy would benefit and would allow residents of those areas to participate (and save on traffic congestion in Manly)

The beach is for everyone. Seems to be taking up a large portion just for volleyball. I would think everyone has a right to use the beach & the portion that is allowed for volleyball at the moment seems fair for everyone.

Not enough beach left for the rest of us!

As a Director of North Steyne SLSC Nippers our kids use the soft sand north and south of the Club to train for their long distance 3km runs. Running to Manly LSC and Queensie SLSC These kids compete at NSW State Champs & Aussies. I do not understand why more permanent fixtures would be erected on the beach which would interfere with our Nipper training? Volleyball has already taken over 1,000 sqm of space. No other Surf Club, Board Riders or Manly Surf School have that much designated space. The beach should be for everyone no space should be a permanent area with preference to one specific group.

At the moment the 3 surf clubs, 3+ board riders and Many Surf School work in consideration of each other. If a Board Riders Comp is on, we do not set up our Nippers near their area. Everyone does the same we share the beach. I understand that this proposal also includes the ability for volleyball to set up pop of nets. This is not noted to be viewed by the Public. What will stop the Volleyball from setting up near the Club where we run weekly Nippers for 400 kids? Who will be the referee in the argument over space? We have special need kids who attend Sunday sessions. They do not like large crowds. We set them up in the same spot every week so the are comfortable and they need routine. What do we do if a pop-up volleyball court has been set up in the area for the special need kids?

This proposal needs to be denied by Council. Please feel free to contact me to discuss further.

The beach is packed- theres plenty of courts already, Leave room for regular beach goers

There are far too many already and they take up a disproportionate amount of the beach.

Too much space taken away permanently from general public use.

The existing volleyball courts take up enough space. The beach is for everyone. Do not create more exclusive spaces

The volley people are cool, but they already have enough space.

Please do not allow them to take more space from other beach goers.

No to new courts.



The existing volleyball courts already take up a large portion of North Steyne Beach. My children like to play spikeball, beach cricket and fly kites in areas adjacent to the courts. If more permanent courts are erected this will impact on the area my family can utilise, pushing us closer to the busy patrolled section of the beach where there is no room to do these activities.

Surf club being impacted for local kids

We have enough already. Every now and again they put up extra temp ones which is fine. Please no more permanent ones up the beach.

Enough already ! It's a very small. Minority and mostly used by no residents

The already have plenty of beach space!

In Australia the beaches are public space - for everyone - and exclusive use shouldn't be given to any group, company or individual. Fine to give them the right to set up portable nets but not exclusive use.

If it's northern beaches volleyball, other beaches should be used for courts, they already have enough space as is

Beach volley ball has a huge portion of the beach already, no other community sport has the luxury of such a stake on a public space permanently so why do they need more? The beach needs to be available for all especially now with a big chunk of queescliff unusable. North Steyne boardriders uses this area monthly for their local comp in summer when nippers is on this would give them no where to run their competition.

Beach should remain natural for general use not dedicated to specific sports

I feel they dominate such a valuable stretch of beach for locals to move away from the main areas near the corso. On top of these permanent nets you have all the portable ones that are also put up right on top of other people enjoying the sand. It's too much to add anymore.

The volleyball courts already take up enough of the beach that others want to enjoy. Plus all the temporary courts that are erected throughout summer

This is taking away public beach space from the people who pay taxes and council rates. Are these people tax/ratepayers? I am! They are intrusive and take away from the peace if the beach. They have their soave. Please keep them contained to it.

They already dominate that whole section of the beach so there's no space for anyone else when the tide is high. This area of the beach is between the flag sets so ideal for the kids to surf and for local families to hang out and watch them. They should use the existing ones for official lessons at more times rather than taking over more of the beach.

I think there is already an excessive amount of space dedicated to volleyball courts. Already significant space allocated to volleyball

I don't believe you will stop at 2 more

There is sufficent capacity with existing courts.

They have enough volley ball courts and they are rarely used after 10am. They also obstruct the beach and during summer when we are sitting down there with the family balls are flying everywhere.

Plus it takes up too much room on the beach

The beach is a heavily utilised public space and its being taken over by a relatively small group of people for volleyball. Kids, tourists etc including nippers, swimmers and surfers and their parents and family all want to use the beach and the space taken up for volleyball is very disproportionate to the total beach going community. Strongly opposed to more nets.

I have nothing against beach volleyball per se, but I find it incredible that the Northern Beaches Volleyball Association thinks this application is reasonable. They have already taken up a significant section of a PUBLIC beach for their private use and the constant assertion of a real ownership mentality around this entire section of beach is as breathtaking and concerning as it is arrogant. Their presence is already excessive and it has compromised access for every other beach goer, resident, visitor and rate payer.

Surf club activities and training for both nippers and adult surf club members are already compromised and so is beach soft sand running and walking.

Compounding an existing problem makes no sense and given the already generous (excessive to my mind) allocation of public beach space to a private operation, I cannot for the life of me see this as anything other than an audacious and improper attempt to take over a beach that is there for everybody to enjoy equally. This is already so unequal as to be raising some serious questions about how the number of permanent courts that already exist were ever allowed to go ahead.

I have been a rate paying resident in Manly for the past 17 years and I am raising two children in Manly. We love Manly, we love the beach and we love seeing people living an active lifestyle and loving the special place that Manly is. But enough is enough with these volleyball courts! It's outrageous and unfair.



I believe the beach is for everyone to enjoy, not just for beach volleyball! The number of courts there now is sufficent. Plus we have future LifeSavers ie Nippers, who need an area on the beach to train. Where will they go if the majority of the iconic Manly Beach is reserved for one sport.

The beach is for everyone. Permanent volley ball courts already have too much exclusive use of Manly Beach.

The courts already monopolise a lot of the beach

It's a public beach and they already take up too much room. Instead of adding more permanent courts, you need to police the dozen makeshift ones they set up everyday!

It would be nice if we could book the courts for a family game. The current system of winner stays on is too intimidating for our family

There are already plenty of volleyball courts. I think the current court allocation is fine. Additional courts would start impacting other beach users.

The parking for locals (and anyone in general) will be an absolute nightmare. The beachfront cannot deal with anymore congestion. Then in summer when you have nippers also taking over the beach, it will be a circus down there! There are currently enough courts for them to rotate.

They take up enough of the beach already

As a resident of Manly Council areas since the 1980's I think it is high time Council supported sports other than soccer. Over the past decade tens of millions of dollars have been lavished on field sports with limited co investment. This very minor investment will allow users of all skill levels access, take a very small and generally unused portion of the beach and add to the character of Manly.

They have already enough space now

The volleyball courts already take up a large amount of the beach.

The volleyball courts are taking over the beach and make it difficult for ordinary beach goers to enjoy the beach in peace without loud music and balls flying everywhere. Set some courts up near the queenscliff clubhouse. There is a large amount of unused sand there.

Also some have taken the liberty to set up portable courts all way to shore & near Corso. Additionally, sand had to be kept level for these unsustainable courts. Beachgoers can't relax and enjoy the beach peacefully near the courts due to noise, loose balls & overcrowded showers. Leave alone trying to access the stairs with some of the volleyball players using stairs as social benches. Please keep part of the beach for peaceful leisurely enjoyment for all, instead of turning everything into commercial gain.

It is stopping other activities from happening. Volleyball is starting to take up the whole beach and is keeping locals away on weekends.

The beach will feel too cramped

The current beach volleyball courts are a sufficient amount of public space which is dedicated to this activity. Giving further volleyball courts is an open invitation in the future to ask for even more public space to be allocated to this one activity to the detriment of other beachgoers. Please note it's not just the court space required - no member of the public can safely sit on the beach anywhere near these courts when they are being used. the courts are a widely used facility and do no disrupt other's enjoyment of the beach

Existing courts are sufficient & are already taking up too much of the beach. There are also inadequate facilities i.e, showers, toilets & parking. Please don't turn Manly beach into a Venice beach, USA.

Will the NBVA have priority use of all the courts over the weekend? Will non NBVA always receive lower priority than that afforded to the NBVA?

We come to beach for quietness— peaceful time! Not to hear- noise, and people jumping up and down from 6 am till 6 pm.

Good to see the beach being used and people staying fit and healthy outdoors in particular young people. Sunbakers and families don't tend to sit on this part of the beach. However - need to be cognisant of where surf comps are set up.



If you have to have more then put them in front of the Corso so the tourists can watch them play. They make the beach look ugly and cramped. North Steyne is a calmer, more quiet part of the beach and we would like to keep it that way. You can also put them at Dee Why/ Long Reef stretch of beach. Plenty of room up there.

They want exclusive use of over 1000 square feet of the beach. Is that fair? They block the path of beach runners that have been soft sand running for decades.

There arent enough parks as it is & this will make it worse.

In summer, the beaches are packed with families, this will lead to over crowding. They have enough as it is, there is still balance between beach gowers (swimmers/surfers/lifesavers) runners, walkers etc etc.

This will cause bad blood between locals & visiting vollyballers.

I do not support additional courts because they already have a lot of existing courts there which draw crowds and noisy groups that dominate this beach and adversely affect the peaceful enjoyment of others using the beach.

Beach is already overused Lack of parking

Organised recreation for a few rather than casual recreation by the general public

On the week ends if my family wants to lay on the beach at mid Styene and relax you cannot because the volleyball courts take up most of this part of the beach and sometimes the volleyballs can become aggressive balls flying every where and manly should be a family beach.

Beach volleyball as a community sport is becoming more popular and the existing courts are in use most of the time. Adding two more courts will benefit the community as well as reduce the need to set up portable courts. The proposed area for the courts is not frequented by beach goers, therefore there will be no negative impact on tourists and other beach users.

Volley Ball is already a significant presence on the beach that impacts on beach access and use. If allowed to expand further it'd deter my use of the beach because it is so dominant.

Environmentally, displacing users along the beach front will put further pressure on the small areas of vegetation present along the beach as the are forced to relocate. These areas were very successful in retaining sand during the recent beach erosion and are the only habitat areas on the sand. Any change of use that causes these areas to disappear should not be allowed.

It should be preferable to distribute this activity along more beaches. This would spread the impact on parking, access and crowds at the beach and provide more opportunities for those who can't travel to Manly.

Additional volleyball courts will interfere significantly with the ability for other members of the community to use and enjoy the beach. Currently, dozens of temporary volleyball are erected. These often take up all of the level space on the sand, right up to the high tide mark, where the sand drops away. This inhibits walkers, surfers and runners from being able to move around these courts. Additionally, the surrounding space is unusable by people wanting to enjoy the beach, given that balls are often projected off the court. Volleyball courts already



take up a significant portion of the beach space, proposed additional courts are excessive and inconsiderate to other members of the community who wish to enjoy the beach.

It is a great sport and beach activity and would be lovely for more people to be able to play

they wont effect any beach users & why not provide a better amenity for active sport peoples

There is already far too much commercialisation of Manly Beach. Why can't Council rent out space on other beaches? In Summer you have beach equipment rental, volleyball courts and surf rental businesses stacked along the beach.

It's ridiculous they take up way to much space already. The beach is for all to enjoy

This was have a negative impact on our surf club area. Manly Malibu Surf Club has been running for decades opposite Carlton Street and the proposed new courts will take over our space. It will be a big disgrace if this goes ahead.

They already have a huge amount of the beach and promenade where people stand to watch them. These two more courts will be in a popular surfing spot and also where the Manly Malibu Boardriders hold their monthly competition as well as other surfing groups hold theirs. Surfers will have to take a huge detour to get to the water. For safety reasons as well if a rescue had to be performed another huge to detour.

Spread the load to other Northern Beaches LGA beaches. It will be too congested on the footpath adjoining the beach to have so many courts in one area. It will also take up too much room on the beach,

It get crowded around the field. It also make it harder for surfer to cross from the walkway.

And the atmosphere is different around the volleyball court it's nice but still like to keep the surfing culture on most of the beach.

I don't think that we need more volleyball courts. More often than not they are not used to their full potential except after 5pm weekdays and in summer holidays/weekends

It's not just about the space they take up but the surrounding beach area that is lost from beachgoers not wanting to be close to court due to rogue balls, sand being kicked up, occasional bodies falling out of space.

I see a surfing group always getting moved along or needing to cancel to allow other events. I see more people wanting to be part of these groups/clubs than play volleyball which seems to be more of an International backpacker cohort

The beach should be for everyone, not just volleyball players. They have already taken up enough space on the beach for one select group.

This area is very popular for surfing - as awesome as volleyball is I'd say there is a high amount of foot traffic with surfboards crossing the beach there.

I believe the current generous allocation is more than fair.



There is already a large area taken up by volleyball courts, there has also been a large number of temporary nets being put up which reduces the beach use for others.

Totally behind the healthy lifestyle culture on the sand as it brings son many benefits socially, emotionally and physically. I suggest this lifestyle gets spread out to other beaches within our council. There is so much focus in Manly, but Collaroy and Narrabeen have lots of space to play sports. We play Beach Tennis here and are a community of 100 players and growing. Every weekend and some week days we set up our own private nets. Collaroy Beach has now turned in to the busiest beach tennis place in Sydney. I believe whilst Manly is the home of Beach Volleyball we could be the home of Beach Tennis. Posts and size of the court are exactly the same and the only thing that changes is the height of the net and the size of the squares of the net. In fact, it is possible to fit in more Beach Tennis courts than Beach Volleyball courts in a space of sand since you only need another metre on either direction of extra space for Beach Tennis courts. Manly beach (North Steyne / South Steyne) are public property - and we must fight to keep it available for the public use. As a community, Manly assigns a very high value to health and exercise - and we welcome visitors from around Sydney and the world to enjoy our natural surroundings in a respectful fashion. This proposal offends that principle.

This proposal effectively privatises nearly one third of the beach. For the customers of NBVA only.

Every weekend NBVA currently take full ownership of the 8 courts and their surrounding areas, they then erect a further 8 temporary courts - and make it so that only NBVA can use any of that enormous section of the beach, Sectioning off the area entirely - from the wall to the waters edge.

Beach Vb is a safe, healthy sport that provides manly with a community activity that is both fun to participate in and watch. The additional courts will help cater to the increasing demand.

This part of the beach is far from the surf club and difficult to patrol, so would help by keeping sunbathers closer to the surf club patrol areas when they go in for a dip.

It's great to see some healthy outdoor exercise options for our local kids, keeping them occupied, active and engaged in a positive way.

It would be great to see many more future world and Olympic champions being produced from our local grassroots sports clubs.

I don't ply volleyball but I love seeing the teams playing and I think it's a great, easy facility to offer to everyone

Manly beach is becoming dominated by organisations charging people to participate in sport. This plan benefits a single company and a relatively small number of locals who are their paying members/customers and negatively impacts the community at large as it reduces access to a recreational area that should be freely enjoyed by everyone. The suggestion of the courts being available for casual use by the community is extremely misleading as that company uses them constantly.

Manly beach is not only a beach for locals but we want to encourage tourists and day trippers from the city to boost our economy. Tourists want a beach not another volleyball court they can't use because they're not members. The beach should be free to be enjoyed by everyone. In summer it is becoming increasingly difficult to find a spot to just sit on the beach. The vollyballers take up a large part of the beach as it is and even use temporary courts but at least those are currently erected in the same area. When you also consider the space the beach tennis club and the beach chair hire areas it is becoming a joke.

Given the recent decimation of Queenscliff beach and the prediction that these weather/tidal events are set to increase it seems unwise to effectively cordon off



more parts of the beach for the exclusive use of private clubs. It is sending the message that the council isn't doing things in the interest of the people they serve but in the interest of filling their coffers.

That area is used by the local Malibu club and would interfere with there monthly comps, they're been on the beach for over 30years. They currently put up temporary nets up to 24 I've counted at one time) in that area and they take over the whole beach and there no space for the public use, they are more of a pain then a benefit, to the local community, they get in the way of other public users. They also take take over the Boardriders dates/competition as they have additional competition which conflict with other local events like the Snowy McAlister, the Cole Classic, and Manly SLSC. It's not fair they take over so much public space on a regular basis, it should be distributed evenly with other local sporting clubs

Extra courts will only worsen the traffic and parking congestion in the area. It's difficult to find parking anywhere near home on a weekend.

Manly is getting more and more crowded with different activities - surfing competitions, volleyball, music events, long boarders comps... - those of us who moved here many years ago also love Manly's 'quiet' times'. Does everything have to be about making money and getting more and more people here? Why not spread the joy and have it at another of our many surrounding beaches? Dee why, Long reef? Palm beach?

I work in aged care and run falls prevention classes - older people are telling me how nervous they get when walking on the paths along Manly Beach now because of the excessive activity, and particularly during an event such as now with the Surfing comp when the walking path is closed so everyone is crammed onto the one path. Thank you

There are too many organisations, trainers, carnivals etc using the beach,parking, polluting and destroying natural habitat. Council should protect natural beauty of beach and surrounds. There are already enough volleyball courts.

They have more than enough space and it can be intimidating being on the beach near the courts.

Outdoor activity is so positive and should be promoted.

I support the application 100% and I have never played beach volleyball in my life!

I know numerous local residents that do not enjoy balls flying around beyond the actual court area, there are often instances of music being played aloud, and the "warm up" area encroaches well beyond the court vicinity.

. I'objected on the basis that the beach should be open to all and no one party should be allowed to set up permanent structures on the community space. There are many other sand areas on adjoining beaches and coves that are less trafficked and conspicuous that could be utilised. Would be fine if the proposed nets were public nets that aren't taken for classes and are used as a first come first serve.

The volleyball crew already have acquired approximately 15% of the available beach space year round. Leave the rest for other beach goers and recreational activities.

Plus it's a bit of an eyesore already.

Far to much of the beach taken up expanding the courts. There is no reason to expand when they are empty for most of the year especially over winter. How much rent are they paying to take up nearly two blocks already and from the new drawing the expansion would take up three blocks from Carlton street down to Raglan

There are already enough courts on the beach and there has to be space for visitors to relax and enjoy a patch of sand. With beach tennis in Queenscliff the space is already at a premium.

That area is used by local families and tourists, especially during the summer and autumn months.

The beach should be there for all to use. There is already considerable space allocated to volleyball courts on Manly beach. Manly is one of the busiest beaches in Sydney - it seems over the top to carve out yet more space for one sport, to the exclusion of other beach users.
Thus part of the beach is hardly used by sun bathers or other people. Two more courts would help to find a court during peak play times. It would also be helpful to implement time restrictions during peak hours.

A beach volley ball court measures 8 meters wide and 16 meters in length . Additional surrounding space is also required. Therefore the existing 8 courts allocated already take up an area of well over 1,024 meters. The additional 2 courts proposed will mean that in excess of 1,280 meters will be permanently and exclusively allocated to one group. Unprecedented. These nets will not stop Individuals associated with NBVA continuing, as they have done for quite some time, erecting nets all along Manly beach. Often from the wall to the high tide mark. Disrupting community sports groups and individuals running and walking along the beach .Manly Beach cannot be treated as a football field. Unlike football, netball or any other team sport once the volleyball game is over the field does not become available to everyone. Considering they are the only permanent structure allowed on an already busy beach there is no need for additional courts that will be taken over on weekends by the volleyball association.

The only time that the public will be able to use these courts will be when the volley ball association is not which generally means middle of the day at lunch mid week when there is already plenty of courts available.

This is an unfair use of space which will increase density of beach goers, which given the current Covid issue, is not a good idea.

Council should also consider opening up some off beach areas for this growing community.

I live close to Manly and also play beach volleyball, so that I think it's a very good idea to have a couple of extra nets.

With most beach goers staying near the ends of the beach (the Corso and Queenscliff), the proposed site takes advantage of an underutilised part of the beach.

Manly is a center of sport. From competitions for rowing, surfing, nippers, and volleyball, there is always something exciting going on. These events always keep people interested and engaged with the beach. Many people stop and watch tournaments or even friendly games as the excitement and athleticism are contagious. With the current shortage of nets, people are leaving to go to other beaches. This challenges Manly's identity as the home of Sydney Volleyball and would be a great loss to Manly.

In addition, most players will spend time and money in Manly before, during and after games. Wether it is the early morning coffee and bowls to get started, a mid morning smoothie to break the heat, a nice lunch after a tough set, or some beers at the local pub to talk victories of the day. Having volleyball players on the beach inevitably turns in to more people in town.

Currently there are not enough nets for all the players. Making additional capacity is the right way to continue to encourage people to engage in this fun and healthy exercise and continuing Manly's tradition as the best sporting beach in Australia.

Great idea. The volleyball community is a lovely mix of ages, genders and nationalities. I'm not aware of this stretch of sand being used by any other regular groups, and each court takes up only a relatively small area.

My only suggestion is to ensure these courts are available for the general community, not just NBVA schools. Of the existing 8 courts, 3 (courts 1, 2 and 3) are already effectively permanently booked by the NBVA for paid classes while court 8 is mostly booked for private training groups. That only leaves 4 for general play. We have to manage a balance between training and playing. There's no point in encouraging many more players - without allowing them space to play.

I suggest that the new courts can only be used for paid training for a maximum of 3 hours per day - and are available for free use outside this.

Attendance at tournaments organised by the NBVA has also increased significantly, with all 8 permanent courts plus nearly as many portable courts being set up for them, over multiple weekends, just to accommodate all the players wanting to play competitively. But also socially, the courts are used a lot and the impact of having recently had so much of the beach, and thus most courts, swept away has been significant. Two extra courts on a slightly different section of the beach, as suggested north of the pipe, would also help lessen that impact and allow people to more easily partake in this wonderful sport, as not everybody can afford to buy and carry around a portable net.

Additionally, I believe it would be good to have more floodlights installed for the current and future courts as well. Currently, it is only possible to play on two of the courts once it gets dark. Considering that other sports like cricket, tennis, rugby, soccer, etc. are all able to have floodlights in Manly at their sporting venues, I believe it more than justifiable to have the same for the beach volleyball courts.

On top of the obvious advantage that more courts bring to the players, I believe it adds to the beach itself, as many people walking along the beach side boardwalk end up taking a break and watching parts of beach volleyball games when they are played. So, even to those not participating the community brings joy and displays of goods sportsmanship.

Lastly, I would like to highlight the success of the NBVA Junior's training programs and add that a couple more courts would mean that that would be more easily accommodated, or could theoretically even be expanded without other "adult" players losing courts for it.

Being active is so important and this part of the beach is not widely used by other beach goes. So more volleyball courts are a great idea

### Quiet Stretch gone for good

The dedicated volleyball area as per the council boundary regulation is north of the steps in front of the Manly Pacific Hotel at Raglan Street and south of the steps at the end of Carlton Street steps - so the two new courts are within that council boundary, but this proposal does mean the loss of a relatively quiet patch of public beach between the noise and crowding of the volleyball courts, and the crowds at North Steyne surf lifesaving club.

## Exceedingly generous

It should also be remembered that this patch of beach is only now user-friendly because of the recent lengthy and no doubt expensive remediation work done to fix the ocean drain. To hand it to a single sport does seem exceedingly generous given all ratepayers paid for the remediation.

It would also be instructive to know if any other popular city beach in Australia has permanently gifted such a large area of public beach to one sport?

# The major problem is people ignoring the council boundary regulation and setting up their own temporary courts

The permanent courts are not the real problem on the Manly to Queenscliff stretch – the real problem is that parties think they can set up their own temporary courts south of the boundary steps towards the Corso, and north of the Carlton Street steps all the way to the North Steyne surf lifesaving club. Full <u>beach volleyball</u> kits are now inexpensive and parties of players think they have the right to place their courts anywhere - and the rest of you can get stuffed.

Last summer it was not uncommon for volleyball courts to stretch all the way north from Carlton Street to the North Steyne surf lifesaving club. (I am told there is a similar problem at Queenscliff bu cannot verify this.) Having volleyball courts encroaching towards the Corso is especially egregious a they "claim" the ground and surrounds for hours on end.

While on patrol for Manly on a busy summer Sunday a fourth court was being erected in front of Th Pantry and in the middle of beachgoers. I explained to the people putting up the court that the council boundary was north of the Raglan Street steps but was told the "*F-off and go save some people*". (I did save two tourists later that afternoon...)

Taking the space for hours, indeed entire mornings at a time, on one of Australia's most popular anbusy beaches is the height of entitlement and the boundary must be enforced.

Regular beach goers and users are fed up and visitors will skip Manly and go north to other beaches where they can enjoy themselves and avoid the hassle.

One need simply walk down to Manly Beach mid-morning on a sunny day for this to be confirmed.

# Additional volleyball courts proposed at Manly Beach

Ref: 2021/808160.

We <u>do not</u> support the request made by the NBVA for an additional 3 permanent volleyball courts on Manly / North Styene beach, between <u>Steinton</u> street and Carlton Street.

There are currently 8 permanent courts and, on most weekends, weather permitting, NBVA already install as many as 6 additional "temporary" courts along the beach blocking off a significant area of the beach from other beach users.

In addition to the NBVA courts mentioned above (as many as 14) there are often between 3 and 4 courts set up by casual players/families in the area you have indicated would be given over to the NBVA for additional courts. Giving NBVA the area between Steinton street and Carlton Street would force these casual users to move further down the beach further reducing the beach area for casual users' ,swimmers and sun lovers.

We don't understand why the NBVA does not expand its footprint on the Northern Beaches (it is **Northern Beaches** Volleyball Association after all) to say Freshwater, Dee Why or Collaroy Beachs as many current players come to Manly from those areas.

Lastly, as NBVA is a commercial enterprise, in that it charges fees to its members to use the courts and for training. It would be interesting to know how much the NBVA contributes to the councils cost for maintaining the courts.

We don't believe Manly/Northern Beaches residents' rates should be used to support this commercial enterprise.

No more of our beach should be given away permanently to special interest groups. No extra permanent courts should be placed on Manly beach.

Volleyball and other sports courts set up on Manly beach outside the permanent court area are a rapidly growing problem, and directly related to the permanent courts already installed.

This is due to the attitude and behaviour of random players setting up those courts, outside the designated area. Most of those people are not from Manly.

It was precisely to prevent these issues that Manly Council had a ban on volleyball and court sports being played on the beach outside the set zones, except with a Council Event Permit.

I note strongly that the members of the local volleyball association are not the issue with either behaviour, or attitude towards the general public. For the most part, they are aware of, and appreciative of, the huge area of beach permanently alienated from the general public for their use.

I was on the Manly Council Sports Facilities and Coastline Management Committees from 1999 to 2010 inclusive, so was involved in the process of establishing (and limiting) the area allowed for volleyball on Manly Beach.

Here is an overview of why the courts were set up, and how the situation has been allowed to deteriorate:

- The 2000 Olympics had Manly athletes involved, and a small set of permanent volleyball courts were set up around that time. They started north of the steps onto the beach, opposite the end of Raglan Street.
- Several years later, a request came to Council for an increase in the number of permanent courts.
- After vigorous debate in the Sports Facilities Committee and Council, it was agreed that
  additional courts would be placed to the north of the existing ones, with several binding
  conditions. Those included NO additional permanent courts would ever be requested or
  provided, and that any other courts could only be set up with Council Event Permits for major
  tournaments. NBVA agreed to that generosity from our community, and gave their word they
  would never ask for more. Guess they can't be trusted.
- To further assist the volleyball players, the Sports Facilities Committee enabled lighting, plus the repurposing of a Council cleaning equipment bay on the roadside for volleyball equipment storage.
- It was also strongly noted, at the time, that the permanent volleyball courts would alienate a
  greater area on the beach (on an annualised basis), than ALL surf life saving activities by the
  3 clubs on the beach, including patrols, carnivals, Nippers and training. In other words,
  volleyball in the area allocated back then, used more beach than surf life saving, without any
  real return to the community, plus the permanent volleyball area could not be used for any
  other purpose by the beachgoing public.

Each court needs a footprint of approximately 450 square metres, for only 4 people. That includes the court area itself, plus a further area at each end and side for safety margin from players moving outside the court during play, and for volleyballs hit at high speed which are not stopped by the players inside the court area.

Two years ago, following increasing issues with volleyball and other "court sports" impacting on other beach users, NB Council management actually INCREASED the allocated area of use from



approximately 6,000 to almost 25,000 square metres. (Please refer to the attached current SNB Council map.) To put that into a familiar area, it's nearly 5 football fields of iconic Manly beach now – allocated to single use, every day of the year. It also equates to almost 20% of the entire beach. – No other beach user can safely or peacefully use any of the area for passive recreation.

What would your response as a Councillor be if someone came to a Council meeting, and applied for permanent exclusive use of 5 football fields of our <u>world famous</u> beach for another sport? And then went ahead and used even more without any sanction from Council?

Until the Council amalgamations, Manly Council lifeguards enforced the "no casual court sports" policy outside the established area. Since amalgamation, the policy has not been effectively enforced, – as there has been no proper guidance to this effect from the new amalgamated Council. The result:

- Increasing numbers of volleyball courts are being set up on the beach, alienating an increasingly greater area of the best beach in Australia.
- Other beach users are being threatened and intimidated by people who set up casual courts.
   This includes verbal abuse and threats of harm, plus having volleyballs smashed at people nearby if they refuse to move away.
- Access to, and along the beach is being affected, with no clear path for the many beach runners and walkers who used to enjoy the length of the beach.
- Beach users are being injured when impacting pegs and spikes used to hold the nets of the casual courts, including those left behind after a casual court is taken down.

Hopefully this information is of use. I am tired of copping it off people for my support of the volleyball, just because the new Council and bureaucracy don't have a handle on managing Manly Beach, which is massively busier than any other beach in the area.

Our beautiful beach used to be for everyone. How can it be good for Manly to lose more of it for ever to special interest groups?

Council needs to enforce the rules set by the previous Manly Council, and agreed to by the local volleyball players and the local association. Council lifeguards should be directed to enforce those rules on a permanent basis. It is likely some signage on light poles above the beach may assist.

I have been informed by a Council employee that lifeguards are under the following instruction regarding the volleyball area - "We're not enforcing that area."

This means anyone wishing to set up additional court sports outside the <u>massive allocated</u> area can do so with impunity. As a result, even more of Manly beach is now taken up by court sports, on top of the 5 football fields already permanently allocated.

Another senior Council employee commented to me last week "Lots of beaches overseas have nothing but courts all over them. That's the future for Manly beach. Get used to it".

When asked about that attitude, the response was "Very few of us managing Council live in the area, and most of the Councillors don't live in Manly. We can do whatever we like."

# Re: Manly Beach volleyball courts - additional courts proposal

Dear Jacinta,

We are writing to you about the proposed additional volleyball courts on Manly Beach. As you may be aware for the past 115 years, the North Steyne Surf Lifesaving Club has been providing lifesaving services to ensure the safety of the public on North Steyne/Manly Beach. Our services include the provision of volunteer patrols to safeguard people in the water, the treatment of minor and major injuries, and the taking of preventative actions to keep people out of harm's way. Along with our lifesaving obligations, we run a number of related activities including training to ensure our skills are up-to-date and for competition purposes. We also host surf lifesaving carnivals (competitions), and we run a successful Nippers program in order to ensure a strong lifesaving community for the future.

The proposed location of the new volleyball courts is approx. 280 metres south of our Clubhouse and will be located in our primary and secondary patrolling areas as defined in our Lifesaving Service Agreement 2020-2023.

As a long-standing community based organisation, we support all users of the beach and welcome activities that ensure we have a vibrant and healthy local community.

We would like to raise some concerns we have, however, with the proposed additional volleyball courts.

# Lifesaving Services

The new courts will have a negative impact on the provision of our lifesaving services and increase safety risk.

During the season our flags can be set up as far south as Carlton Street, which is part of our primary patrolling area. Our patrol tent needs to be set up close to the flags to ensure appropriate surveillance and ready access to first aid, CPR and rescue equipment so we can rapidly respond to any incident where assistance is required. Depending on the shape of the beach, the courts could impact the placement of our patrol tent and our rescue equipment.

PO Box 310 Manly 1655 • Telephone 9977 6180 • Facsimilie 9977 6227 admin@northsteyneslsc.com.au • www.northsteyneslsc.com.au The placement of the courts could also obstruct partial or rapid access by the paramedics to an incident should there be an emergency on the beach when the flags are located in this area.

If the flags are located further north, there is a concern that more people will likely enter the water near the volleyball courts and where there are no flags. We experience this issue every season in front of the current volleyball courts as people seem to be reluctant to walk even a relatively short distance to "swim between the flags." Such non-compliance will increase the lifesaving risk. This will mean more consistent patrolling of the area, thus putting extra demands on volunteer lifesavers, and/or may require a second set of flags.

# Surf Lifesaving Carnivals

The proposed permanent volleyball courts will impact how we run our surf lifesaving carnivals, including impacts on competitors, spectators, infrastructure and safety. We are already experiencing issues with the volleyball players who complain about these competitions, even though they have been approved by Council.

During the summer season, Surf Lifesaving Sydney Northern Beaches holds various surf lifesaving events across the 21 beaches. Many of these events occur along the beach front from Manly LSC to Queenscliff SLSC. North Steyne generally hosts between 2-3 carnivals per season. This includes carnivals for Nippers, Branch championships and surf boats. Often the running tracks and water areas are set-up south of our Clubhouse and can extend to the area between Carlton and Steinton Street. This is particular the case with beach events when there are 1km and 2km runs. Already competitors experience many hazards in running in between the volleyball courts (both permanent and temporary) as they must avoid stray balls, enthusiastic players and difficult to see tether lines. More courts will exacerbate this issue even further.

Our surf boat carnival, held every January, also requires a significant area of the beach in order to run a safe competition. With over 70 clubs competing, a substantial area of beach is needed for competitors, beach craft, officials, first aid stations, tents and water safety and emergency equipment. This event also attracts a significant number of spectators who stand on the promenade of beach itself to watch the competition. The competition area generally extends south from our Clubhouse some 200-300 metres and from the waterfront the road. There is no doubt that this carnival will consume the area of the proposed permanent volleyball courts.

Further, the Northern Beaches Council has an agreement with Surf Life Saving NSW to host the NSW State Championships for the next 2-4 years. This event attracts thousands of people from across the State to compete and watch the competition over a period of 3 weeks (Late Feb – mid March). Due to the inclement weather and surf conditions, this year's event was mainly concentrated in front of our Clubhouse and extended over 350 metres south. The current volleyball courts were an issue during the competition and impacted the infrastructure that was required to be set-up (tents for Officials / first aid) and water safety access. More courts will mean more difficulties during this important event.



# **Other Activities**

Depending on the placement of the flags and the conditions of the beach and surf, our training and other activities can take place in the Carlton Street area. This includes lifesaving, competition and Nippers. New courts will make this area very congested, particularly on a Sunday morning, and put additional strain on the lifesaving and lifeguarding services.

In addition to our own activities, the beach front has many other users including the North Steyne Board Riders, Manly Surf School and various bootcamps and exercise groups. The erection of permeant volleyball courts will impact the space for these activities and in turn put pressure on effective and safe lifesaving operations.

# **Temporary Courts**

We would like to take this opportunity to also raise the growth of temporary volleyball courts on the beach which has caused issues in accessing our equipment, the running of our Nippers, disagreements during carnivals and the general obstruction of the beach and water for the public. Temporary courts are currently being erected all over Manly Beach and not just in the adjacent areas of the permanent courts. In some cases, these courts are set-up to the east of the permanent courts and right down to the water's edge, and they have been erected immediately outside our Clubhouse obstructing access to our IRB and rescue equipment. We are concerned that more permanent courts will encourage more temporary courts in the adjacent areas, thus extending the volleyball footprint both north and east and impacting even more on our lifesaving operations, training, Nippers, and Ripper Nipper activities.

We would like Council to better monitor these courts and give the lifeguards authority or have rangers/beach inspectors on hand to request the removal of these courts when they impact on beach safety, our usual activities and the general public's enjoyment of the beach.

We would welcome the opportunity to discuss these issues with you further, and would appreciate a formal response to ensure our concerns are addressed.

# Do you support the proposal for up to two additional permanent volleyball courts at Manly Beach? No


#### Please help us understand more about your choice by providing additional comments

There are currently 8 beach vb courts at Manly. These are well used and occupy quite a stretch of flat beach. I have no objection to the existing permanent courts – they provide important community use and recreation. In addition, there are many other temporary courts setup along the beach in different areas. There appears to be no clear guidelines on whether this is permitted, or where these should be located.

I don't support any additional courts at Manly for the following reasons:

- 1. Manly is already very busy, particularly on weekends and early mornings, and additional courts will just amplify this issue
- 2. As a rate paying resident and local volunteer surf lifesaver, my personal preference is for Manly NOT to resemble a Miami style beach, with courts spread along the beach. The current courts should be sufficient for use in the Manly area and they occupy quite a stretch of flat beach, not otherwise available to beach goers.
- 3. Council should consider courts on **other** northern beaches venues, so other areas share the benefit, and associated burden. We don't have all the NB sports fields or tennis courts located in one location, so why should all the beach volleyball courts be at Manly? The beachfront area is already extremely busy and congested this will only exacerbate the problem for local residents and visitors.
- 4. Temporary courts should be regulated better, if allowed at all. Often these are setup closer to the water line and interfere with amenity of other beach goers. Numerous temporary courts seem to be appearing.
- 5. There has also been a "beach tennis" group starting up at Queenscliff (and advertising) with similar nets laid out across the beach. The precedent for beach volleyball will make it difficult to manage expectations of other groups wanting their share of beach.
- 6. The proposal aims to meet the demand for more courts arising from the increasing popularity of beach volleyball at Manly Beach why does this have to be at Manly? We are blessed with many suitable beaches along the cost spread the load.

The photos attach provide evidence of the proliferation of courts along the beach. Council needs to take appropriate action to better regulate this. I do not support this proposal.

I live at Manly in the building directly opposite the existing volley ball courts Thank you for the offer to express my view about the increase in Volley ball courts at Manly Beach I accept that volley ball is a healthy outdoor sport and somewhat enhances the carnival atmosphere of Manly Beach

However I STRONGLY OPPOSE an increase in the volley ball courts from 8 present courts to10 courts i.e. 25% increase for the following reasons:

NOISE POLLUTION
 When competition games are played the WHISTLE IS BLOWN AFTER EVERY POINT SCORED
 Best of 3 games
 Average score say 21/15 for first 2 games i.e 72 points
 Deciding game score say 15/10 i.e.25 points
 Total points 97 i.e. 97 whistle blows for just one court
 8 courts at present

8x97=776 WHISTLE BLOWS FOR JUST ONE COMPETITION ON EACH COURT

25% INCREASE 10 courts=970 WHISTLE BLOWS FOR JUST ONE COMPETITION GAME ON EACH COURT

Practice often starts at 6.30 am at weekends and the whistle blowing starts at 8am and continues non stop until 5 pm both Saturday and Sunday

This piercing whistle sound penetrates every corner of my unit and prevents me from experiencing the ambience of my own home at the weekend

2. VISUAL POLLUTION
Each court has 2 posts 2metres high to which the net is attached
When play is finished and the net removed these posts stay permanently in place
8 courts 16 posts permanently in place at present
10 courts 20 posts permanently in place
These posts visually pollute the area and give the impression that it is a CONSTRUCTION SITE and a NO GO AREA to beach goers when the courts are not in use

3.EFFECT ON ADJACENT BEACH AREA When play is in progress the area of the beach between the court boundary and the water's edge is adversely affected

Beach goers DO NOT USE this area because of :

1 the nonstop whistle blowing 2 stray volley balls impact on this area as does players chasing after the balls

So in actual effect the volley ball courts utilise the whole area from the sandstone wall to the water's edge

So that a 25% increase in the volley ball area would result in a significant reduction of beach area for the general beach goers

MANLY BEACH as we all know is WORLD FAMOUS and SHOULD BE RETAINED AS IS FOR THE ENJOYMENT OF ALL

If you could please open the above attachment first as it shows that I have had an interest in the Volleyball courts from their installation back in 2004. I live in right across the road from the courts. The courts were put on our beach without any neighbourhood consultation back then, as this was the days of Precinct Committees. The residents along the beachfront are very much effected by the Courts & the invasion of our beachfront on a PERMANENT basis. Could you please explain how a Council can allow 'a business' to rent beach space to run a business? It's called beach volley ball but does it necessarily have to be played on a beach. Why not place sand on a nearby oval or parkland & create a permanent volleyball centre, still in Manly but not on our beach. Over the eighteen years (OMB HAS IT BEEN THAT LONG) the high tide mark has slowly moved up the beach towards the wall of the esplanade. In recent times the courts have been washed away on several occasions & now the high tide mark encroaches on the court base every day. I don't think the courts will be usable on a permanent basis for long into the future. I agree with submission regards the erection of two more courts to our already eight! It's an enormous invasion of our privacy, beach space & the noise created by the business during its lessons, classes & competitions. I might add that when they have enough people making up numbers for more games & tournaments they put up at least another 4-6 temporary courts spreading further north & south to accommodate the extra games. When the courts are in use it makes the beach space between Raglan & Steinton Streets unusable for beach goers & walkers. The distance between the esplanade wall & the waters edge is slowly being eroded & soon there will not be enough space for the courts & beach goers to share the space. Why should the Council give this business the privilege to use our beach at all. Even Bondi has no 'business' operating on its beach

Could Council please consider coming down to observe & survey the area where the volley ball courts are now located & where the proposed additional two are to go? I'm here observing this happening right before my eyes every day & think its a complete waste of time to grant permission for something that is certainly going to be short lived. I was very surprised to receive your notification regards the additions courts because of the fact the the courts have been out of action for so much of this year because of their position & vulnerability to the encroaching seas. #### Re: Beachvolleyball Courts North Steyne

I refer to the concerns you raised about the installation of 2 additional beachvolleyball courts on Manly Beach.

Since 2000 interest in this sport has grown dramatically, due to Australia's high profile in this sport at both World champion ship and Olympic level. Manly is recognised as the official home of beachvolleyball in Australia. In early 2003, the Northern Beaches Beachvolleyball Association tabled a proposal with Manly Council Sports Facilities Committee to increase the number of courts from 6 to 8.

This proposal was unanimously supported and presented to the Ocean Beach Precinct Committee. Various configurations were discussed namely expanding either north or south of the current courts and the distance from the seawall, its impact on general access via the stairs etc.

It was not possible to move all the courts south, as this have infringed on the stairs of to the south. The risk of having the courts to close to the wall of the esplanade, needed to be addressed as a safety issue, resulted in the courts remaining the same distance from the wall as the existing poles. As for the comment that the courts are close to the waterline, this only occurs when we experience high tides.

Council considered the concerns raised by residents and aims for a balance approach and promoting a healthy lifestyle within our community. Only recently, Manly Council (in response to calls to ban ball games on Bondi) proudly and publicly supported our proactive approach to encouraging ball sport/games on our beaches.



Usually the group who lease the space from you keep an eye on the situation & the nets are removed as are the posts when big seas threaten the area. They have a cupboard on North Steyne where the nets are stored, usually during the week when not in use. As you can see the posts are being eroded & will probably get washed out over the next few days if not removed. This is becoming a frequent event with the last one eroding away lots of the sand leaving courts unusable.
