NB Consulting Engineers has assessed the architectural plans prepared by Network Design (dated April 2024) for a proposed new dwelling at the above site address in reference to potential flood issues.

Flood levels have been obtained from council. This assessment has been based on the Newport Flood Study 2019 information and has considered that the development is within the predicted flood extent and flood affected area.

Northern Beaches Council flood management information (refer appendix B) indicates the following:

- Flood Planning Level (FPL) (Max)
- 1% AEP Flood Level (Max)
- 1% AEP Flood Depth (Max)
- 1% AEP Flood Velocity (Max)
- Probable Maximum Flood Level (PMF) (Max)
- Probable Maximum Flood Depth (PMF) (Max)
- Probable Maximum Velocity (Max)
- Flood Category
- Flood life hazard classification
- Provisional Flood Hazard

The proposed ground floor level of the new dwelling (RL 10.30m AHD) is located outside the extent of the 1% AEP flood level and above the Flood Planning Level (RL 9.61m AHD).

Therefore, the development is generally in accordance with Pittwater DCP provided that the following recommendations below are complied with.

Structural requirements

Any new structures are to be constructed of fit for purpose building materials in accordance with "Reducing vulnerability of buildings to flood damage"¹ and are to be designed and constructed to ensure structural integrity up to the FPL, taking into account the forces of floodwater, wave action, flowing water with debris and buoyancy and immersion.



Waterproofing requirements

Furthermore, the switchboard and main circuit unit must be fitted above the FPL. All new electrical equipment, power points, wiring, fuel lines, sewerage systems or any other service pipes and connections must be waterproofed and/or located above the FPL. Electrical conduits must be laid such that they are free draining. All existing electrical equipment and power points located below the FPL within the subject structure must have residual current devices installed that turn off all supply of electricity to the property when flood waters are detected.

Shelter in Place requirements

The proposed floor level (RL 10.30m AHD) is recommended to provide an on-site refuge above the PMF (RL 10.05m AHD). The on-site refuge must have appropriate access installed to enable access points from all areas within the development. The proposed on-site refuge is to be structurally adequate up to the PMF. **Refer appendix A for shelter in place location.**

The on-site refuge must provide:

- Sufficient clean water for all occupants
- Portable radio with spare batteries
- Torch with spare batteries
- First aid kit

If flooding is experienced:

- Evacuate to the designated on-site refuge location
- Evacuate if ordered by Emergency Services Personnel regardless of availability of on-site refuge.

The development is not envisaged to have a detrimental effect on neighbouring properties.







MAP B: FLOODING - 1% AEP EXTENT





MAP C: 1% AEP FLOOD HYDRAULIC CATEGORY EXTENT MAP





Preparation of a Flood Management Report

Introduction

These guidelines are intended to provide advice to applicants on how to determine what rules apply on flood prone land, and how to prepare a Flood Management Report. The purpose of a Flood Management Report is to demonstrate how a proposed development will comply with flood related planning requirements.

Planning Requirements for Flood Prone Land

Development must comply with the requirements for developing flood prone land set out in the relevant Local Environment Plan (LEP) and Development Control Plan (DCP). There are separate LEPs and DCPs for each of the former Local Government Areas (LGAs), although preparation of a LGA-wide LEP and DCP is currently under way.

The clauses specific to flooding in the LEPs and DCPs are as follows:

* The Warringah LEP (2000) is relevant only for the "deferred lands" which affects only a very small number of properties, mostly in the Oxford Falls area.

Development on flood prone land must also comply with Council's Water Management for Development Policy, and if it is in the Warriewood Release Area, with the Warriewood Valley Water Management Specification and Clause C6.1 of the Pittwater 21 DCP (2014). Guidelines for Flood Emergency Response Planning are available for addressing emergency response requirements in the DCP. These documents can be found on Council's website on the <u>Flooding page</u>.

Note that if the property is affected by estuarine flooding or other coastal issues, these need to be addressed separately under the relevant DCP clauses.

When is a Flood Management Report required?

A Flood Management Report must be submitted with any Development Application on flood prone land (with exceptions noted below), for Council to consider the potential flood impacts and applicable controls. For Residential or Commercial development, it is required for development on land identified within the Medium or High Flood Risk Precinct. For Vulnerable or Critical development, it is required if it is within any Flood Risk Precinct.

There are some circumstances where a formal Flood Management Report undertaken by a professional engineer may not be required. However the relevant parts of the DCP and LEP would still need to be addressed, so as to demonstrate compliance. Examples where this may apply include:

- If all proposed works are located outside the relevant Flood Risk Precinct extent
- First floor addition only, where the existing ground floor level is above the FPL

• Internal works only, where habitable floor areas below the FPL are not being increased

Note that development on flood prone land will still be assessed for compliance with the relevant DCP and LEP, and may still be subject to flood related development controls.

What is the purpose of a Flood Management Report?

The purpose of a Flood Management Report is to demonstrate how a proposed development will comply with flood planning requirements, particularly the development controls outlined in the relevant LEP and DCP clauses. The report must detail the design, measures and controls needed to achieve compliance, following the steps outlined below.

A Flood Management Report should reflect the size, type and location of the development, proportionate to the scope of the works proposed, and considering its relationship to surrounding development. The report should also assess the flood risk to life and property.

Preparation of a Flood Management Report

The technical requirements for a Flood Management Report include (where relevant):

- 1. Description of development
 - Outline of the proposed development, with plans if necessary for clarity
 - Use of the building, hours of operation, proposed traffic usage or movement
 - Type of use, eg vulnerable, critical, residential, business, industrial, subdivision, etc

2. Flood analysis

- 1% AEP flood level
- Flood Planning Level (FPL)
- Probable Maximum Flood (PMF) level
- Flood Risk Precinct, ie High, Medium or Low
- Flood Life Hazard Category
- Mapping of relevant extents
- Flood characteristics for the site, eg depth, velocity, hazard and hydraulic category, and the relevance to the proposed development

If the property is affected by an Estuarine Planning Level (EPL) which is higher than the FPL, then the EPL should be used as the FPL. If the FPL is higher than the PMF level, then the FPL should still be used as the FPL, as it includes freeboard which the PMF does not.

- Demonstration of how the development complies with any relevant flood planning requirements from the DCP, LEP, Water Management for Development Policy, and if it is in the Warriewood Valley Urban Land Release Area, with the Warriewood Valley Water Management Specification (2001)
- For any non-compliance, a justification for why the development should still be considered.
- Calculations of available flood storage if compensatory flood storage is proposed
- Plan of the proposed development site showing the predicted 1% AEP and PMF flood extents, as well as any high hazard or floodway affectation
- Development recommendations and construction methodologies
- Qualifications of author Council requires that the Flood Management Report be prepared by a suitably qualified Engineer with experience in flood design / management who has, or is eligible for, membership to the Institution of Engineers Australia
- Any flood advice provided by Council
- Any other details which may be relevant


