Many community members watched the meeting together, unfortunately with Covid 19, this did not come across and have impact of a large community objection.

We do feel for the applicant but we know that there are alternative solutions. Their application will also greatly affect us as well.

We have engaged BBF Town Planners who have provided alternative concepts in its submission, of which Council is in receipt.

Residents requested several times to meet with the architect and owners to come up with design alternatives together, to mediate this matter to a more agreeable solution to all. Unfortunately the owners declined all suggested meetings.

There are 16 properties that show solutions to how a driveway may be developed. These should be explored. An alternative may also to lower public path at the point of the driveway, to lower the RL of the footpath.
