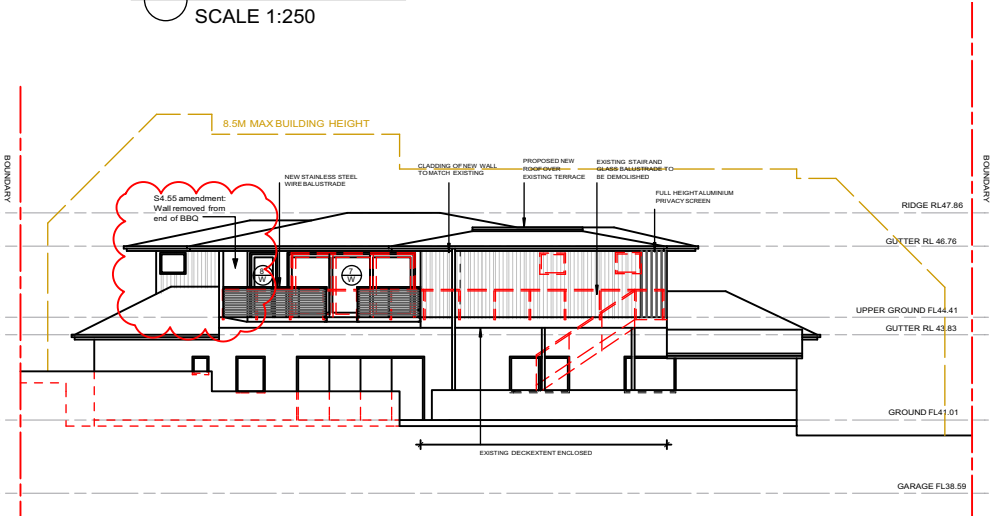
 SOUTH-EAST ELEVATION
