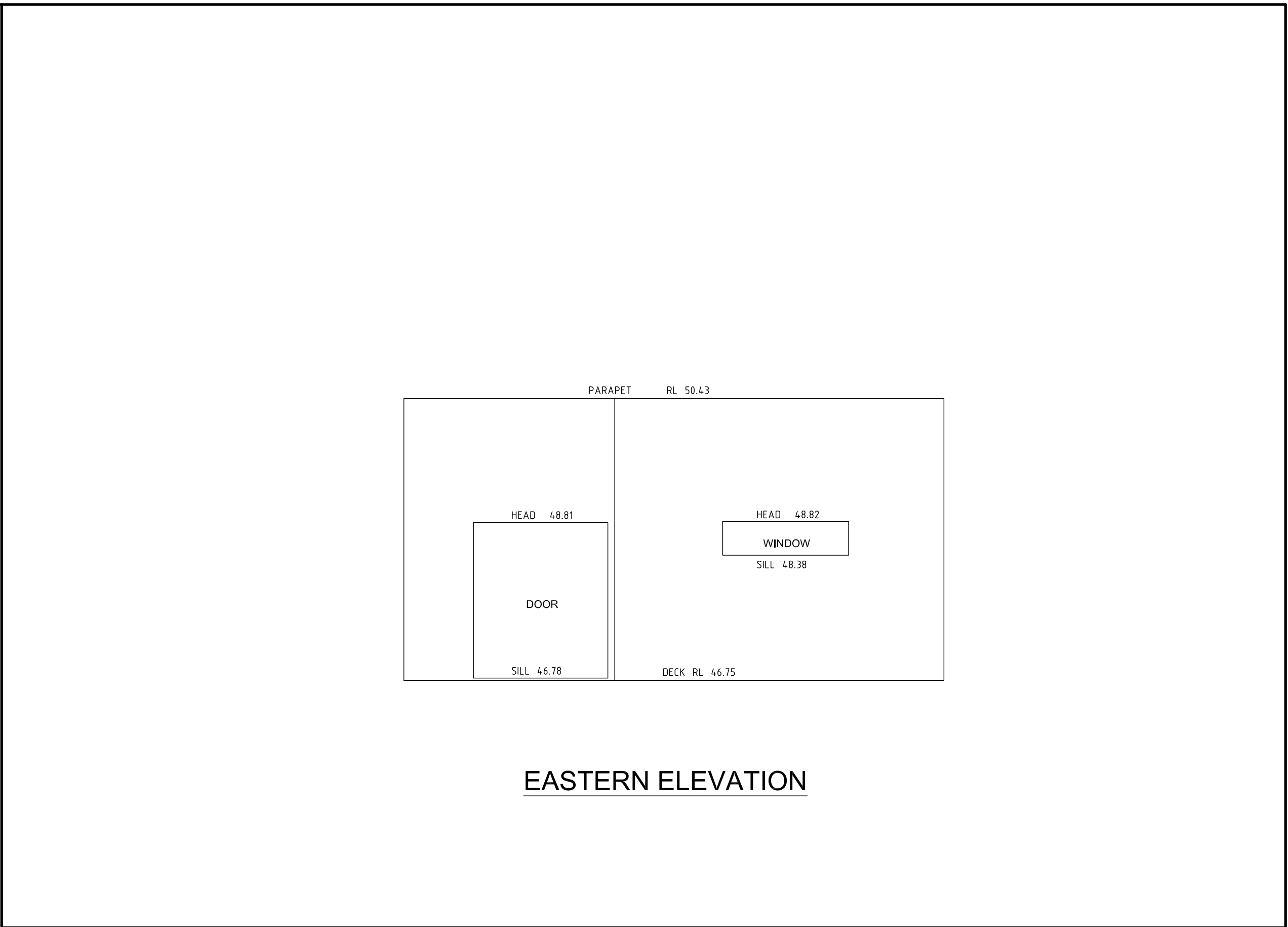




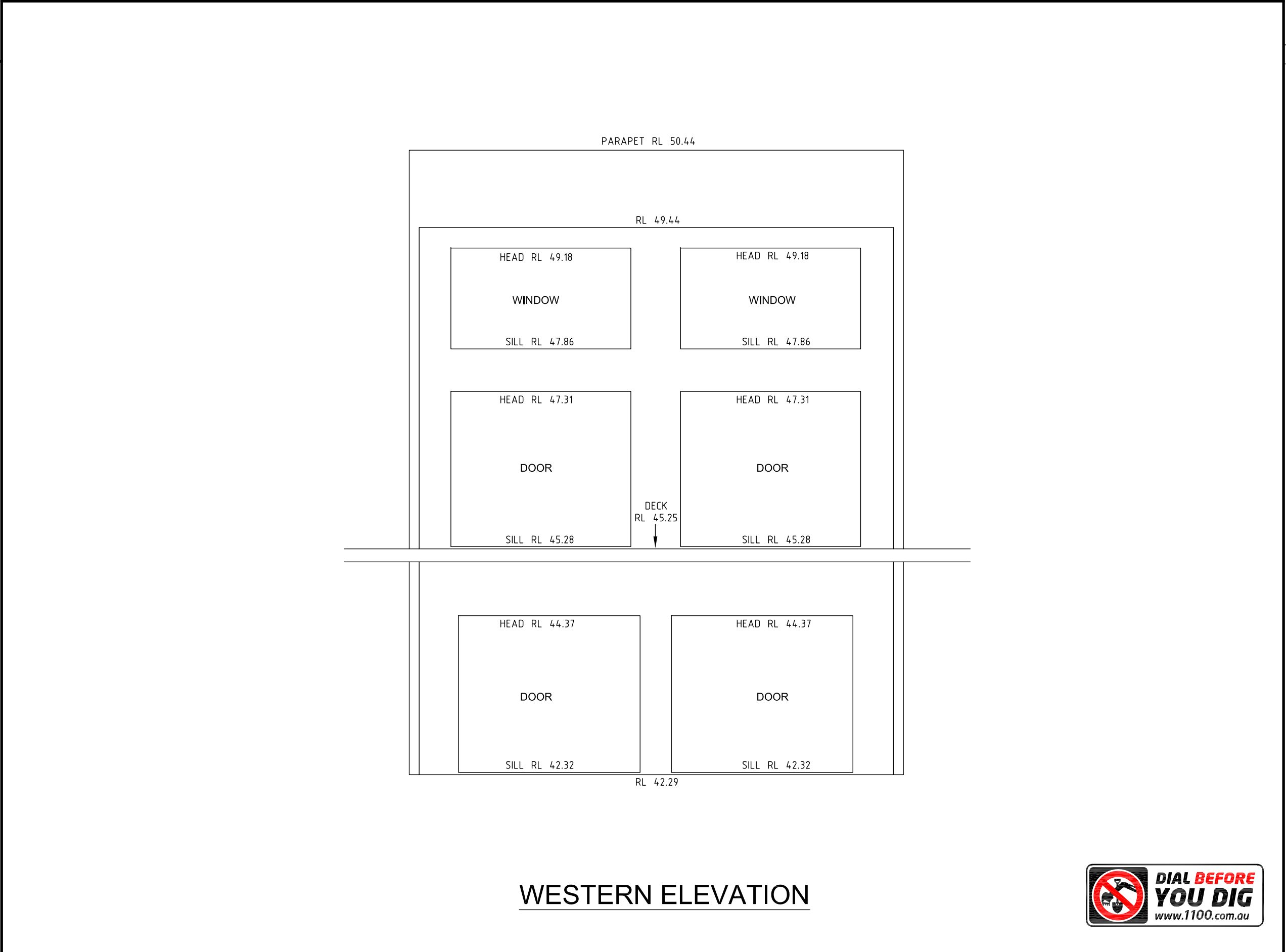
NORTHERN ELEVATION

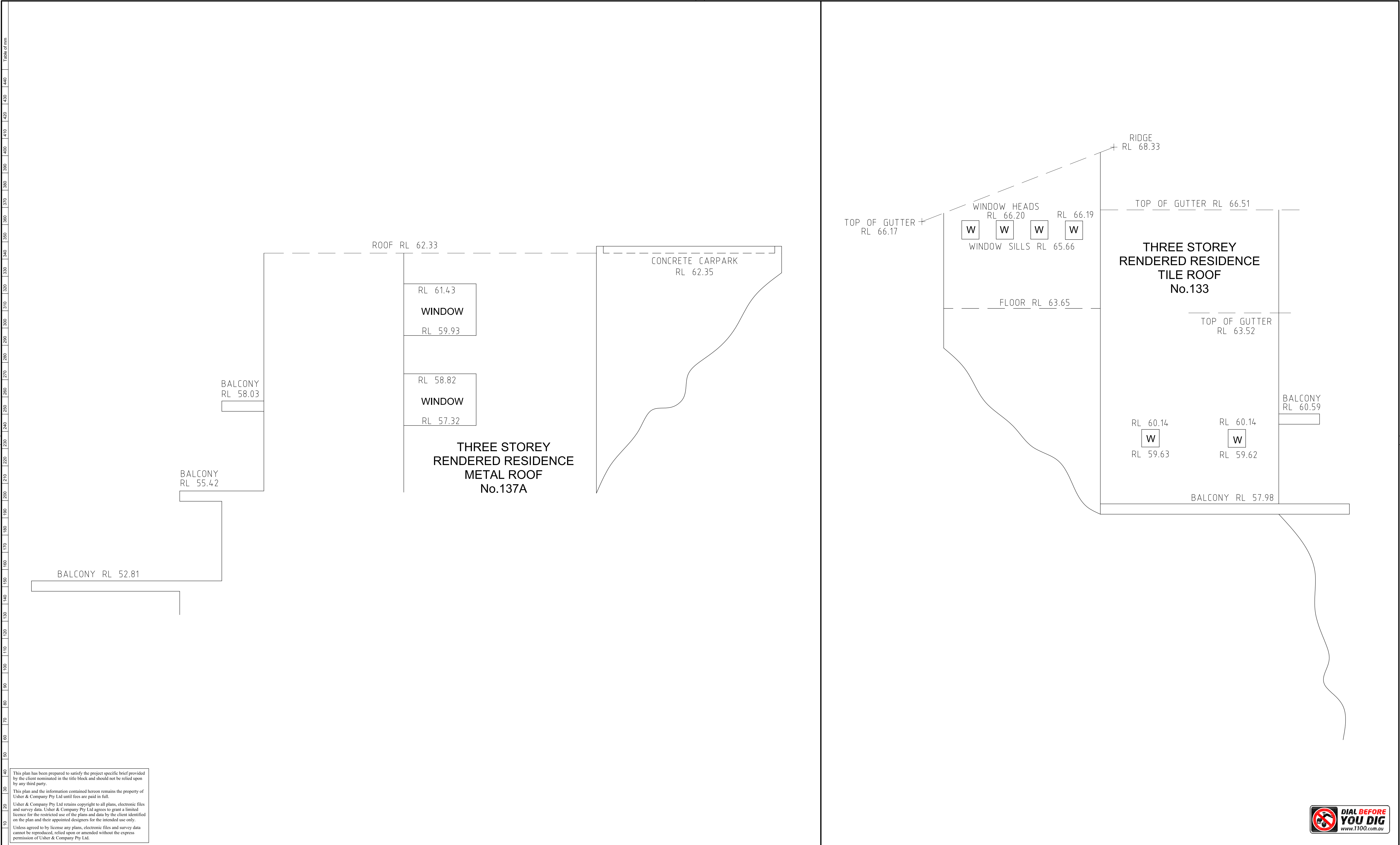
