<b>Domestic Waste (Non-Recyclable)</b>	General waste including food scraps, tissues, etc.	1320 litres	Bins will be provided in the offices and staff-areas of the hospital to allow for separation of food and general waste.	Collected by United Resource Management weekly for disposal.
<b>Recyclables</b>	Paper, Cardboard, Glass, Soft Plastic, Hard Plastic, Metal	1320 litres	Separate bins will be made available throughout the hospital to sort various recyclables. These will be emptied into commercial bins for storage until collection.	Collected by United Resource Management weekly for recycling.
<b>Clinical Waste (Non-Sharps)</b>	Includes syringes, patient waste, drug waste, gloves, paper towels, etc.	1320 litres	Collected in specially marked clinical waste bins.	Collected by Daniels Health Services weekly for disposal by incineration.
<b>Sharps</b>	Includes needles, biopsy equipment, scalpel blades, or anything capable of cutting or penetrating the skin.	20 litres	Collected in rigid-walled labelled containers that comply with AS/NZS 3816:1998	Collected by Daniels Health Services weekly for disposal by incineration.
<b>Cytotoxic Waste</b>	Includes cytotoxic drug containers, syringes, contaminated bedding, gloves, gowns, etc.	55 litres	Placed in appropriate labelled cytotoxic waste bags (non-sharps) or rigid-walled containers (sharps) that comply with AS/NZS 3816:1998	Collected by Daniels Health Services monthly for disposal by incineration.
<b>Deceased Animals</b>	Includes whole bodies or body parts (i.e. from amputation)	60 kilograms	Placed in appropriate, labelled body bags and stored in a secure freezer	Collected by Patch & Purr thrice-weekly for private or general disposal.
<b>Bulky Waste</b>	Includes furniture, out of service equipment, polystyrene packaging	76 litres	Collected in a secure area on-site.	Taken on an as-needed basis to the Kimbriki Resource Recovery Centre.

Note: No solid animal waste will be placed in the sewer system, all patient waste will be collected as clinical waste and incinerated. The waste store room will be properly secured and measures taken to prevent access from the public or vermin.
