## NOTICE OF DETERMINATION OF PERMIT

THE CORYMBIA MACULATA TREE ADJACENT TO THE HOUSE HAD MAJOR STORM DAMAGE THAT HAS RESULTED IN THE ALTERING OF THE TREES STRUCTURE. THE TREE HAD MAJOR LARGE DEADWOOD. THE CANOPY OF MOST OF THE STRUCTURE WAS EPICORMIC WITH INDICATIONS OF DECAY. THE TREE DID NOT APPEAR TO HAVE RESPONDED WELL TO THE LOSS OF THE BRANCHING (FOLIAGE) AND WAS LIKELY IN THE EARLY STAGES OF DECLINE.

## GENERAL CONDITIONS

## APPROVED WORKS

### 1. Works

The following applies to the site:

#### (a) Trees approved for removal

This consent includes approval to remove the following trees:

### 2. (e) Replacement tree planting is a condition of the Notice of Determination (permit) penalties may apply for non-compliance.

The following replacement tree species must be planted onsite to ensure the preservation of the landscape character and tree canopy of the locality:

Replacement trees are to satisfy the following:

- All replacement trees must be a minimum container size of 45 Litres at planting and in accordance with permit.
- The replacement trees shall be planted within three (3) months of the approved trees removal.
- Please provide photographic evidence to Council of newly planted trees for our records Quoting your permit number to [council@northernbeaches.nsw.gov.au](mailto:council@northernbeaches.nsw.gov.au).

**Reason:**

*To enhance the landscape character, protect, retain, maintain, and improve our tree canopy.*

*To assist in implementing our replenishment/compensation tree planting program for private trees that considers the right tree replenishment (replacement) ratios and improves auditing, of compliance with tree planting permits.*

## SITE REQUIREMENTS

### 3. Permit on Site

A copy of this Permit shall be displayed in a prominent position at the front of property prior to the commencement of the authorised tree work and until all tree works are completed.

**Reason:** *As notification and to ensure that the tree works are carried out in accordance with the approved permit.*

### 4. Protection of Footpaths and Roadways

(a) The public footways and roadways adjacent to the site shall be maintained at all times during the course of the work in a safe condition.

(b) No trees on public property (footpaths, roads, reserves, etc.) unless specifically approved in this development consent shall be removed or damaged during construction including for the erection of any fences, hoardings or other temporary works.

**Reason:** *Protection of footpath and roadways.*

### 5. Silt & Sediment Control

Provision shall be made throughout the period of tree removal to prevent transmission of soil to the public road and drainage system by vehicles leaving the site.

**Reason:** *To avoid siltation to adjoining properties and waterways.*

### 6. Soil Erosion and Landslip Risks

Any person carrying out works permitted under permit has a duty of care in the appropriate management of soil erosion and landslip risks when removing trees and vegetation. It is the responsibility of landowners to see expert advice from a Geotechnical Engineer in relation to these matters prior to the removal of the tree/stump. Operating under this permit does not absolve the landowner from their responsibility for landslip and erosion issues.

**Reason:** *To avoid soil erosion and landslip.*

### 7. No Work on Public Open Space

The applicant shall not enter or undertake any work within adjoining public lands (i.e. Parks, Reserves, Roads etc) without the prior approved permit of Council.

**Reason:** *Protection of existing public infrastructure and land and to ensure public safety and proper management of public land.*

### 8. Kerbside restrictions, construction zones

The applicant's attention is drawn to the existing kerbside restrictions adjacent to the development. Should the applicant require alteration of existing kerbside restrictions, or the provision of a construction zone, the appropriate application must be made and the fee paid. Applicants should note that the alternatives of such restrictions may require referral to Council's Traffic Committee and may take considerable time to be resolved. An earlier application is suggested to avoid delays in construction programs.

**Reason:** *Proper management of public land.*

## **9. Noxious Plants**

All lantana, privet, rubber trees, parateria, and other declared noxious plants on the site, shall be eradicated.

Eradication of noxious weeds shall be conducted within three (3) months of the approved works being conducted.

**Reason:** *To ensure that plants identified as weed species are not allowed to proliferate or interfere with a quality-landscaping outcome.*

## **10. Protection of Wildlife**

Any person carrying out works permitted under this permit must check for native wildlife roosting and nesting within the tree hollows prior to and during tree works. Where wildlife is found to be using tree hollows which are proposed for removal, a wildlife carer must be contacted to facilitate any required animal rescue.

**Reason:** *Protection of wildlife.*

## **11. Hours of Work**

Works shall be restricted to within the hours of 7.00 am to 5.00 pm Monday to Friday and on Saturday to within the hours of 8.00 am to 1.00 pm inclusive, with no work on Sundays and Public Holidays in accordance with Industrial Noise Policy and the *Protection of the Environment Operations Act 1997 (POEO Act)* / Regulations.

The person acting upon this consent shall display, on-site, their twenty-four (24) hour contact telephone number, which is to be clearly visible and legible from any public place adjoining the site.

Where it is necessary for works to occur outside those hours allowed by these conditions, approval for such will be subject to issue of a permit on each occasion from Council's Customer Services Centre. Such permit must be obtained and the appropriate fee paid at least two (2) clear working days in advance of each relevant date. Such occurrence shall be limited to two occasions per calendar month and shall only be approved if public safety or convenience is at risk.

**Reason:** *To ensure that works do not interfere with reasonable amenity expectations of residents and the community. (DACGEch)*

## **12. Health and Safety**

- a) The work undertaken must satisfy applicable occupational health and safety and construction safety regulations, including any WorkCover Authority requirements to prepare a health and safety plan.
- b) Site fencing must be installed (where required) sufficient to exclude the public from the site.
- c) Safety signs must be erected that; warn the public to keep out of the site, and provide a contact telephone number for enquiries.

**Reason:** *To ensure the health and safety of the community and workers on the site.*

## **13. Prohibition on Use of Pavements**

Any person carrying out works permitted under this permit shall ensure that Council's footpath is maintained in a safe way to ensure safe pedestrian access throughout any tree removal / pruning. Under no circumstances are any branches or other tree debris to be placed on Council's footpaths, roadways, parks or grass

verges and a suitable sign to this effect shall be erected adjacent to the street alignment.

All tree debris is to be disposed of appropriately. Should the material need to be stored, it must be contained and stored within the property boundary and in a safe and healthy condition.

***Reason:*** *To ensure public safety and amenity on public land.*

### **Right of Appeal**

If you are dissatisfied with this decision, Chapter 2 'Vegetation in non-rural areas' of the Biodiversity and Conservation SEPP may give you the right to appeal to the Land and Environment Court within 3 months after the date on which you receive this notice.
