George is 78 years old and suffered a major brain aneurysm several years ago, and as a result has both physical and neurological disabilities. I am 71 years old and have increasing issues relative to arthritis in my ankle and knees. While we both try to stay as active as possible, with our increasing age such activity becomes increasingly problematic.

Our grandchildren are aged 13 years to 7 months. We wish to participate fully in their lives and that will mean having the ability to make frequent trips to the waterfront facilities that belong to 127 Riverview Road. We are writing to you today in regard to a section 96 we have submitted for our property at 127 Riverview Rd, Clareville. Part of our submission includes a request to install an inclinator on the property from the garage to the waterfront.

We have lived in this house for over a decade now and need to do some required maintenance, as the building is now 20 years old, as well as make some modifications to better suit our family. We are a family of 6, my husband and myself, along with our 4 children aged 13, 11, 8 and 7 months. We also live with my parents who both in their 70's.
