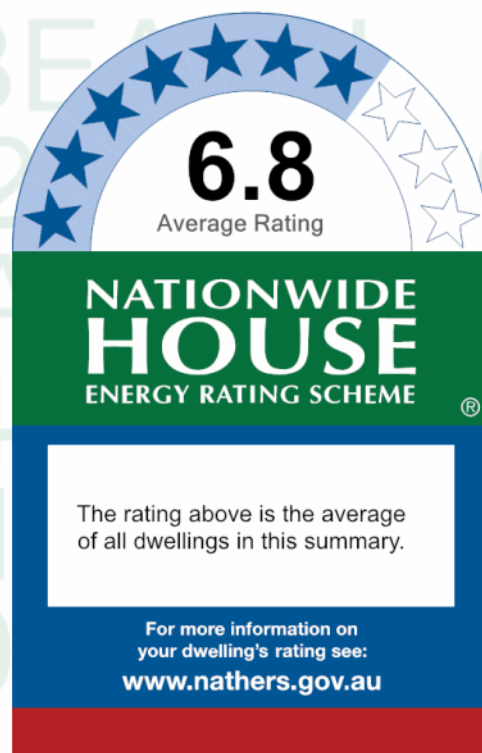

This summary rating is the average rating of all NCC Class 2 dwellings in a development. It addresses the building layout, orientation and fabric (i.e. walls, windows, floors, roofs and ceilings), but does not cover the water or energy use of appliances, or energy production of solar panels.
