1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of the exhibition of the proposed Manly Dam – Safe access to water project conducted between 10 May to 9 June 2024.

The feedback received during consultation indicated a high level of support for the proposed water access platform and accessible pathway upgrades. The majority (64 percent) of respondents supported the plan outright or with some changes, and feedback said the plan would allow more people of different abilities to enjoy Manly Dam.

While most feedback supported the proposed water access platform, some respondents requested the platform width be extended to better accommodate wheelchair users. Others requested handrails be incorporated into the design.

Those not in support of the proposal were against the infrastructure improvement, stating that it compromised the natural environment. Another mentioned it was not suitable as a kayak launch ramp.





Community and Stakeholder Engagement Report Manly Dam - Safe access to water



2. Background

We are proposing to construct a platform that allows safe entry and exit into the water for all paddlers and swimmers. This facility will offer an option for people with reduced mobility to enjoy Manly Dam, by providing safe access to the water's edge and water. The platform will be located at the shoreline of Section 1 Picnic Area adjacent to the playground. This location was determined after listening to community concerns raised in a prior round of consultation.

As part of the works, we are also proposing to construct a new accessible pathway that will link the new water access platform to the accessible amenities and parking bays. New turf will also be laid to complement the pathway connections.

A Review of Environmental Factors has been prepared to assess and mitigate any potential environmental impacts of the works.

This proposed infrastructure project continues from recent works on the memorial space with a focus on accessibility upgrades.

3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities
- identify community and stakeholder concerns, local knowledge and values
- provide accessible information so community and stakeholders can participate in a meaningful way
- communicate to community and stakeholders how their input was incorporated into the planning and decision making process.



4. Engagement approach

Community and stakeholder engagement for the Manly Dam - Safe access to water project was conducted between 10 May and 9 June 2024, and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022).

A Your Say project page² was established with information provided in an accessible and easy to read format.

Key stakeholders, resident groups and local residents received notification letters requesting feedback on the proposed concept plan.

The project was primarily promoted through our regular email newsletter (EDM), media channels and signage at the location to reach those frequenting Manly Dam.

Feedback was captured through an online comment form embedded onto the Have Your Say project page. The form included a question that directly asked respondents for their level of support on the proposed water access platform and accessible pathway.

An onsite pop-up event was held on a Saturday morning at Manly Dam - Section 1 where the proposed works are to take place. Our aim was to gather feedback and to maximise community involvement.

We contacted community members who had an interest in the recent works on the memorial space as both projects had a focus on accessibility upgrades.

We also invited comment through email and in writing.

4.1. Reaching diverse audiences

A thorough stakeholder mapping exercise was completed to identify and understand the needs of the whole community.

We encouraged community participation and sought feedback on the project through several other activities to attract all the potentially affected people including:

- information was provided on Council's Have Your Say project page
- a community pop-up event with the project team held on a Saturday morning
- letterbox drops to neighbouring residents
- displays of onsite notification posters
- Mayor's weekly e-news.

I have taken clients to family bbqs at the dam and they've said they wish they could swim with us - but currently would not be safe for either of us to try. Unfortunately there are not many FULLY accessible facilities on the

Take a look at the pontoons at	I understand you want to provide better accessible access but you will waste your money with the proposed materials and design. When entering or exiting a canoe or kayak the paddler will sit or lie on the pontoon. You can't do that with the steel grid proposed. It needs to be level and wide enough for two boats, about 10-12 metres.

	• If the water access platform is intended to facilitate use by people with 'reduced mobility' I would suggest including a strong metallic handrail on one side of the ramp to enable easier access to and from the water. The inclusion of a post with a floatation could also be included. If 'reduced mobility' includes wheelchair users the ramp would need to extended further into the water. While the water depth increases rapidly in the area it is feasible that such individuals might want to utilise the ramp with appropriate personal floatation devices and enjoy kayaking and other aquatic activities. The dam is an ideal place for these people due to the calm waters and protected environment.

Your map key indicates that the ramp will be east of this, in front of the War Memorial. This area is totally inappropriate for water access. This site was previously presented, and was not supported by the community, the War Memorial trust and the ranger staff. The water access slope is too steep. It would be highly disrespectful to Anzacs and those that appreciate and venerate the Memorial area for respectful, quiet contemplation of the services of our diggers. The new ramp and path etc must be well away from the Memorial and rotunda designated area.	No further comment provided.

39	The idea that launching and returning a kayak from a platform in the water is not possible. I've paddled a kayak in Manly Dam 30 odd times a year over the past 35 plus years. My kayak needs to be grounded with my weight in it for my safe entry and exit. trying to get in or out while the kayak is floating is and can result in me tipping into the water. The older I get the more careful I must be. I've entered the water from the picnic area below the far carpark for years. This enables me to fish the biggest area of the Dam without trespassing in the water ski area. Lately I use the beach at the 1st parking area as the walk to the water is closer. Both areas have flat launching areas.	The proposed location of the pontoon encourages Kayakers to paddle through the water ski area which is not allowed. If you want to enable wheel chair access the beach at the 1st carpark is the best area, any other point makes travel to the water a lot further. If that area has been vetoed than I'm afraid any proposal is doomed.
40	This proposal has been developed without consideration of larger and more important issues that council has a responsibility for and will need to take more initiative with. Namely Manly Dam reaching capacity is the major contributor to all major flooding in North Manly since 2014, and it must be better used as part of the flood management strategy moving forward as we experience the effects of climate change. Using MD as a flood management asset is necessary and it should involve lowering its default water level, thus this project is premature. Flood mitigation for the wider community where safely is compromised and widespread property loss occurs clearly takes precedent over recreational users.	No further comment provided.
41	I question whether this is really needed or money is just being spent for the sake of it. Why does money continue to be invested in recreation while nothing is spend not flood mitigation for those downstream? 	Has the constantly fluctuating dam (often 1.8m's variation) been considered and that part of the ramp will need to be sumbmerged and may become slippery and weed coated. As opposed to a floating pontoon. For simple the current non powered craft ramp is very short so not usually covered but when it is it is very slippery.

We negotiated for a long time to reduce the proposed playground and a good outcome was achieved.
