1. Summary

This report outlines the outcomes of community and stakeholder engagement conducted as part of a proposal to undertake alterations and extension to the North Narrabeen Surf Life Saving Club building.

The building extension and upgrades will provide a new meeting room for the North Narrabeen Boardriders Club, first-floor deck extension, increasing the enclosed seating space, and building improvements generally.

The feedback collected during consultation revealed a high level of support for the proposed works with 90% of the respondents providing positive feedback. The comments include feedback on the local community infrastructure that requires upgrading, the provision of the Boardriders room, improving the use of the deck for the local community and visitors alike.

We heard from 23% who supported the proposal with changes which included a reduction to the size of the first-floor enclosed space to accommodate a larger open balcony space, and some comments suggested a further increase to the Boardriders room.

Respondents who did not support the proposal indicated that the open deck is the best feature of the building that should be expanded and not reduced.





3. Background

This report outlines the community and stakeholder engagement conducted as part of the exhibition period of the project.

This project was initiated by North Narrabeen Surf Life Saving Club (NNSLSC) and the North Narrabeen Boardriders Club (NNBC) for a small extension of the building to provide a new space for the NNBC. In addition, the proposal also includes other works to address significant waterproofing issues within the building, improve accessibility and functionality, and to provide an upgraded facility overall.

The project is proposed to be delivered in three stages.

- Stage 1 Boardriders room, BBQ renewal and associated landscaping works (GF) and slab extension (L1).
- Stage 2 Internal refurbishment with new ceiling, lighting, flooring (L1).
- Stage 3 Decking renewal and waterproofing works, new enclosed space, balustrades and cladding (L1).

The community was asked to comment on the concept plan and provide feedback about the proposal and design elements.

4. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities regarding the proposed works
- provide accessible information so community and stakeholders can participate in a meaningful way
- provide balanced and objective information to assist the community in understanding the proposal, alternatives and/or solutions
- identify community and stakeholder concerns, local knowledge and values that may influence our decisions.



5. Engagement approach

Community and stakeholder engagement for the North Narrabeen Surf Life Saving Club Alterations and Extensions was conducted between 27 March to 30 April 2023, and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022).

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter channels. Two onsite drop-ins were organised on 20 and 22 April 2023 to meet with the community, explain the project and answer questions.

Feedback was captured through an online submission form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

During the consultation Council received several questions either through direct contact or within feedback received.

Table 2: Questions raised and Council's answers

Why is North Narrabeen Surf Club getting a small upgrade only?	The building structure is in good condition, functional and serviceable and as such it is considered that the significant expense to demolish and rebuild the facility is not appropriate.
It looks like the outside table are only big enough to sit 2 people. Is that correct?	The arrangement of tables and seats shown on the plans are indicative only. The enclosed space will be reduced thus providing a larger balcony space between the glass doors and the balustrade that will easily accommodate larger tables.
Are there toilet/shower facilities for the public?	There are existing community amenities within the building this project does not propose any changes to the existing public toilet and shower facilities
How wide is the proposed balcony?	The plan currently shows 4m and we aim to increase this width to 6m to provide more balcony space. This amendment will be implemented before finalising the plans.

	public facilities are full of light, clean, dry and with the private enclosed shower cubicles, is
	predominately dry most of the time. In fact, a delight to go into and reminiscent of one's own
	bathroom.
	The design fail with Mona Vale is of course the dreaded "timber cladding". I for one warned
	Council many times, that timber in and around an ocean environment will always just rot out
	regardless of any finishes applied.
	So what we see now at Mona Vale Surf Club (main building) is that the "timber cladding" used
	on the facade of the main building is already rotting out at the base of each and every piece,
	and this just over a year in.
	When I look at your proposal for this minor renovation at Nth Narrabeen SLSC, the proposition

I'm writing with regards to the proposed development of North Narrabeen Surf Life Saving Club (NNSLSC). Please consider this feedback against the current design to extend the indoor seating area.

NNSLSC is a rare building in NSW because it has an outdoor deck overlooking the ocean - what an asset! The current design will reduce this value significantly and therefore I do not consider it an upgrade and only support the proposed alterations and extensions with changes to the proposed footprint of the indoor entertainment area.

Currently, there is enough indoor area and seating for the cafe, bar and it's patrons. The extension of this would see it turn into a restaurant sized area which, in my experience, I doubt the current cafe facilities and staff would be able to accommodate. We need the outdoor deck for community events where people come to stand together on some occasions. The Mona Vale surf club design has recognised this!

I see this design as a grab for space for the sale of food instead of community use. It is important to also ensure the outdoor BBQ area on the deck is kept for the use by the community - both the SLSC and North Narrabeen Boardriders, where they should be able to meet and consume their own food and drinks on occasion, even if this means closing the cafe and public bar.

NNSLSC does not need another indoor entertainment area on the northern beaches, the outdoor deck is unique and very much valued by the community.

- Yes with changes. I support stage 1 and stage 2 of the proposed alterations and extensions. I am opposed to the first floor balcony being enclosed. Enclosing the current balcony is essentially to build a function centre for the commercial use of the North Narrabeen Surf lifesaving club.
