### Discussion of reason for referral

This application has been referred as it is in the vicinity of a number of local heritage items, being:

Item I28 Wellings reserve, Gourlay Ave and New Street, North Harbour, Balgowlah; and Item I39 Trees, Forty Baskets Beach Reserve (off Beatty Street), Balgowlah Heights

### Details of heritage items affected

#### 11 Harbour foreshores, all suburbs

Statement of Significance

Natural landscape type - Aesthetic.

### Physical description

Length of foreshore including natural and built elements of the landscape. Rocky sandstone ledgers, beaches, mud flats and sandstone retaining walls and timber structures.

### 128 Wellings reserve, Gourlay Ave and New Street, North Harbour, Balgowlah

#### Statement of Significance

Natural landscape, scientific and aesthetic significant.

### Physical Description

Remnant natural bushland of low woodland character. Some intrusions of weed species adjacent to roads and suburban development. Generally in good condition. Commemorative reserve named after former Shire Clerk.

# 139 Trees, Forty Baskets Beach Reserve (off Beatty Street), Balgowlah Heights

### Statement of Significance

Listed for its aesthetic importance.

# Physical Description

Line of Phoenix Canariensis (Canary Island Palms) forming visual screen and backdrop between beach front and suburban development.

This application is for construction of a swimming pool, deck, retaining walls and landscaping, primarily in the rear of the property, adjoining the foreshore reserve.

The proposed works are located 15 metres from the harbour foreshore, 15 metres from the closest heritage listed tree and 20 metres from Wellings Reserve (separated by the New Street unformed road reserve). Given this separation, it is considered that there will be no adverse impact on the heritage significance of these items.

Therefore, no objections are raised on heritage grounds, and no conditions required.
