It has to come to our notice that there are more over 55's developments about to take place in Rose Avenue, beside the Rose Church, and now there is yet another development taking shape at <u>45 Lantana Avenue</u>, <u>Wheeler Heights, NSW</u> 2097.

We strongly object to the above Development proposal. Our reasons for objection are set out below:-We have lived here at our home for 20 years. We are totally shocked at the Council allowing such new Developments springing up. Why can't the Council ask Developers to chose a different location which is not so overdeveloped already? The beauty of this area has been diminished ever since this Development was built @ 44 Rose Ave. It is very unfair. This over 55's development built about 2 years ago, has already caused those of us who live in Rose Avenue and Berith Street, great inconveniences <u>every single day</u> and why: (we are not the only sufferers.)

1. Some people living @ 44 Rose Ave, have obviously found that some of the houses there, were too small, yet Council gave permission to convert their garages into another room. Result? No Garage. So every day these people inconvenience those of us who were, until now, living happily in our homes. Why did the Council agree to this? Didn't they see this happening when there are two lots of big buses fighting to getting past each other. It is ridiculous and time consuming trying to get into Rose Avenue and very dangerous. Many people who had bought houses at No 44 have already moved elsewhere, as it was not thought out properly. Why did The Council let this pass?

2. Parking of "vehicles " every day from No. 44 are parked very close to the entrance to our drive, (31 Rose Avenue) daily, one vehicle is parked very close on one side of our drive, and another vehicle parked very close on the other side of our drive tightly. Plus other vehicles parked on the other side of Berith Street. Some of these vehicles are very large! This makes it almost impossible for us to get out of our drive with so many Vehicles narrowing the entrance to our home. We are old now. Does the Council think this is fair and OK? For us to be forced to live with this inconvenience every single day? We are very distressed (but we are not moving as we have lived here 20 years).

Why did the Council allow this? It is not fair to us long-time Residents. The Council needs to, and should stop all new developments springing up, so that we can live in peace. Does the Council really deem this to be good behaviour?

3.We very strongly object to these new developments being built, particularly the one at <u>45 Lantana Avenue</u> as the War Vets have already built so many houses in Lantana Avenue. We are also very concerned of the precedence this Development would set for the whole of this Suburb - which was a low density Residential area. Our Residential amenity must not be taken away by the Council passing these Non-compliant Developments.
