We refer to our letter dated 23 June 2021.

We confirm that we continue to act for Northern Beaches Council ("Council") in the above proceedings against Collaroy Street Pty Ltd ("Applicant").

These proceedings related to the Applicant's appeal against Council's deemed refusal of Development Application No. DA2020/1453 ("the development application") seeking approval for the demolition of existing buildings and construction of a 4-storey shop top housing development with basement parking and landscaping at 1 Alexander Street, Collaroy and 4 Collaroy Street, Collaroy ("the site").

The matter is listed for its final hearing on **14 and 15 September 2021**.
