I was most disappointed to see that there are plans submitted on DA R0002/09 for a giant supermarket 23b Macpherson St Warriewood

This goes beyond any expectation we had for the neighbourhood when purchasing our property over 5 years ago- from plans of Australand Initially, it seemed there would be a community centre – and perhaps some select shops – which would compliment Flower Power, and would make this particular site pleasant to the eye

To envisage a 3200sqm monstrosity next to the newest Australand site, with single lane traffic flow on both Macpherson and Garden Streets – seems to be completely at odds with the area

I would be most pleased for a small supermarket, a selection of shops takeaway, hairdresser, shop top residences, as these should not pose long term problems, or traffic chaos With the current size of the proposed supermarket and truck deliveries, it would be total madness, in this area

There is also the larger consideration of the safety factor regarding the amount of schoolchildren, that frequent the area constantly

<u>Why would Warriewood need another large supermarket</u>? when we have Coles and Woolworths already and Mona vale has Woolworths & Coles- with a new Aldi store also opening soon, plus the contentious issues of the big two – in Newport

I completely reject this proposal – and hope you can agree to look at this in more detail as to the long term problems this proposed development would bring - with the much more traffic, noise, safety, late delivery hours, and anti social behaviour (that is almost out of control already) – and give the residents of Warriewood, who bought houses in good faith of it becoming a great village, something special to look forward to, instead of this mish mash.
