I am a resident of Warriewood at a stage of life to be excited about finding an ideal environment which combines friendliness peace trees bushy reserves open spaces from where the stars & moon can be seen as crystal at night populated by young families retirees children galore well behaved bike riders pram pushers & dog walkers The subject vacant allotment (currently) is approximately 2.5 km s to major shopping facilities in 2 separate directions (including 4 supermarkets & 2 more soon to be opened) & to the sea in another

Most who have moved to the area did so with an assurance that there could be no major commercial intrusion into this haven (or heaven). We were entitled to believe that Council zoning was set in stone & would accommodate a small store or two with some variety possibly a coffee shop. & in the main, we would welcome such amenities

There are now strong indications that Council is pushing for rezoning to allow a huge supermarket to be dumped into the centre of the Valley in isolation amongst the unique middle priced residential properties which currently make up this very green & happy environment. The resulting endless traffic night & day intrusion of vehicles into the very limited streets contributing to choking pollution, chaotic queuing & parking would be intolerable & physically dangerous.
