This application has been referred as the site has frontage to Middle Harbour which is subject to a local heritage listing - <b>Item 11 - Harbour foreshores</b> , listed in Schedule 5 of Manly Local Environmental Plan 2013. In this instance, it appears that the subject site is not affected by the heritage listing as mapped, however as the lot has frontage to a harbour foreshore, it is implied that it is affected by this heritage listing.
