We are writing to advise that the request to modify the above-mentioned Development Consent has been approved on 25 March 2008 and determined as follows:

"(a) Condition 27 be modified to read as follows:

27. The stated level of use by Manly Warringah Rugby League Club during the season other than preseason, practice or exhibition matches is generally:

Weekly Training: Monday, Tuesday & Thursday evening – from 16.30 to 22.00 Wednesday evening training – from 16.30 to 20.30 Saturday and Sunday morning from 07.00 to 10.00

National Competition Matches The matches may be scheduled on:	12 home matches to be played in the season
	Friday evening – finishes at 22.00 Saturday afternoon – finishes at 18.00 Saturday evening – finishes at 22.00 Sunday afternoon – finishes at 18.00 Monday evening – finishes at 21.00

Reason: To reduce impact on surrounding residential areas"

(b) Condition 28 be modified to read as follows:

28. Night matches are limited to a maximum of 12 matches per season (in total) to be played on either Friday, Saturday nights, including up to three (3) Monday nights.

(c) Condition No. 58 be deleted

This letter should therefore be read in conjunction with Development Consent 6000/4021 (No.94/380) dated 22 August 1994, (Mod 1 No. 6000/4021/1 withdrawn), Modification 2 No. 6000/4021/2 dated 26 May 2006 and Modification 3 No. 6000/4021/3 dated 8 may 2007. Please find attached a consolidated set of conditions incorporating all modifications of consent.

Please find attached the amended Operational Plan of Management which now replaces the previous two Operational Plans of Management. Copies of the new Operational Plan of Management should be available on the Manly Warringah Sea Eagles Website prior to the next home game.

Section 96(6) of the Environmental Planning and Assessment Act confers on an applicant who is not satisfied with the determination of the Consent Authority a right of appeal to the Land and Environment Court.
