We are writing to Council in support of this DA but subject to the consent condition set out below and in response to Council's notification to Mrs Boland of the DA dated 16 December 2019.

The consent condition below has been discussed with the owners of the property upon which the proposed development will be located and approved by them as evidenced by the exchange of emails with the Applicant below. We are the owner and occupiers of 130 Booralie Road which shares a shortish boundary with the property subject of the DA to the south of that boundary and along that part of that property upon which (part of) the proposed Arena will be located. The consent condition which has been agreed (subject, of course to Council's approval) is:

"No artificial lighting will be used or amplified music, voice or other noise transmitted or played within the indoor arena after the hour of 9.30pm and before the hour of 7.00am (Sydney time) on any day."

The purpose of this condition is to avoid disturbance by lighting or noise by the use of the arena after or before reasonable "business hours" as the ordinary training of horses on the arena is often done by communication between teacher and rider by "shouting" which, these days. can be - and usually is - by direct communication to the rider's ears by a suitable device.

We also oppose the imposition of limitations on the use of the property for the keeping of domestic animals as pets by the occupiers except that the numbers of such pets (including horses) might well be limited It would be a severe restriction on the use of our neighbours' land if the rights to keep pets were limited in the manner which has been imposed in more recent subdivisions in Joalah and Booralie Roads when existing occupiers such as ourselves and our existing neighbours are not subject to such restrictions.

I refer to our recent exchanges of emails and your meeting with Nanette last Thursday.

As you may be aware your neighbours have now received notification from the Council of the lodgement of your DA and inviting submissions which must be lodged by 28 January 2020. As you are not unhappy with our proposals about the arena use and its lighting as well, we propose that our submission to Council would propose the following condition of approval and indicate that it has been discussed with and approved by you. Before doing that we would be pleased if you would consider our draft and suggest any amendments to it that you think better sets out what you would prefer and let us have any comments in ample time for us to "debate" any points of difference or wording and reach agreement if you want amendment. We propose:
